AN ACT to amend the penal law, in relation to non-support of a child where parent voluntarily reduces or terminates employment

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 2 of section 260.05 of the penal law, as added by chapter 70 of the laws of 2008, is amended to read as follows:

- 2. being a parent, guardian or other person obligated to make child support payments by an order of child support entered by a court OR AGENCY of competent jurisdiction for a child less than eighteen years old, he or she knowingly fails or refuses without lawful excuse to provide support for such child when he or she is able to do so, or becomes unable to do so, when, though employable, he or she voluntarily terminates his or her employment, voluntarily reduces his or her earning capacity, or fails to diligently seek employment.
- 11 S 2. Paragraph (b) of subdivision 1 of section 260.06 of the penal 12 law, as added by chapter 70 of the laws of 2008, is amended to read as 13 follows:
  - (b) being a parent, guardian or other person obligated to make child support payments by an order of child support entered by a court OR AGENCY of competent jurisdiction for a child less than eighteen years old, he or she KNOWINGLY fails or refuses without lawful excuse to provide support for such child when he or she is able to do so, OR BECOMES UNABLE TO DO SO, WHEN, THOUGH EMPLOYABLE, HE OR SHE VOLUNTARILY TERMINATES HIS OR HER EMPLOYMENT, VOLUNTARILY REDUCES HIS OR HER EARNING CAPACITY OR FAILS TO DILIGENTLY SEEK EMPLOYMENT; and
- 21 CAPACITY OR FAILS TO DILIGENTLY SEEK EMPLOYMENT; and
  22 S 3. This act shall take effect on the first of November next succeed23 ing the date on which it shall have become a law.
