AN ACT to amend the judiciary law, in relation to the establishment of a pilot program for courts for the treatment of veterans; and providing for the repeal of such provisions upon the expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The judiciary law is amended by adding a new article 5-C to read as follows:

ARTICLE 5-C

SECTION 178-A. ESTABLISHMENT OF COURTS FOR VETERANS; PILOT PROGRAM.

10 S 178-A. ESTABLISHMENT OF COURTS FOR VETERANS; PILOT PROGRAM. THE ADMINISTRATOR OF THE COURTS, BY ADMINISTRATIVE ORDER, IS AUTHOR-11 CHIEF 12 IZED AND DIRECTED TO ESTABLISH A COURT FOR VETERANS IN THE CITY COURT OF THE CITY OF UTICA, AND IN THE SUPREME COURTS OF THE CITY OF 13 NEW YORK, AND ASSIGN ONE OR MORE JUSTICES OR JUDGES TO PRESIDE THEREIN. (1) A LOCAL CRIMINAL COURT IN A COUNTY IN WHICH A COURT FOR VETERANS 1 HAS BEEN ESTABLISHED UNDER THIS ARTICLE MAY, UPON MOTION OF THE DEFEND-2 3 ANT AND WITH THE CONSENT OF THE DISTRICT ATTORNEY, CAUSE COPIES OF 4 PAPERS AND OTHER DOCUMENTS FILED IN SUCH LOCAL CRIMINAL COURT IN 5 CONNECTION WITH A CRIMINAL ACTION OR PROCEEDING PENDING THEREIN TO BE 6 SENT TO THE COURT FOR VETERANS:

7 (I) UPON OR AFTER ARRAIGNMENT OF THE DEFENDANT ON A LOCAL CRIMINAL 8 COURT ACCUSATORY INSTRUMENT BY WHICH SUCH ACTION OR PROCEEDING WAS 9 COMMENCED; OR

10 (II) UPON OR AFTER COMMENCEMENT OF A PROCEEDING BROUGHT AGAINST A 11 DEFENDANT FOR THE VIOLATION OF A CONDITION OF A SENTENCE OF PROBATION OR 12 A SENTENCE OF CONDITIONAL DISCHARGE.

(2) NOT LATER THAN FIVE DAYS FOLLOWING RECEIPT OF THE PAPERS AND OTHER 13 14 DOCUMENTS, THE JUSTICE OR JUDGE PRESIDING IN THE COURT FOR VETERANS 15 SHALL DETERMINE WHETHER OR NOT A TRANSFER OF THE ACTION OR PROCEEDING TO 16 THE COURT WOULD PROMOTE THE ADMINISTRATION OF JUSTICE. IF THE JUSTICE OR 17 JUDGE PRESIDING IN THE COURT DETERMINES THAT IT WOULD, HE OR SHE MAY ORDER SUCH TRANSFER, IN WHICH EVENT THE ACTION OR PROCEEDING SHALL BE 18 19 TRANSFERRED TO THE COURT FOR VETERANS, ALL ORIGINATING PAPERS SHALL THEN BE SENT FROM THE ORIGINATING COURT TO THE COURT FOR VETERANS, AND ALL 20 21 FURTHER PROCEEDINGS SHALL BE CONDUCTED THEREIN. IF THE JUSTICE OR JUDGE 22 DETERMINES THAT A TRANSFER OF THE ACTION OR PROCEEDING WOULD NOT PROMOTE THE ADMINISTRATION OF JUSTICE, HE OR SHE SHALL NOTIFY THE LOCAL CRIMINAL 23 24 COURT OR OTHER COURT FROM WHICH THE REFERENCE WAS RECEIVED OF SUCH 25 DETERMINATION, WHEREUPON ALL FURTHER PROCEEDINGS IN SUCH ACTION OR 26 PROCEEDING SHALL BE CONDUCTED IN ACCORDANCE WITH LAW. 27

28 (1) AT ANY TIME WHILE A CRIMINAL ACTION OR PROCEEDING IS PENDING IN A SUPERIOR COURT IN A COUNTY IN WHICH A COURT FOR VETERANS HAS BEEN ESTAB-29 LISHED, INCLUDING A PROCEEDING BROUGHT AGAINST A DEFENDANT FOR THE 30 VIOLATION OF A CONDITION OF A SENTENCE OF PROBATION OR A SENTENCE 31 OF 32 CONDITIONAL DISCHARGE, A JUDGE OR JUSTICE OF THE COURT IN WHICH THE ACTION OR PROCEEDING IS PENDING MAY, UPON MOTION OF THE DEFENDANT AND 33 CONSENT OF THE DISTRICT ATTORNEY, CAUSE COPIES OF PAPERS AND 34 WITH THE OTHER DOCUMENTS FILED IN SUCH COURT IN CONNECTION WITH THE ACTION OR 35 PROCEEDING TO BE SENT TO THE JUDGE OR JUSTICE PRESIDING IN THE COURT FOR 36 37 VETERANS FOR REVIEW OF THE APPROPRIATENESS OF THE TRANSFER.
