AN ACT to amend the correction law, the executive law and the penal law, in relation to certain residency requirements for sex offenders

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 168-b of the correction law is amended by adding a 2 new subdivision 12 to read as follows:

3 12. THE DIVISION, WHEN ACKNOWLEDGING INITIAL REGISTRATION AND THERE-4 AFTER ANNUAL CORRESPONDENCE, SHALL ADVISE EACH SEX OFFENDER TO WHOM IN 5 THE RESIDENCY RESTRICTION IN SECTION ONE HUNDRED SIXTY-EIGHT-W OF THIS 6 ARTICLE APPLIES, CONCERNING THE TERMS AND SPECIFIC DURATION OF SUCH 7 RESTRICTION.

8 S 2. Section 168-t of the correction law, as amended by chapter 373 of 9 the laws of 2007, is amended to read as follows:

S 168-t. Penalty. Any sex offender required to register or to verify 10 pursuant to the provisions of this article who fails to register or 11 12 verify in the manner and within the time periods provided for in this article shall be guilty of a class E felony upon conviction for the 13 first offense, and upon conviction for a second or subsequent offense 14 shall be guilty of a class D felony. Any sex offender who violates the 15 16 provisions of section one hundred sixty-eight-v OR SUBDIVISION ONE OF 17 SECTION ONE HUNDRED SIXTY-EIGHT-W of this article shall be guilty of a class A misdemeanor upon conviction for the first offense, and upon 18 19 conviction for a second or subsequent offense shall be guilty of a class felony. Any such failure to register or verify may also be the basis 20 D for revocation of parole pursuant to section two hundred fifty-nine-i of 21 the executive law or the basis for revocation of probation pursuant to 22 23 article four hundred ten of the criminal procedure law.

1 S 3. Section 168-w of the correction law, as relettered by chapter 604 2 of the laws of 2005, is relettered section 168-x and a new section 168-w 3 is added to read as follows:

4 S 168-W. RESIDENCY REQUIREMENTS FOR SEX OFFENDERS. 1. NO SEX OFFENDER 5 SHALL RESIDE IN A RESIDENCE THAT IS WITHIN ONE THOUSAND FEET OF ANY SCHOOL BUILDING REGULARLY USED FOR INSTRUCTIONAL PURPOSES, A BUILDING IN 6 7 WHICH CHILD DAY CARE IS PROVIDED OR A PARK. THE PROVISIONS OF THIS SUBDIVISION SHALL APPLY FOR THE GREATER OF TEN YEARS OR THE 8 PERIOD OR TERM OF PROBATION, PAROLE, CONDITIONAL RELEASE OR POST-RELEASE SUPER-9 10 VISION APPLICABLE TO SUCH OFFENSE.

12 PRIVATE ELEMENTARY, PAROCHIAL, INTERMEDIATE, JUNIOR HIGH, VOCATIONAL OR 13 HIGH SCHOOL.

14 3. NOTHING IN THIS SECTION SHALL BE CONSTRUED AS RESTRICTING ANY 15 LAWFUL CONDITION THAT MAY BE IMPOSED ON A SENTENCED SEX OFFENDER.

16 S 4. Section 259-c of the executive law is amended by adding a new 17 subdivision 18 to read as follows:

18 18. WHEN THE PROVISIONS OF SECTION ONE HUNDRED SIXTY-EIGHT-W OF THE 19 CORRECTION LAW CONCERNING CERTAIN RESTRICTIONS ON RESIDENCE APPLY, 20 DIRECT THE DIVISION TO NOTIFY THE RELEASEE OF THE RESTRICTION IN WRITING 21 AND DIRECT THE SUPERVISING PAROLE OFFICER TO NOTIFY THE RELEASEE OF SUCH 22 RESTRICTION ORALLY AND IN WRITING.

23 S 5. Section 65.10 of the penal law is amended by adding a new subdi-24 vision 6 to read as follows:

6. NOTICE OF RESIDENCY REQUIREMENTS FOR SEX OFFENDERS. WHEN THE PROVISIONS OF SECTION ONE HUNDRED SIXTY-EIGHT-W OF THE CORRECTION LAW CONCERNING CERTAIN RESTRICTIONS ON RESIDENCE APPLY, THE COURT SHALL NOTIFY THE DEFENDANT OF THE RESTRICTION IN WRITING AND THE SUPERVISING PROBATION OFFICER SHALL NOTIFY THE OFFENDER OF THE RESTRICTION ORALLY AND IN WRITING.

31 S 6. This act shall take effect on the sixtieth day after it shall 32 have become a law and shall apply to sex offenders convicted or released 33 on or after such date.
