AN ACT to amend the executive law, in relation to child victims

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 631 of the executive law is amended by adding a new
2 subdivision 17 to read as follows:
3 17. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISION ONE OF THIS SECTION,
4 WHERE A CHILD VICTIM HAS NOT BEEN PHYSICALLY INJURED AS A DIRECT RESULT
5 OF A CRIME, OR HAS WITNESSED A CRIME IN WHICH NO PHYSICAL INJURY
6 OCCURRED, THE CLAIMANT SHALL ONLY BE ELIGIBLE FOR AN AWARD THAT INCLUDES
7 THE UNREIMBURSED COST OF REPAIR OR REPLACEMENT OF ESSENTIAL PERSONAL
8 PROPERTY OF THE CHILD VICTIM THAT HAS BEEN LOST, DAMAGED OR DESTROYED AS
9 A DIRECT RESULT OF A CRIME, TRANSPORTATION EXPENSES INCURRED BY THE
10 CLAIMANT FOR NECESSARY COURT APPEARANCES OF THE CHILD VICTIM IN
11 CONNECTION WITH THE PROSECUTION OF SUCH CRIMES, AND, IF COUNSELING IS
12 COMMENCED WITHIN ONE YEAR FROM THE DATE OF THE INCIDENT OR ITS DISCOV-
13 ERY, (1) THE UNREIMBURSED COST OF COUNSELING PROVIDED TO THE CHILD
14 VICTIM ON ACCOUNT OF MENTAL OR EMOTIONAL STRESS RESULTING FROM THE INCI-
15 DENT IN WHICH THE CRIME OCCURRED, AND/OR (2) THE UNREIMBURSED COST OF
16 COUNSELING PROVIDED TO THE CLAIMANT ELIGIBLE UNDER PARAGRAPH (H) OF
17 SUBDIVISION ONE OF SECTION SIX HUNDRED TWENTY-FOUR OF THIS ARTICLE AND
18 RESULTING FROM THE INCIDENT IN WHICH THE CRIME OCCURRED.
19 S 2. This act shall take effect immediately.
