AN ACT to amend the public authorities law, in relation to providing for the financing and construction of capital facilities for a certain not-for-profit corporation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph (b) of subdivision 2 of section 1676 of the
2 public authorities law is amended by adding a new undesignated paragraph
3 to read as follows:
4 FORDHAM PREPARATORY SCHOOL, INC., FOR THE FINANCING OR REFINANCING, OR
5 REIMBURSEMENT OF THE COSTS OF THE ACQUISITION, DESIGN, CONSTRUCTION,
6 RECONSTRUCTION, REHABILITATION, IMPROVEMENT, FURNISHING AND EQUIPPING
7 OF, OR OTHERWISE PROVIDING FOR CONSTRUCTION OF ADDITIONAL EDUCATIONAL
8 FACILITIES LOCATED ON FORDHAM UNIVERSITY ROSE HILL CAMPUS, THE BRONX,
9 NEW YORK.
10 S 2. Subdivision 1 of section 1680 of the public authorities law is
11 amended by adding a new undesignated paragraph to read as follows:
12 FORDHAM PREPARATORY SCHOOL, INC., FOR THE FINANCING OR REFINANCING, OR
13 REIMBURSEMENT OF THE COSTS OF THE ACQUISITION, DESIGN, CONSTRUCTION,
14 RECONSTRUCTION, REHABILITATION, IMPROVEMENT, FURNISHING AND EQUIPPING
15 OF, OR OTHERWISE PROVIDING FOR CONSTRUCTION OF ADDITIONAL EDUCATIONAL

3 S 3. Any contracts entered into by the dormitory authority pursuant to
4 this act shall be deemed state contracts within the meaning of that term
5 as set forth in article 15-A of the executive law, and the authority

7 that term is used in such article.

8 S 4. This act shall take effect immediately.
