AN ACT to amend the executive law and the mental hygiene law, in relation to enacting the "behavioral health services for veterans act"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. This act shall be known and may be cited as the "behavioral health services for veterans act".

3 S 2. The executive law is amended by adding a new section 368 to read 4 as follows:

5 368. BEHAVIORAL HEALTH SERVICES FOR VETERANS ADVISORY BOARD. S 1. 6 THERE IS HEREBY ESTABLISHED WITHIN THE DIVISION, A BEHAVIORAL HEALTH 7 SERVICES FOR VETERANS ADVISORY BOARD. SUCH BOARD SHALL CONSIST OF NINE 8 MEMBERS, THREE OF WHOM SHALL BE APPOINTED BY THE GOVERNOR, TWO OF WHOM SHALL BE APPOINTED BY THE TEMPORARY PRESIDENT OF THE SENATE, TWO OF WHOM 9 SHALL BE APPOINTED BY THE SPEAKER OF THE ASSEMBLY, ONE OF WHOM SHALL BE 10 APPOINTED BY THE MINORITY LEADER OF THE SENATE AND ONE OF WHOM SHALL BE 11 APPOINTED BY THEMINORITY LEADER OF THE ASSEMBLY. SUCH MEMBERS SHALL 12 SERVE AT THE PLEASURE OF THE APPOINTING AUTHORITY. 13 VACANCIES ON THE BOARD SHALL BE FILLED IN THE MANNER OF THE ORIGINAL APPOINTMENT. MEMBERS 14 THE BOARD SHALL RECEIVE NO COMPENSATION FOR THEIR SERVICES BUT SHALL 15 OF BE REIMBURSED FOR ACTUAL AND NECESSARY EXPENSES INCURRED IN THE PERFORM-16 17 ANCE OF THEIR DUTIES.

2. THE BEHAVIORAL HEALTH SERVICES FOR VETERANS ADVISORY BOARD SHALL 18 19 STUDY AND ANALYZE BOTH THE ADEQUACY OF EXISTING AND THE NEED FOR NEW BEHAVIORAL HEALTH SERVICES FOR VETERANS. IN PROVIDING SUCH ANALYSIS, THE 20 BOARD SHALL WORK IN COOPERATION WITH THE DIVISION, THE OFFICE 21 OF ALCO-HOLISM AND SUBSTANCE ABUSE SERVICES AND THE DEPARTMENT OF MENTAL 22 23 HYGIENE. THE BOARD SHALL REPORT THE FINDINGS OF SUCH STUDY TO THE GOVER-24 NOR AND THE LEGISLATURE ALONG WITH RECOMMENDATIONS IT DEEMS NECESSARY

The mental hygiene law is amended by adding a new section 19.43 4 to read as follows: 5 S 19.43 BEHAVIORAL HEALTH SERVICES FOR VETERANS. 6 (A) THE OFFICE, IN COOPERATION WITH THE DEPARTMENT AND THE DIVISION OF 7 VETERANS' AFFAIRS, SHALL ESTABLISH WITHIN EVERY COUNTY WITHIN THE STATE, ACCESS TO BEHAVIORAL HEALTH SERVICES FOR VETERANS. IN ESTABLISHING SUCH 8 ACCESS, THE OFFICE SHALL PROVIDE TREATMENT ON AN INPATIENT, OUTPATIENT 9 10 AND RESIDENTIAL BASIS, THAT SHALL INCLUDE, BUT NOT BE LIMITED TO, PHAR-MACOTHERAPY FOR ALCOHOL DEPENDENCE, OPIOID DEPENDENCE AND OTHER CHEMICAL 11 12 DEPENDENCE AND SUBSTANCE ABUSE DISORDERS. PROVIDING BEHAVIORAL HEALTH SERVICES 13 (B) STAFF TO VETERANS SHALL 14 RECEIVE TRAINING IN THE SPECIFIC NEEDS OF VETERANS WITH RESPECT TO CHEM-15 ICAL DEPENDENCIES AND SUBSTANCE ABUSE DISORDERS AND SHALL BE EXPANDED 16 WHEN NEEDED TO ADEQUATELY PROVIDE SUCH SERVICES. 17 IN ADDITION TO THE SERVICES SET FORTH IN SUBDIVISION (A) OF THIS (C) SECTION, THE OFFICE SHALL PROVIDE THE FOLLOWING SERVICES: 18 19 1. COORDINATION OF SERVICES BY AN INDIVIDUAL CARE COORDINATOR FOR EACH 20 VETERAN WHO SEEKS SERVICES; 21 2. SCREENING AND ASSESSMENT FOR POST TRAUMATIC STRESS DISORDER, TRAU-22 MATIC BRAIN INJURY, DEPRESSION AND POTENTIAL FOR SUICIDE; 23 AGENCY NETWORKING TO PROVIDE VETERANS WITH CONSISTENT TREATMENT 3. 24 THROUGHOUT THE STATE AND THE VETERANS ADMINISTRATION; 25 4. TRANSPORTATION TO AND FROM THE SERVICES PROVIDED BY THIS SECTION; 26 5. EVALUATION OF CLINICAL PRACTICES SPECIFIC TO VETERANS; AND 27 6. COORDINATION OF PATIENT CARE SERVICES. 28 (D) THE OFFICE IS HEREBY AUTHORIZED AND DIRECTED TO PROMULGATE RULES 29 AND REGULATIONS NECESSARY FOR THE IMPLEMENTATION OF THIS SECTION. S 4. This act shall take effect immediately; provided that section two 30 of this act shall take effect April 1, 2010; and provided further that 31 32 effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effec-33 tive date is authorized to be made and completed on or before such date. 34
