Introduced by M. of A. THIELE -- read once and referred to the Committee on Judiciary

AN ACT to amend the family court act and the domestic relations law, in relation to reducing a parent's child support obligation by the amount of social security dependent benefits received by the child

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subparagraph 1 of paragraph (b) of subdivision 1 of section  
2 413 of the family court act, as amended by chapter 567 of the laws of  
3 1989, is amended to read as follows:

4 (1) "Basic child support obligation" shall mean the sum derived by  
5 adding the amounts determined by the application of subparagraphs two  
6 and three of paragraph (c) of this subdivision except as increased  
7 pursuant to subparagraphs four, five, six and seven of such paragraph  
8 AND DECREASED PURSUANT TO SUBPARAGRAPH EIGHT OF SUCH PARAGRAPH.

9 S 2. Clause (iii) of subparagraph 5 of paragraph (b) of subdivision 1  
10 of section 413 of the family court act, as amended by chapter 567 of the  
11 laws of 1989, is amended to read as follows:

12 (iii) to the extent not already included in gross income in clauses  
13 (i) and (ii) of this subparagraph, the amount of income or compensation  
14 voluntarily deferred and income received, if any, from the following  
15 sources:

- 16 (A) workers' compensation,  
17 (B) disability benefits,  
18 (C) unemployment insurance benefits,  
19 (D) social security benefits,  
20 (E) veterans benefits,  
21 (F) pensions and retirement benefits,  
22 (G) fellowships and stipends, [and]  
23 (H) annuity payments[;], AND

3 S 3. Paragraph (c) of subdivision 1 of section 413 of the family court  
4 act is amended by adding a new subparagraph 8 to read as follows:

5 (8) SOCIAL SECURITY BENEFITS RECEIVED BY THE CHILD OR CHILDREN DUE TO  
6 THE EARNINGS OF A PARENT SHALL BE CREDITED AS CHILD SUPPORT TO THE  
7 PARENT UPON WHOSE EARNING RECORD IT IS BASED.

8 S 4. Subparagraph 1 of paragraph (b) of subdivision 1-b of section 240  
9 of the domestic relations law, as added by chapter 567 of the laws of  
10 1989, is amended to read as follows:

11 (1) "Basic child support obligation" shall mean the sum derived by  
12 adding the amounts determined by the application of subparagraphs two  
13 and three of paragraph (c) of this subdivision except as increased  
14 pursuant to subparagraphs four, five, six and seven of such paragraph  
15 AND DECREASED PURSUANT TO SUBPARAGRAPH EIGHT OF SUCH PARAGRAPH.

17 1-b of section 240 of the domestic relations law, as added by chapter  
18 567 of the laws of 1989, is amended to read as follows:

- 26 (D) social security benefits,
- 27 (E) veterans benefits,
- 28 (F) pensions and retirement benefits,
- 29 (G) fellowships and stipends, [and]
- 30 (H) annuity payments[;], AND

31 (I) SOCIAL SECURITY DEPENDENT BENEFITS RECEIVED BY THE CHILD OR CHIL-  
32 DREN DUE TO THE EARNINGS OF THE PARENT;

33 S 6. Paragraph (c) of subdivision 1-b of section 240 of the domestic  
34 relations law is amended by adding a new subparagraph 8 to read as  
35 follows:

36 (8) SOCIAL SECURITY BENEFITS RECEIVED BY THE CHILD OR CHILDREN DUE TO  
37 THE EARNINGS OF A PARENT SHALL BE CREDITED AS CHILD SUPPORT TO THE  
38 PARENT UPON WHOSE EARNING RECORD IT IS BASED.

39 S 7. This act shall take effect immediately.
