AN ACT to amend the agriculture and markets law and the environmental conservation law, in relation to establishing a maple syrup assistance program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph f of subdivision 2 of section 301 of the agricul-
2 ture and markets law, as separately amended by chapters 316 and 797 of
3 the laws of 1992, is amended to read as follows:
4 f. Maple sap AND PURE MAPLE PRODUCTS.
5 S 2. Paragraph d of subdivision 9 of section 301 of the agriculture
6 and markets law, as amended by chapter 536 of the laws of 2008, is
7 amended to read as follows:
8 d. Maple syrup AND PURE MAPLE PRODUCTS processed from maple sap
9 produced on land used in agricultural production in conjunction with the
10 same or an otherwise qualified farm operation;
11 S 3. Section 16 of the agriculture and markets law is amended by
12 adding a new subdivision 45 to read as follows:
13 45. ENCOURAGE AND SUPPORT THE PRODUCTION OF MAPLE SYRUP AND PURE MAPLE
14 PRODUCTS IN THE STATE; AND, IN CONSULTATION WITH THE DEPARTMENT OF ENVI-
15 RONMENTAL CONSERVATION, ASSIST WITH THE DEVELOPMENT OF THE MAPLE SYRUP
16 ASSISTANCE PROGRAM (MAPSAP) AS PROVIDED FOR IN SUBDIVISION ONE-A OF
17 SECTION 9-0505 OF THE ENVIRONMENTAL CONSERVATION LAW.
18 S 4. Subdivision 4 of section 297 of the agriculture and markets law,
19 as added by chapter 269 of the laws of 2000, is amended to read as
20 follows:
21 4. Eligible projects. Projects involving new product development;
22 alternative production, processing, distribution and marketing technolo-
23 gies; introduction of high technologies; or organizational methods that
24 further development of the food and agriculture industry in the state
25 shall be eligible for grant awards pursuant to the food and agriculture

1 industry development program. Also eligible shall be projects involving
2 farm woodland, MAPLE SAP OR PURE MAPLE PRODUCTS or fresh water aquatic
3 products produced in either natural or man-made water bodies or in
4 natural or man-made controlled structures. Projects that include publ-
5 ic-private partnership investments, and with a strong potential for
6 near-term commercial application and long-term economic value to the
7 state and localities, shall be given priority.

8 S 5. Subdivision 9 of section 284 of the agriculture and markets law,
9 as amended by chapter 639 of the laws of 2004, is amended to read as
10 follows:

11 9. Establish the Hudson valley agricultural center to serve as a
12 marketing, promotional, informational and cultural center for the Hudson
13 river valley agricultural region and greenway and to promote the
14 production of fruits (including juices, jellies, and preserves made
15 therefrom), wine, cider, vegetables, MAPLE SAP AND PURE MAPLE PRODUCTS
16 and other agricultural products.

17 S 6. Section 9-0505 of the environmental conservation law is amended
18 by adding a new subdivision 1-a to read as follows:

19 1-A. THE COMMISSIONER, IN CONSULTATION WITH THE DEPARTMENT OF AGRICUL-
20 TURE AND MARKETS, SHALL CREATE A MAPLE SYRUP ASSISTANCE PROGRAM (MAPSAP)
21 TO PROVIDE FOR THE TAPPING OF MAPLE TREES FOR THE PRODUCTION OF SAP FROM
22 MAPLE TREES ON ANY AREAS OUTSIDE OF THE FOREST PRESERVE COUNTIES HERETO-
23 FORE OR HEREAFTER ACQUIRED BY GIFT, PURCHASE OR APPROPRIATION AND ON ANY
24 LANDS WITHIN THE FOREST PRESERVE COUNTIES, BUT OUTSIDE OF THE ADIRONDACK
25 AND CATSKILL PARKS AS NOW FIXED, OR HEREAFTER EXTENDED BY LAW, HERETO-
26 FORE OR HEREAFTER ACQUIRED PURSUANT TO THIS SECTION BY THE DEPARTMENT.
27 IN DEVELOPING THE PROGRAM, THE COMMISSIONER, IN CONSULTATION WITH THE
28 DEPARTMENT OF AGRICULTURE AND MARKETS, SHALL INCLUDE, BUT NOT BE LIMITED
29 TO, CONSIDERATION OF THE ACCESSIBILITY OF MAPLE TREES TO BE USED IN
30 TAPPING AND PRODUCTION AND THE RUNNING OF SEMI-PERMANENT TUBING TO BE
31 USED IN THE PRODUCTION OF SAP.

32 S 7. This act shall take effect immediately.
