AN ACT to amend the agriculture and markets law and the penal law, in relation to the creation, sale or possession of images of animal cruelty

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The agriculture and markets law is amended by adding eight
2 new sections 353-e, 353-f, 353-g, 353-h, 353-i, 353-j, 353-k and 353-l
3 to read as follows:

10 1. A PERSON IS GUILTY OF SALE OF IMAGES DEPICTING ANIMAL CRUELTY IN

13 ANOTHER PERSON OR ENTITY; AND
