AN ACT to amend the mental hygiene law, in relation to directing the commissioner of mental health to prepare a report on the effectiveness of mental health parity; to amend chapter 748 of the laws of 2006 amending the insurance law relating to enacting "Timothy's law", in relation to making the provisions of such chapter permanent; and to amend chapter 502 of the laws of 2007 amending the insurance law relating to certain coverage for mental illness, in relation to the effectiveness thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 7.09 of the mental hygiene law is amended by adding
2 a new subdivision (k) to read as follows:
3 (K) THE COMMISSIONER OF MENTAL HEALTH, IN CONSULTATION WITH THE SUPER-
4 INTENDENT OF INSURANCE, SHALL PREPARE A REPORT ON THE EFFECTIVENESS OF
5 MENTAL HEALTH PARITY. SUCH REPORT SHALL INCLUDE, BUT NOT BE LIMITED TO
6 THE RESULTS AND FINDINGS OF A STUDY CONDUCTED BY THE OFFICE OF MENTAL
7 HEALTH AND THE SUPERINTENDENT OF INSURANCE PURSUANT TO CHAPTER SEVEN
8 HUNDRED FORTY-EIGHT OF THE LAWS OF TWO THOUSAND SIX. THE COMMISSIONER
9 OF MENTAL HEALTH SHALL DELIVER A COPY OF SUCH REPORT TO THE GOVERNOR,
10 THE TEMPORARY PRESIDENT OF THE SENATE AND THE SPEAKER OF THE ASSEMBLY ON
11 OR BEFORE MARCH THIRTY-FIRST, TWO THOUSAND TEN.
12 S 2. Section 8 of chapter 748 of the laws of 2006, amending the insur-
13 ance law relating to enacting "Timothy's law", is amended to read as
14 follows:
15 S 8. This act shall take effect on the first of January next succeed-
16 ing the date on which it shall have become a law [and shall expire and

1 be deemed repealed December 31, 2009;] and the provisions of this act
2 shall apply to policies and contracts issued, renewed, modified, altered
3 or amended on or after such effective date.

4 S 3. Section 4 of chapter 502 of the laws of 2007, amending the insur-
5 ance law relating to certain coverage for mental illness, is amended to
6 read as follows:

7 S 4. This act shall take effect immediately and shall be deemed to
8 have been in full force and effect on and after January 1, 2007, and
9 shall apply to all policies and contracts issued, renewed, modified,
10 altered or amended on or after such date; provided, however, that the
11 notice of availability of coverage requirements provided in sections
12 one, two and three of this act and the amendments relating to school
13 blanket contracts made by sections two and three of this act shall take
14 effect immediately and shall apply to all contracts issued, renewed,
15 modified, altered or amended on or after such effective date[; and
16 provided further, that the amendments to paragraph 5 of subsection (l)
17 of section 3221 and subsections (g) and (h) of section 4303 of the
18 insurance law made by sections one, two and three of this act shall not
19 affect the expiration of such provisions and shall expire therewith].

20 S 4. This act shall take effect immediately.
