AN ACT to amend the elder law, in relation to authorizing a pooled purchasing program for certain services and commodities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 8 of section 203 of the elder law, as added by
2 chapter 48 of the laws of 2007, is amended and a new subdivision 10 is
3 added to read as follows:
4 [8] 9. The director of the office for the aging is hereby authorized,
5 to the extent appropriations are available therefor, to establish, oper-
6 ate and maintain, under the control of the office for the aging or in
7 conjunction with an association, institution, agency, or other public or
8 private entity, or community program engaged in the care of animals, one
9 or more senior pet companionship programs. The purpose and intent of a
10 senior pet companionship program shall be to match seniors who have
11 limited social contact with pets, including cats and dogs and other
12 small animals, to improve the lives of such seniors by enhancing their
13 emotional and mental well-being through such companionship.
14 10. IN ADDITION TO THE POWERS AND DUTIES CONTAINED IN SECTION TWO
15 HUNDRED TWO OF THIS TITLE, THE OFFICE IS HEREBY AUTHORIZED TO ESTABLISH,
16 OPERATE, COORDINATE, ENCOURAGE THE DEVELOPMENT OF, AND/OR MAINTAIN, OR
17 TO CONTRACT WITH OTHER NOT-FOR-PROFIT OR FOR-PROFIT OR PUBLIC ENTITIES
18 ON BEHALF OF THOSE ENTITIES, PROGRAMS, AND SERVICES FOR THE AGING OVER
19 WHICH IT HAS JURISDICTION, OVERSIGHT, OR OTHER CONTRACTUAL RELATIONSHIP,
20 FOR THE OPERATION OF A POOLED PURCHASING PROGRAM FOR CERTAIN SERVICES
21 AND COMMODITIES, INCLUDING, BUT NOT LIMITED TO, LIABILITY AND MOTOR
22 VEHICLE INSURANCE, AS SHALL BE DETERMINED BY THE OFFICE AFTER CONSULTA-
23 TION WITH THE ADVISORY COMMITTEE FOR THE AGING AND OTHERS. THE OFFICE
24 SHALL ESTABLISH RULES AND REGULATIONS FOR THE OPERATION OF SUCH POOLED
25 PURCHASING PROGRAMS IN WHICH IT IS INVOLVED.
26 S 2. This act shall take effect immediately.
