AN ACT to amend the environmental conservation law, in relation to  
allowing the use of rifles for hunting in the county of Chautauqua;  
and providing for the repeal of such provisions upon expiration there-

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907  
2     of the environmental conservation law, as amended by chapter 412 of the  
3     laws of 2008, is amended to read as follows:

42 S 4. This act shall take effect immediately, provided that the amend-  
43 ments to item (i) of paragraph a of subdivision 2 of section 11-0907 of  
44 the environmental conservation law made by section one of this act shall  
45 be subject to the expiration and reversion of such paragraph pursuant to  
46 section 3 of chapter 412 of the laws of 2008, as amended, when upon such  
47 date the provisions of section two of this act shall take effect and  
48 provided, further, that the amendments to item (i) of paragraph a of  
49 subdivision 2 of section 11-0907 of the environmental conservation law  
50 made by section two of this act shall be subject to the expiration and  
51 reversion of such paragraph pursuant to section 13 of chapter 600 of the  
52 laws of 1993, as amended, when upon such date the provisions of section  
53 three of this act shall take effect and provided further that the  
54 provisions of this act shall expire and be deemed repealed one year  
55 after such effective date.
