AN ACT to amend the public authorities law and the executive law, in relation to the powers of the Triborough bridge and tunnel authority

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 553 of the public authorities law is amended by
2 adding a new subdivision 22 to read as follows:

3 22. TO SUBMIT, IN THE FORM AND AT THE INTERVALS APPROVED BY THE DIVI-
4 SION OF CRIMINAL JUSTICE SERVICES, A REPORT INDICATING:

5 (A) THE NUMBER OF SIMPLIFIED TRAFFIC INFORMATIONS FOR TRAFFIC INFRAC-
6 TIONS ISSUED PURSUANT TO SUBDIVISION SEVEN-A OF THIS SECTION BY OFFICERS
7 OF THE AUTHORITY;

8 (B) THE NUMBER OF VIOLATIONS OF RULES AND REGULATIONS OF THE AUTHORITY
9 GOVERNING TRAFFIC ON THE FACILITIES OF THE AUTHORITY. SUCH VIOLATIONS
10 SHALL BE TRAFFIC INFRACCTIONS AS SUCH TERM IS DEFINED IN SECTION ONE
11 HUNDRED FIFTY-FIVE OF THE VEHICLE AND TRAFFIC LAW AND SHALL BE PUNISHA-
12 BLE AS SUCH;

13 (C) THE NUMBER OF ARRESTS MADE BY BRIDGE AND TUNNEL OFFICERS,
14 SERGEANTS AND LIEUTENANTS OF THE AUTHORITY;

15 (D) THE NUMBER OF MOTOR VEHICLE ACCIDENTS AND MOTOR VEHICLE FIRES AS
16 REPORTED BY THE AUTHORITY ON THEIR FACILITIES; AND

17 (E) ANY OTHER INFORMATION REQUESTED BY THE DIVISION OF CRIMINAL
18 JUSTICE SERVICES.

19 S 2. Subdivision 1 of section 837-b of the executive law, as amended
20 by chapter 459 of the laws of 1975, is amended to read as follows:

21 1. It is hereby made the duty of the state administrator of the
22 unified court system; and of every sheriff, county or city commissioner
23 of correction and head of every police department, state, county, or
24 local, and also railroad, steamship, park, aqueduct and tunnel police

1 [and], town constables AND OFFICERS OF THE TRIBOROUGH BRIDGE AND TUNNEL
2 AUTHORITY, of every district attorney, of every probation agency; and of
3 head of every institution or department, state, county and local, deal-
4 ing with criminals and of every other officer, person or agency, dealing
5 with crimes or criminals or with delinquency or delinquents, to transmit
6 to the commissioner not later than the fifteenth day of each calendar
7 month, or at such times as provided in the rules and regulations adopted
8 by the commissioner, such information as may be necessary to enable him
9 to comply with subdivision four of section eight hundred thirty-seven OF
10 THIS ARTICLE. Such reports shall be made upon forms which shall be
11 supplied by the commissioner.
