AN ACT to amend the public service law, in relation to utility service call centers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 11 of section 65 of the public service law, as
2 added by chapter 693 of the laws of 1985, is renumbered subdivision 12
3 and a new subdivision 13 is added to read as follows:

4 13. EVERY GAS CORPORATION, ELECTRIC CORPORATION OR MUNICIPALITY
5 FURNISHING UTILITY SERVICE SHALL, USING SERVICES LOCATED WITHIN THIS
6 STATE AND WITHIN THEIR SERVICE AREA, PROVIDE CALL CENTER SERVICE ASSIST-
7 ANCE FOR THE FOLLOWING SERVICES:

- 8 (A) DETERMINING CUSTOMER FINANCIAL RESPONSIBILITY.
9 (B) TAKING REQUESTS FOR NEW OR ADDITIONAL SERVICES, INCLUDING, BUT NOT
10 LIMITED TO, EMERGENCY SERVICE.
11 (C) DETERMINING DEPOSIT REQUIRED OR BILLING RATE.
12 (D) PREPARING METER AND SERVICE ORDERS AND OBTAINING ACCESS TO METERS.
13 (E) EXPLAINING COMPANY RATES, REGULATIONS, POLICIES, PROCEDURES,
14 EQUIPMENT AND COMMON PRACTICES.
15 (F) INVESTIGATING TROUBLE ORDER FORMS AND INITIATING HIGH BILL INVES-
16 TIGATIONS.
17 (G) HANDLING PAYMENT AND OTHER CREDIT ARRANGEMENTS SUCH AS OBTAINING
18 DEPOSITS, FINANCIAL STATEMENTS AND PAYMENT PLANS.
19 (H) REFERRING CUSTOMERS TO SOCIAL SERVICE AGENCIES AND OTHER ASSIST-
20 ANCE PROGRAMS.

21 S 2. This act shall take effect on the first of January in the year
22 next succeeding the year in which it shall have become a law.
