AN ACT to amend the town law, in relation to the review of projects with regional significance by town planning boards

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The town law is amended by adding a new section 275 to read
2 as follows:

3 S 275. PROJECTS WITH REGIONAL SIGNIFICANCE. 1. FOR PURPOSES OF THIS
4 SECTION THE TERM "PROJECT WITH REGIONAL SIGNIFICANCE" SHALL MEAN:

5 (A) A HOUSING PROJECT CONTAINING FIFTY OR MORE UNITS;

6 (B) ANY PROJECT CONTAINING ONE HUNDRED THOUSAND SQUARE FEET OR MORE;
7 OR

8 (C) ANY PROJECT WHICH REQUIRES THE INVESTMENT OF FIVE MILLION DOLLARS
9 OR MORE.

10 2. IN ADDITION TO THE REVIEW REQUIRED BY THIS ARTICLE, THE PLANNING
11 BOARD SHALL INCLUDE THE FOLLOWING IN ITS REVIEW OF A PROJECT WITH
12 REGIONAL SIGNIFICANCE:

13 (A) THE IMPACT OF SUCH PROJECT ON THE CREATION OF JOBS WITHIN THE
14 TOWN;

15 (B) THE IMPACT OF SUCH PROJECT ON THE TOTAL TAX REVENUES GENERATED IN
16 SUCH TOWN; AND

17 (C) THE OVERALL ECONOMIC IMPACT OF SUCH PROJECT ON SUCH TOWN.

18 3. ANY PERSON OR PERSONS AGGRIEVED BY A DECISION BASED ON THE REVIEW
19 REQUIRED BY THIS SECTION MAY APPLY TO THE SUPREME COURT FOR REVIEW BY A
20 PROCEEDING UNDER ARTICLE SEVENTY-EIGHT OF THE CIVIL PRACTICE LAW AND
21 RULES CONSISTENT WITH THE PROVISIONS OF SECTION TWO HUNDRED SIXTY-SEV-
22 EN-C OF THIS ARTICLE.

23 S 2. This act shall take effect immediately.
