AN ACT to amend the tax law, in relation to the creation of an E-ZPass expense tax credit

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 606 of the tax law is amended by adding a new
2 subsection (qq) to read as follows:

3 (QQ) CREDIT FOR E-ZPASS EXPENSES. (A) ALLOWANCE AND AMOUNT OF CREDIT.
4 A TAXPAYER, WHO HAS E-ZPASS EXPENSES INCURRED IN NEW YORK STATE, SHALL
5 BE ALLOWED A CREDIT, TO BE COMPUTED AS PROVIDED IN THIS SUBSECTION,
6 AGAINST THE TAX IMPOSED BY THIS ARTICLE. THE AMOUNT OF THE CREDIT SHALL
7 BE EQUAL TO AN AMOUNT NOT TO EXCEED FIVE HUNDRED DOLLARS.

8 (B) DEFINITION. THE TERM "E-ZPASS" SHALL, FOR THE PURPOSES OF THIS
9 SUBSECTION, REFER TO A SYSTEM OF COLLECTING TOLLS OR CHARGES WHICH IS
10 CAPABLE OF CHARGING AN ACCOUNT HOLDER THE APPROPRIATE TOLL OR CHARGE BY
11 TRANSMISSION OF INFORMATION FROM AN ELECTRONIC DEVICE ON A MOTOR VEHICLE
12 TO THE TOLL LANE, WHICH INFORMATION IS USED TO CHARGE THE ACCOUNT THE
13 APPROPRIATE TOLL OR CHARGE.

14 (C) APPLICATION OF CREDIT. IF THE AMOUNT OF THE CREDIT SHALL EXCEED
15 THE TAXPAYER'S TAX FOR SUCH YEAR THE EXCESS SHALL BE CARRIED OVER TO THE
16 FOLLOWING YEAR OR YEARS, AND MAY BE DEDUCTED FROM THE TAXPAYER'S TAX FOR
17 SUCH YEAR OR YEARS. NO CREDIT SHALL BE ALLOWED UNDER THIS SECTION WHERE
18 SUCH EXPENSE HAS BEEN CLAIMED AS AN EXPENSE OR DEDUCTION ON ANY TAX
19 RETURN.

20 S 2. This act shall take effect the first of January next succeeding
21 the date on which it shall have become a law.
