AN ACT to amend the public health law, in relation to restricting areas where smoking is permitted

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 1399-o of the public health law is amended by 2 adding a new subdivision 19 to read as follows:
- 3 19. A. PRIVATE PASSENGER CARS, PRIVATE PASSENGER VANS OR PRIVATE 4 PASSENGER TRUCKS WHERE MINORS UNDER FOURTEEN YEARS OF AGE ARE PASSENGERS 5 IN ANY SUCH VEHICLES.
- 6 A PERSON WHO HOLDS A LIGHTED CIGAR, CIGARETTE, PIPE OR ANY OTHER 7 MATTER OR SUBSTANCE WHICH CONTAINS TOBACCO OR ANY OTHER PLANT OR MATTER THAT CAN BE SMOKED TO, OR IN THE IMMEDIATE PROXIMITY OF HIS OR HER 8 PERSON WHILE IN SUCH VEHICLE IS PRESUMED TO BE ENGAGING IN SMOKING WITH-9 IN THE MEANING OF THIS SECTION. 10 THE PRESUMPTION ESTABLISHED 11 PARAGRAPH IS REBUTTABLE BY EVIDENCE SHOWING THAT THE PERSON WAS NOT LIGHTED CIGAR, 12 SMOKING A CIGARETTE, PIPE OR ANY OTHER 13 SUBSTANCE WHICH CONTAINS TOBACCO OR ANY OTHER PLANT OR MATTER THAT CAN 14
- 15 S 2. Subdivision 1 of section 1399-q of the public health law, as 16 amended by chapter 13 of the laws of 2003, is amended to read as 17 follows:
- 18 1. Private homes, private residences and private automobiles EXCEPT AS 19 PROVIDED IN SUBDIVISION NINETEEN OF SECTION THIRTEEN HUNDRED 20 NINETY-NINE-O OF THIS ARTICLE;
- 21 S 3. Section 1399-v of the public health law, as added by chapter 244 22 of the laws of 1989, is amended to read as follows:

9 10 S 1399-v. Penalties. 1. The commissioner may impose a civil penalty for a violation of this article in an amount not to exceed that set forth in subdivision one of section twelve of this chapter. Any other enforcement officer may impose a civil penalty for a violation of this article in an amount not to exceed that set forth in paragraph [f] (F) of subdivision one of section three hundred nine of this chapter.

- 2. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISION ONE OF THIS SECTION ANY PERSON WHO VIOLATES THE PROVISIONS OF SUBDIVISION NINETEEN OF SECTION THIRTEEN HUNDRED NINETY-NINE-O OF THIS ARTICLE SHALL BE LIABLE FOR A FINE OF NOT MORE THAN ONE HUNDRED DOLLARS TO BE IMPOSED BY ANY ENFORCEMENT OFFICER.
