AN ACT to amend the agriculture and markets law, in relation to
inspection and testing of optical scanning devices and systems

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY,
DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 13 of section 179 of the agriculture and
2 markets law, as amended by chapter 402 of the laws of 1998, is amended
3 to read as follows:
4 13. Inspect and test, either personally or through his authorized
5 agents, weights and measures, weighing and measuring devices and
6 systems, and accessories relating thereto, AND OPTICAL SCANNING DEVICES
7 AND SYSTEMS, which are used commercially within the state by any person,
8 firm or corporation in determining the weight, measure or count of
9 commodities or things sold, or offered or exposed for sale on the basis
10 of weight, measure or count, or in computing the basic charge or payment
11 for services rendered on the basis of weight, measure or count, or in
12 the case of coin counting machines which are used commercially within
13 the state by any coin processor required to be licensed pursuant to
14 article twenty-seven-A of the general business law ("coin processor
15 licensing act"), in determining an accurate count of coins, OR IN SCANNING
16 THE PRICE OR DETERMINING THE IDENTITY OF COMMODITIES OR OTHER
17 THINGS SOLD, in order to ascertain if such weights and measures, weighing
18 and measuring devices and systems, or accessories related thereto OR
19 OPTICAL SCANNING DEVICES AND SYSTEMS are correct and are being used
20 correctly; and charge fees commensurate with the cost of each such
21 inspection or test for inspections and tests which are not otherwise
22 conducted by municipalities. The commissioner is also authorized to
23 charge fees commensurate with the cost of each such inspection or test
24 for inspections and tests conducted for the purpose of certifying munic-

1 ipal weighing and measuring devices and systems. Fees authorized by this
2 subdivision shall be established by the commissioner by regulation.
3 S 2. This act shall take effect on the one hundred twentieth day after
4 it shall have become a law, provided, however, that effective immediate-
5 ly, the addition, amendment and/or repeal of any rule or regulation
6 necessary for the implementation of this act on its effective date is
7 authorized to be made and completed on or before such date.
