AN ACT to amend the agriculture and markets law, in relation to penalties for attendance as a spectator at a place where animal fighting is being conducted

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subdivisions 3, 4 and 5 of section 351 of the agriculture
2 and markets law, subdivisions 3 and 4 as added by chapter 150 of the
3 laws of 1984 and subdivision 5 as added by chapter 308 of the laws of
4 2008, are amended to read as follows:
5 3. (a) Any person who engages in conduct specified in paragraph (b) of
6 this subdivision is guilty of a misdemeanor [and is] punishable by
7 imprisonment for a period not to exceed one year, or by a fine not to
8 exceed fifteen thousand dollars, or by both such fine and imprisonment.
9 (b) The owning, possessing or keeping of any animal under circum-
10 stances evincing an intent that such animal engage in animal fighting.
11 4. (a) Any person who engages in conduct specified in paragraph (b)
12 [hereof] OF THIS SUBDIVISION is guilty of a misdemeanor [and is] punish-
13 able by imprisonment for a period not to exceed one year, or by a fine
14 not to exceed one thousand dollars, or by both such fine and imprison-
15 ment.
16 (b) The knowing presence as a spectator [having paid an admission fee
17 or having made a wager] at any place where an exhibition of animal
18 fighting is being conducted, REGARDLESS OF WHETHER SUCH PERSON HAS PAID
19 AN ADMISSION FEE OR HAS MADE A WAGER.
20 5. [(a) Any person who engages in the conduct specified in paragraph
21 (b) of this subdivision is guilty of a violation punishable by a fine
22 not to exceed five hundred dollars. Any person who engages in the
23 conduct specified in paragraph (b) of this subdivision after having been
24 convicted within the previous five years of a violation of this subdivi-

1 sion or subdivision four of this section is guilty of a misdemeanor and
2 is punishable by imprisonment for a period not to exceed one year, or by
3 a fine not to exceeded one thousand dollars, or by both by such fine and
4 imprisonment.

5 (b) The knowing presence as a spectator at any place where an exhibi-
6 tion of animal fighting is being conducted.] ANY PERSON WHO IS CONVICTED
7 OF A VIOLATION OF SUBDIVISION FOUR OF THIS SECTION AND WHO HAS PREVIOUS-
8 LY BEEN CONVICTED OF A VIOLATION OF SUBDIVISION FOUR OF THIS SECTION
9 WITHIN THE PRECEDING FIVE YEARS, IS GUILTY OF A MISDEMEANOR PUNISHABLE
10 BY IMPRISONMENT FOR A PERIOD NOT TO EXCEED ONE YEAR, OR BY A FINE NOT TO
11 EXCEED TWO THOUSAND DOLLARS, OR BY BOTH SUCH FINE AND IMPRISONMENT.

12 S 2. This act shall take effect on the ninetieth day after it shall
