AN ACT to amend the insurance law, in relation to mandatory health insurance coverage for cerebral palsy

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subsection (i) of section 3216 of the insurance law is
2 amended by adding a new paragraph 26 to read as follows:
3 (26)(A) EVERY POLICY WHICH PROVIDES HOSPITAL, SURGICAL, OR MEDICAL
4 CARE COVERAGE SHALL PROVIDE COVERAGE FOR CEREBRAL PALSY AND SHALL NOT
5 EXCLUDE COVERAGE PRESCRIBED BY THE REFERRING PHYSICIAN FOR THE TREATMENT
6 OF CEREBRAL PALSY, INCLUDING, BUT NOT LIMITED TO, COVERAGE FOR THERAPEU-
7 TIC EVALUATIONS AND INTERVENTIONS, SUCH AS SPEECH THERAPY, OCCUPATIONAL
8 THERAPY, PHYSICAL THERAPY, INTENSIVE EARLY INTERVENTION, AND BEHAVIORAL
9 AND EDUCATIONAL INTERVENTION PROGRAMS.
10 (B) SUCH COVERAGE MAY BE SUBJECT TO ANNUAL DEDUCTIBLES AND COINSURANCE
11 AS MAY BE DEEMED APPROPRIATE BY THE SUPERINTENDENT AND AS ARE CONSISTENT
12 WITH THOSE ESTABLISHED FOR OTHER BENEFITS WITHIN A GIVEN POLICY.
13 S 2. Subsection (l) of section 3221 of the insurance law is amended by
14 adding a new paragraph 18 to read as follows:
15 (18)(A) EVERY POLICY WHICH PROVIDES HOSPITAL, SURGICAL, OR MEDICAL
16 CARE COVERAGE SHALL PROVIDE COVERAGE FOR CEREBRAL PALSY AND SHALL NOT
17 EXCLUDE COVERAGE PRESCRIBED BY THE REFERRING PHYSICIAN FOR THE TREATMENT
18 OF CEREBRAL PALSY, INCLUDING, BUT NOT LIMITED TO, COVERAGE FOR THERAPEU-
19 TIC EVALUATIONS AND INTERVENTIONS, SUCH AS SPEECH THERAPY, OCCUPATIONAL
20 THERAPY, PHYSICAL THERAPY, INTENSIVE EARLY INTERVENTION, AND BEHAVIORAL
21 AND EDUCATIONAL INTERVENTION PROGRAMS.
22 (B) SUCH COVERAGE MAY BE SUBJECT TO ANNUAL DEDUCTIBLES AND COINSURANCE
23 AS MAY BE DEEMED APPROPRIATE BY THE SUPERINTENDENT AND AS ARE CONSISTENT
24 WITH THOSE ESTABLISHED FOR OTHER BENEFITS WITHIN A GIVEN POLICY.

1 S 3. Section 4303 of the insurance law is amended by adding a new
2 subsection (ff) to read as follows:
3 (FF)(1) EVERY POLICY WHICH PROVIDES COVERAGE FOR HOSPITAL, SURGICAL,
4 OR MEDICAL COVERAGE SHALL PROVIDE COVERAGE FOR CEREBRAL PALSY AND SHALL
5 NOT EXCLUDE COVERAGE PRESCRIBED BY THE REFERRING PHYSICIAN FOR THE
6 TREATMENT OF CEREBRAL PALSY, INCLUDING, BUT NOT LIMITED TO, COVERAGE FOR
7 THERAPEUTIC EVALUATIONS AND INTERVENTIONS, SUCH AS SPEECH THERAPY, OCCU-
8 PATIONAL THERAPY, PHYSICAL THERAPY, INTENSIVE EARLY INTERVENTION, AND
9 BEHAVIORAL AND EDUCATIONAL INTERVENTION PROGRAMS.
10 (2) SUCH COVERAGE MAY BE SUBJECT TO ANNUAL DEDUCTIBLES AND COINSURANCE
11 AS MAY BE DEEMED APPROPRIATE BY THE SUPERINTENDENT AND AS ARE CONSISTENT
12 WITH THOSE ESTABLISHED FOR OTHER BENEFITS WITHIN A GIVEN POLICY.
13 S 4. This act shall take effect on the one hundred twentieth day after
14 it shall have become a law and shall apply to all policies issued,
15 renewed, modified, or altered on or after such date.
