- AN ACT to amend the environmental conservation law, in relation to the granting of utility easements within reforestation areas

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The environmental conservation law is amended by adding a 2 new section 9-0511 to read as follows:

3 S 9-0511. UTILITY EASEMENTS.

4 THE COMMISSIONER IS HEREBY AUTHORIZED TO GRANT UTILITY EASEMENTS FOR 5 FAIR MARKET VALUE WITHIN A REFORESTATION AREA FOR THE PURPOSE OF PROVID-6 ELECTRICAL POWER TO PERSONS RESIDING WITHIN SUCH AREA. SUCH EASE-ING 7 MENTS SHALL BE LIMITED TO PLACEMENT WITHIN THE FOOTPRINT A PUBLIC OF 8 ROADWAY. ANY SUCH EASEMENT MAY BE GRANTED UPON APPLICATION BY ANY PERSON 9 REFORESTATION AREA, WHERE GRANTING OF SUCH EASEMENT RESIDING WITHIN A 10 WOULD ALLOW SUCH APPLICANT TO RECEIVE ELECTRICAL POWER. IN MAKING HIS OR HER DETERMINATION WITH RESPECT TO WHETHER OR NOT AN 11 APPLICATION FOR A UTILITY EASEMENT SHALL BE GRANTED, THE COMMISSIONER SHALL CONSIDER: 12

13 1. THE ENVIRONMENTAL COMPATIBILITY OF UTILITY POLES AND UTILITY LINES 14 WITH THEIR SURROUNDINGS, INCLUDING THE IMPACT OF SUCH POLES AND LINES ON 15 THE NATURAL ENVIRONMENT, WILDLIFE AND BIRDS, THE AESTHETICS OF THE 16 REGION AND OUTDOOR RECREATIONAL OPPORTUNITIES; AND

17 2. WHETHER OR NOT THE PUBLIC GOOD SHALL BE SERVED BY GRANTING SUCH 18 EASEMENT.

19 S 2. This act shall take effect immediately.
