AN ACT to amend the environmental conservation law, in relation to the management of marine fish subject to interstate and federal fishery management plans and migratory game birds

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 11-0307 of the environmental 2 conservation law, as amended by chapter 494 of the laws of 1984, is 3 amended to read as follows:

1. The department [shall] MAY adopt rules and regulations in relation to migratory game birds [consistent with], PROVIDED SUCH REGULATIONS ARE NO LESS RESTRICTIVE THAN federal regulations made under authority of the Migratory Bird Treaty Act of July 3, 1918, (16 U.S.C. secs. 703-711), as [presently constituted or as hereafter] MAY BE amended FROM TIME TO TIME.

10 S 2. Subdivision 1 of section 11-0903 of the environmental conserva-11 tion law is amended to read as follows:

12 1. Open seasons and bag limits with respect to migratory game birds 13 shall be those PUBLISHED ANNUALLY IN THE FEDERAL REGISTER BY THE U.S. 14 DEPARTMENT OF THE INTERIOR, [fixed by] UNLESS the department [in] ADOPTS 15 regulations pursuant to section 11-0307[, to conform with federal regu-16 lations made under authority of the Migratory Bird Treaty Act of July 3, 17 1918 (16 U.S.C. SS 703-711)].

18 S 3. Paragraph a of subdivision 2 of section 11-0905 of the environ-19 mental conservation law, as amended by chapter 911 of the laws of 1990, 20 is amended to read as follows:

THE COMMISSIONER MAY, BY ORDER, ADOPT MEASURES FOR THE MANAGEMENT OF MARINE FISH NECESSARY TO COMPLY WITH FISHERY MANAGEMENT PLANS ADOPTED BY THE ATLANTIC STATES MARINE FISHERIES COMMISSION OR ADOPTED PURSUANT TO THE FEDERAL FISHERY CONSERVATION AND MANAGEMENT ACT (16 U.S.C. S 1800 ET SEQ.) OR EMERGENCY ACTIONS ADOPTED BY THE ATLANTIC STATES MARINE FISHER-IES COMMISSION OR THE U.S. DEPARTMENT OF COMMERCE, INCLUDING BUT NOT 19 LIMITED TO SIZE LIMITS, CATCH AND POSSESSION LIMITS, AND OPEN AND CLOSED 20 SEASONS, PROVIDED THAT FOR THE MARINE SPECIES NAMED IN SUBDIVISIONS 2 21 AND 3 OF THIS SECTION, THE MINIMUM SIZE LIMITS SHALL BE NO LESS RESTRIC-22 TIVE THAN PROVIDED IN SUCH SUBDIVISIONS. THE COMMISSIONER SHALL INFORM PUBLIC AT LEAST TEN DAYS PRIOR TO THE EFFECTIVE DATE OF SUCH ORDER. 23 THE 24 ANY ORDER MADE PURSUANT TO THIS SECTION SHALL BE EFFECTIVE FOR A PERIOD 25 NOT MORE THAN ONE HUNDRED TWENTY DAYS, PROVIDED THAT IF A NOTICE OF OF 26 PROPOSED RULEMAKING HAS BEEN PUBLISHED IN THE STATE REGISTER, SUCH ORDER 27 SHALL REMAIN IN EFFECT UNTIL SUCH REGULATIONS HAVE BEEN ADOPTED, BUT IN CASE FOR LONGER THAN TWO HUNDRED FORTY DAYS. All shortnose sturgeon 28 NO 29 irrespective of size and all Atlantic sturgeon under the size limits prescribed by regulations adopted pursuant to section 11-1303 of this 30 chapter taken in gill nets shall be immediately returned to the water 31 without unnecessary injury. Other fish named by regulations adopted pursuant to sections 11-0303, 11-1303, 13-0338, 13-0339-a, 13-0340, 32 33 13-0340-a, 13-0340-b, 13-0340-c, 13-0340-d, 13-0340-e, 13-0340-f and 13-0340-g of this chapter and under the size limits prescribed in such 34 35 regulations, shall not be bought, sold or trafficked in. 36 37 S 5. This act shall take effect immediately.
