AN ACT to amend the education law, in relation to the board of trustees of the higher education services corporation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivisions 3 and 4 of section 652 of the education law, subdivision 3 as amended by chapter 653 of the laws of 2004, subdivision 4 as amended by chapter 297 of the laws of 1997, are amended to read as follows:

- The corporation shall be governed and all of its corporate powers exercised by a board of trustees which shall consist of fifteen members, 6 7 [ten] NINE of whom shall be appointed by the governor with the and consent of the senate[, three of whom]. THE MEMBERS NOT REQUIRING 8 9 THE ADVICE AND CONSENT OF THE SENATE shall be the commissioner of education, the chancellor of the state university, the chancellor of the city 10 11 university of the city of New York, and [four of whom shall be] students. One such student shall be the president of the student assem-12 13 bly of the state university of New York, one such student shall be the chair of the united student senate of city university of New York, [one 14 15 such student shall be a student currently registered and in full time 16 attendance at a degree granting independent institution of higher educa-17 tion in New York,] and one such student shall be a student registered in 18 full time course of study at a state university community college. In 19 the event a student who shall be a member by reason of his or her office in a student organization shall fail to qualify, the student who holds 20 21 the next highest office in the organization shall be the member of the 22 board.
 - 4. All members shall be at least eighteen years of age, citizens of the United States and residents of the state. [Exclusive of the student

representative of the state university community colleges and the student representative of degree granting independent institutions of higher education, the] THE appointed members shall consist of two representatives of banking institutions within the state, two such members shall be the presidents of independent institutions of higher education 5 within the state, one such member shall be a president or chief execu-6 7 tive officer of a school licensed or registered pursuant to section five 8 thousand one of this chapter, one such member shall be a financial aid officer at a higher education institution in New York, one such member 9 10 shall be a president or chief executive officer of a degree granting proprietary college located within the state, ONE SUCH MEMBER SHALL BE A 11 STUDENT CURRENTLY REGISTERED AND IN FULL TIME ATTENDANCE AT A DEGREE 12 GRANTING INDEPENDENT INSTITUTION OF HIGHER EDUCATION IN NEW YORK, 13 14 one shall be representative of the public.

S 2. This act shall take effect immediately.
