- AN ACT to amend the environmental conservation law, in relation to global warming pollution control

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Legislative findings. Global warming poses a serious threat 1 2 to the economic well-being, public health, natural resources and envi-3 ronment of New York. The potential adverse impacts of qlobal warming include the exacerbation of air quality problems, a reduction in the 4 5 quality and supply of water to the state, a rise in sea levels resulting б in the displacement of coastal businesses, residents and infrastructure, 7 damage to marine ecosystems and the natural environment, and an increase 8 in the incidences of infectious diseases, asthma, and other human 9 health-related problems. Global warming will have detrimental effects on some of New York's largest industries, including agriculture, tour-10 ism, skiing, recreational and commercial fishing and forestry. 11

12 The Intergovernmental Panel on Climate Change, awarded the 2007 Nobel 13 Peace Prize, determined that burning coal, oil and gas has led to higher 14 temperatures that are already impacting physical and biological systems.

5 National and international actions are necessary to fully address the 6 issue of global warming. Action taken by New York and other states to 7 reduce emissions of greenhouse gases will have far-reaching effects by encouraging the federal government, and other countries to act including 8 9 encouraging the development of sustainable, non-polluting technologies 10 such as solar, wind, geothermal and ocean currents. New York state needs to continue its leadership in addressing global warming; building 11 on the progress gained by creating the regional greenhouse gas initi-12 ative. The legislature recognizes the steps taken by the state in moving 13 14 forward on the Renewable Portfolio Standard (RPS) to generate thirty 15 percent of our energy needs from renewable sources by 2015, the energy efficiency portfolio standard to reduce electric usage by fifteen 16 17 percent by 2015, and the work of the state climate action plan to reduce 18 our greenhouse gas emissions.

GREENHOUSE GAS REPORTING. 49 1. NO LATER THAN MAY 1, 2011, THE DEPARTMENT SHALL PROMULGATE RULES AND REGULATIONS REOUIRING ANNUAL GREENHOUSE GAS EMISSIONS REPORTING FROM 50 GREENHOUSE GAS EMISSION SOURCES. (B) ENSURE RIGOROUS AND CONSISTENT ACCOUNTING OF EMISSIONS, AND 1 2 PROVIDE REPORTING TOOLS AND FORMATS TO ENSURE COLLECTION OF NECESSARY 3 DATA; 4 (C) ENSURE THAT EACH GREENHOUSE GAS EMISSION SOURCE MAINTAINS COMPRE-5 HENSIVE EMISSIONS RECORDS OF ANY GREENHOUSE GAS REPORTED FOR AT LEAST 6 THREE YEARS; AND 7 (D) NOT REOUIRE THE REPORTING OF GREENHOUSE GAS EMISSIONS FROM AGRI-8 CULTURAL SOURCES THAT ARE EXEMPT FROM ENVIRONMENTAL PROTECTION AGENCY REPORTING REQUIREMENTS UNDER RULE 40 CFR 98. 9 10 2. (C) CONSIDER OVERALL SOCIETAL BENEFITS, INCLUDING REDUCTIONS IN OTHER 1 2 AIR POLLUTANTS, DIVERSIFICATION OF ENERGY SOURCE, AND OTHER BENEFITS TO THE ECONOMY, ENVIRONMENT, AND PUBLIC HEALTH; 3

4 (D) CONSIDER THE SIGNIFICANCE OF THE CONTRIBUTION OF EACH SOURCE OR 5 CATEGORY OF SOURCES TO STATEWIDE EMISSIONS OF GREENHOUSE GASES;

6 (E) CONSIDER UTILIZING APPROACHES WHICH ARE DESIGNED TO AVOID UNDUE 7 DELETERIOUS ECONOMIC EFFECTS OR OVERLY BURDENSOME IMPACTS UPON PERSONS 8 DIRECTLY OR INDIRECTLY AFFECTED BY THE RULE OR REGULATION OR UPON THE ECONOMY OR ADMINISTRATION OF STATE OR LOCAL GOVERNMENT AGENCIES; 9

10 (F) NOT PLACE OR INCREASE AN ADDITIONAL ENVIRONMENTAL OR HEALTH BURDEN ON A COMMUNITY THAT HAS A SIGNIFICANT LEVEL OF REGULATED AIR CONTAMINANT 11 SOURCE EMISSIONS WITHIN THE COMMUNITY AS COMPARED WITH THE COUNTY AVER-12 13 AGE;

(G) BE COMPATIBLE WITH OTHER EMISSIONS REDUCTIONS PROGRAMS; AND

15 (H) INCLUDE A PLAN TO THE EXTENT PRACTICABLE TO ADDRESS ADAPTATION TO CLIMATE CHANGE INCLUDING BUT NOT LIMITED TO TERRESTRIAL AND AQUATIC HABITATS, PLANTS AND ANIMAL SPECIES, CONNECTIVITY OF HABITATS, AND 16 17 ECOSYSTEM SERVICES PROVIDED BY NATURAL RESOURCES INCLUDING BUT NOT 18 19 LIMITED TO FLOOD CONTROL AND DRINKING WATER SUPPLY.

20 (I) TAKE INTO ACCOUNT ACTIONS TAKEN BY ENTITIES THAT HAVE VOLUNTARILY 21 AND NOT UNDER REQUIREMENTS OF OTHER STATE GREENHOUSE GAS REDUCTION 22 PROGRAMS, REDUCED THEIR GREENHOUSE GAS EMISSIONS PRIOR TO THE IMPLEMEN-TATION OF THIS TITLE RECEIVE APPROPRIATE CREDIT FOR EARLY VOLUNTARY 23 24 REDUCTIONS.

IT SHALL BE THE GOAL OF THE STATE OF NEW TO REDUCE CURRENT GREENHOUSE GAS EMISSIONS FROM ALL SOURCES WITHIN 33 YORK 34 THE STATE EIGHTY PERCENT BELOW LEVELS EMITTED IN THE YEAR NINETEEN HUNDRED NINETY BY THE YEAR TWO THOUSAND FIFTY. TO THAT END, THE CLIMATE 35 ACTION COUNCIL IS NEEDED TO FORM AND COORDINATE A PLAN TO REDUCE 36 SUCH 37 EMISSIONS. THE CLIMATE ACTION COUNCIL AND ITS PLAN FOR REDUCING SUCH EMISSIONS IS NOT INTENDED TO BE STATIC, BUT RATHER A DYNAMIC AND CONTIN-38 39 UALLY EVOLVING STRATEGY TO ASSESS AND ACHIEVE THE GOAL OF SUSTAINED 40 REDUCTIONS OF GREENHOUSE GAS EMISSIONS.

S 616. CLIMATE ACTION COUNCIL; CREATION; MEMBERSHIP. 1. THERE IS 41 HEREBY CREATED A CLIMATE ACTION COUNCIL ("COUNCIL") CONSISTING OF THE 42 COMMISSIONERS OF AGRICULTURE AND MARKETS, ECONOMIC DEVELOPMENT, ENVIRON-43 MENTAL CONSERVATION, HOUSING AND COMMUNITY RENEWAL, AND TRANSPORTATION; 44 45 THE CHAIRS OF THE PUBLIC SERVICE COMMISSION AND THE METROPOLITAN TRANS-PORTATION AUTHORITY; THE PRESIDENTS OF THE NEW YORK STATE ENERGY 46 47 RESEARCH AND DEVELOPMENT AUTHORITY, LONG ISLAND POWER AUTHORITY, NEW YORK POWER AUTHORITY AND DORMITORY AUTHORITY OF THE STATE OF NEW YORK; 48 49 THE SECRETARY OF STATE; THE DIRECTOR OF THE BUDGET; THE DIRECTOR OF 50 STATE OPERATIONS; AND THE COUNSEL TO THE GOVERNOR; PLUS SIX ADDITIONAL MEMBERS WITH INDIVIDUAL EXPERTISE IN AGRICULTURE, ECONOMIC DEVELOPMENT, 51 ENVIRONMENTAL CONSERVATION, HOUSING, TRANSPORTATION, AND ENERGY ISSUES, 52 WHO SHALL BE APPOINTED AS FOLLOWS; TWO MEMBERS BY THE TEMPORARY PRESI-53 54 DENT OF THE SENATE, TWO MEMBERS BY THE SPEAKER OF THE ASSEMBLY, ONE 55 MEMBER BY THE MINORITY LEADER OF THE SENATE AND ONE MEMBER BY THE MINOR-ITY LEADER OF THE ASSEMBLY. ALL SUCH APPOINTMENTS SHALL BE MADE BY 56

1 FEBRUARY FIRST, TWO THOUSAND ELEVEN. THE DIRECTOR OF STATE OPERATIONS 2 SHALL SERVE AS THE CHAIR OF THE COUNCIL.

3 2. MEMBERS OF THE COUNCIL MAY DESIGNATE AN EXECUTIVE STAFF MEMBER TO 4 REPRESENT THEM AND PARTICIPATE ON THE COUNCIL ON THEIR BEHALF, SUBJECT THE APPROVAL OF THE CHAIR. A MAJORITY OF THE MEMBERS OF THE COUNCIL 5 то 6 SHALL CONSTITUTE A QUORUM, AND ALL ACTIONS AND RECOMMENDATIONS OF THE 7 COUNCIL SHALL REOUIRE APPROVAL OF A MAJORITY OF THE TOTAL MEMBERS OR 8 THEIR REPRESENTATIVES. S 617. GENERAL FUNCTIONS; POWERS AND DUTIES. 1. THE COUNCIL 11 SHALL PREPARE A DRAFT CLIMATE ACTION PLAN ON OR BEFORE SEPTEMBER THIRTIETH, 12 TWO THOUSAND TEN. THE COUNCIL SHALL HOLD REGIONAL PUBLIC COMMENT HEAR-13 14 INGS ON THE DRAFT PLAN, AND SHALL ALLOW AT LEAST SIXTY DAYS FOR THE SUBMISSION OF PUBLIC COMMENT. ON OR BEFORE SEPTEMBER THIRTIETH, 15 TWO THOUSAND FIFTEEN AND EVERY FIVE YEARS THEREAFTER, THE COUNCIL SHALL UPDATE THE FINAL CLIMATE ACTION PLAN, WHICH ADDRESSES EACH ITEM IDENTI-16 17 IN SUBDIVISION TWO OF THIS SECTION. THE CLIMATE ACTION PLAN WHICH 18 FIED 19 SHALL BE REVIEWED AND, IF WARRANTED, ADJUSTED ANNUALLY BY THE COUNCIL, 20 SHALL INCLUDE A DISCUSSION AND EVALUATION OF THE ABILITY OF THE STATE 21 AND PRIVATE MARKETS TO IMPLEMENT THE POLICIES, PROGRAMS, AND OTHER RECOMMENDATIONS AS FOUND IN THE CLIMATE ACTION PLAN, AND RECOMMENDATIONS 22 FOR NEW OR AMENDED POLICIES AS NEEDED TO CONTINUE SUCCESSFUL MOVEMENT 23 24 TOWARDS IMPLEMENTATION AND REALIZATION OF SUCH POLICES AND PROGRAMS.

B. IDENTIFY AND ASSESS SHORT-TERM AND LONG-TERM ACTIONS TO REDUCE
GREENHOUSE GAS EMISSIONS AND ADAPT TO CLIMATE CHANGE ACROSS ALL ECONOMIC
SECTORS, INCLUDING INDUSTRY, TRANSPORTATION, AGRICULTURE, BUILDING
CONSTRUCTION AND ENERGY PRODUCTION;

33 C. IDENTIFY AND ANALYZE THE ANTICIPATED REDUCTIONS, AND THE ECONOMIC 34 IMPLICATIONS THEREOF, AS A RESULT OF EACH ACTION;

D. IDENTIFY THE ANTICIPATED LIFE-CYCLE IMPLICATIONS, CONSEQUENCES,
 BENEFITS AND COSTS OF IMPLEMENTING EACH ACTION, INCLUDING IMPLICATIONS,
 CONSEQUENCES, BENEFITS AND COSTS TO THE STATE, LOCAL GOVERNMENTS, BUSI NESS AND RESIDENTS FROM IMPLEMENTATION OF EACH OPTION AND ACTION;

E. IDENTIFY WHETHER SUCH ACTIONS SUPPORT NEW YORK'S GOALS FOR A CLEAN
ENERGY ECONOMY, INCLUDING SPECIFIC SHORT-TERM AND LONG-TERM ECONOMIC
DEVELOPMENT OPPORTUNITIES AND DISADVANTAGES RELATED TO GREENHOUSE GAS
EMISSION REDUCTIONS AND THE DEVELOPMENT AND DEPLOYMENT OF NEW AND EMERGING TECHNOLOGIES AND ENERGY SOURCES INCLUDING IDENTIFYING THE AVAILABILITY AND COST EFFECTIVENESS OF BEST AVAILABLE CONTROL TECHNOLOGIES;

45 F. COORDINATE ITS ACTIVITIES WITH THE STATE ENERGY PLANNING PROCESS OF 46 THE STATE ENERGY PLANNING BOARD;

G. IDENTIFY EXISTING LEGAL, REGULATORY AND POLICY CONSTRAINTS TO
REDUCING GREENHOUSE GAS EMISSIONS, ASSESSING THE IMPACTS OF CLIMATE
CHANGE, AND ADAPTING TO CLIMATE CHANGE, AND RECOMMEND MEASURES NEEDED TO
ENSURE ECOSYSTEM BASED ADOPTION TO ADDRESS ANY SUCH CONSTRAINTS;

H. EVALUATING AND ASSESSING ANY ADAPTIVE MEASURES IDENTIFIED IN TERMS

3. THE ENTITIES REPRESENTED ON THE COUNCIL ARE AUTHORIZED TO PROVIDE THE PRIMARY STAFF AND OTHER RESOURCES THAT ARE NECESSARY FOR THE COUNCIL TO COMPLY WITH THIS SECTION. IN ADDITION, EVERY OTHER AGENCY, DEPART-MENT, OFFICE, DIVISION AND PUBLIC AUTHORITY OF THIS STATE SHALL COOPER-ATE WITH THE COUNCIL AND FURNISH SUCH INFORMATION AND ASSISTANCE AS THE COUNCIL DETERMINES IS REASONABLY NECESSARY FOR IT TO COMPLY WITH THIS SECTION.

17 4. THE COUNCIL MAY CONVENE ADVISORY PANELS TO ASSIST OR ADVISE IT IN 18 AREAS REQUIRING SPECIAL EXPERTISE OR KNOWLEDGE.

19 S 4. This act shall take effect immediately.
