AN ACT to amend the executive law and the general business law, in relation to directing the office of homeland security to develop rules and regulations relating to truck rental security

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraphs (q) and (r) of subdivision 2 of section 709 of
2 the executive law, paragraph (q) as separately amended by chapters 537
3 and 620 of the laws of 2005 and paragraph (r) as added by chapter 537 of
4 the laws of 2005, are amended to read as follows:
5 (q) request from any department, division, office, commission or other
6 agency of the state or any political subdivision thereof, and the same
7 are authorized to provide, such assistance, services and data as may be
8 required by the office of homeland security in carrying out the purposes
9 of this article, subject to applicable laws, rules, and regulations;
10 [and]
11 (r) develop standards and a certification process for training
12 programs for training of private security officers in commercial build-
13 ings which shall:
14 (i) improve observation, detection and reporting skills;
15 (ii) improve coordination with local police, fire and emergency
16 services;
17 (iii) provide and improve skills in working with advanced security
18 technology including surveillance and access control procedures;
19 (iv) require at least forty hours of training including three hours of
20 training devoted to terrorism awareness; and
21 (v) have been certified as a qualified program by the state office of
22 homeland security[.];

1 S 2. Paragraph (r) of subdivision 2 of section 709 of the executive
2 law, as added by chapter 620 of the laws of 2005, is amended and a new
3 paragraph (t) is added to read as follows:

4 [(r)] (S) work in consultation with or make recommendations to the
5 commissioner of agriculture and markets in developing rules and regu-
6 lations relating to ammonium nitrate security[.]; AND

7 (T) PROMULGATE RULES AND REGULATIONS WITHIN TWELVE MONTHS OF THE
8 EFFECTIVE DATE OF THIS PARAGRAPH, IN CONSULTATION WITH THE DEPARTMENT OF
9 TRANSPORTATION AND THE DEPARTMENT OF STATE, TO ENSURE THAT:

10 (I) ANY PERSON OR ORGANIZATION, OR ANY SUBSIDIARY OR AFFILIATE,
11 INCLUDING A FRANCHISE, IN THE BUSINESS OF RENTING TRUCKS, VANS OR TRAIL-
12 ERS TO THE PUBLIC FROM LOCATIONS IN THIS STATE, BE REGISTERED WITH THE
13 OFFICE OF HOMELAND SECURITY;

14 (II) EACH SUCH PERSON OR ORGANIZATION MAINTAINS ACCURATE RECORDS OF
15 ANY PERSON RENTING A TRUCK, VAN OR TRAILER FOR AT LEAST TWO YEARS; AND

16 (III) ANY PERSON OR ORGANIZATION, OR ANY SUBSIDIARY OR AFFILIATE,
17 INCLUDING A FRANCHISE, IN THE BUSINESS OF RENTING TRUCKS, VANS OR TRAIL-
18 ERS TO THE PUBLIC REQUIRE A VALID DRIVERS LICENSE AND AT LEAST ONE OTHER
19 FORM OF IDENTIFICATION TO RENT TRUCKS, VANS OR TAILERS AND REQUIRE THAT
20 MEANINGFUL ASSURANCES ARE MADE BY THE RENTAL ENTITY TO VERIFY THE IDEN-
21 TITY OF ANY PERSON RENTING A TRUCK, VAN OR TRAILER;

22 (IV) ANY PERSON RENTING A TRUCK, VAN OR TRAILER MAY BE CHECKED AGAINST
23 STATE OR FEDERAL CRIMINAL DATABASES FOR THE PURPOSES OF SCREENING FOR
24 POSSIBLE TERRORISTS; AND

25 (V) THE OFFICE SHALL DEVELOP AND PROMOTE BEST PRACTICES FOR THE TRUCK
26 RENTAL INDUSTRY IN THIS STATE, AND WORK TO EDUCATE PERSONS AND AGENCIES
27 RENTING TRUCKS, VANS AND TRAILERS ON HOW TO DETECT AND REPORT SUSPICIOUS
28 ACTIVITY AS DEFINED BY THE OFFICE.

29 S 3. Subdivision 1 of section 396-z of the general business law is
30 amended by adding a new paragraph (k) to read as follows:

31 (K) "TRUCK RENTAL COMPANY" MEANS ANY PERSON OR ORGANIZATION, OR ANY
32 SUBSIDIARY OR AFFILIATE, INCLUDING A FRANCHISEE, IN THE BUSINESS OF
33 RENTING TRUCKS, VANS OR TRAILERS TO THE PUBLIC FROM LOCATIONS IN THIS
34 STATE.

35 S 4. Subdivision 1 of section 396-z of the general business law is
36 amended by adding a new paragraph (d) to read as follows:

37 (D) "TRUCK RENTAL COMPANY" MEANS ANY PERSON OR ORGANIZATION, OR ANY
38 SUBSIDIARY OR AFFILIATE, INCLUDING A FRANCHISEE, IN THE BUSINESS OF
39 RENTING TRUCKS, VANS OR TRAILERS TO THE PUBLIC FROM LOCATIONS IN THIS
40 STATE.

41 S 5. Section 396-z of the general business law is amended by adding a
42 new subdivision 13-b to read as follows:

43 13-B. FOR TRUCK RENTAL COMPANIES, THE FOLLOWING DISCLOSURE NOTICE
44 SHALL BE MADE ON THE FACE OF THE RENTAL AGREEMENT EITHER BY STAMP, LABEL
45 OR AS PART OF THE WRITTEN CONTRACT OR ON ANY OTHER WRITTEN DOCUMENT
46 PROVIDED TO THE AUTHORIZED DRIVER AT THE TIME SUCH DRIVER TAKES
47 POSSESSION OF THE VEHICLE, SHALL BE SET APART IN BOLDFACE TYPE AND IN NO
48 SMALLER PRINT THAN TEN POINT TYPE:

49 NOTICE: BY ENTERING INTO THIS RENTAL AGREEMENT, YOU UNDERSTAND THAT
50 YOUR NAME AND INFORMATION MAY BE CHECKED AGAINST STATE OR FEDERAL CRIMI-
51 NAL DATABASES FOR THE PURPOSES OF SCREENING FOR POSSIBLE TERRORISTS.

52 S 6. This act shall take effect on the ninetieth day after it shall
53 have become a law; provided that the amendment to section 396-z of the
54 general business law made by section three of this act shall not affect
55 the repeal of such section and shall be deemed repealed therewith, when
56 upon such date the provisions of section four of this act shall take

1 effect; and provided, further, that the amendment to section 369-z of
2 the general business law made by section five of this act shall survive
3 the repeal and reversion of such section as provided in section 2 of
4 chapter 656 of the laws of 2002, as amended; provided further that any
5 rules and regulations necessary to implement the provisions of this act
6 on its effective date are authorized and directed to be promulgated on
7 or before such effective date.
