- AN ACT to amend the waterfront commission act, in relation to empowering the waterfront commission to accept applications in the longshoremen's register; and to repeal section 5-p of such act relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 5-p of chapter 882 of the laws of 1953, constituting the waterfront commission act, is REPEALED and a new section 5-p is added to read as follows:

4 S 5-P. THE COMMISSION SHALL ACCEPT APPLICATIONS FOR INCLUSION IN THE 5 LONGSHOREMEN'S REGISTER UPON THE RECOMMENDATION IN WRITING OF STEVEDORE б AND OTHER EMPLOYERS OF LONGSHOREMEN IN THE PORT OF NEW YORK DISTRICT, 7 ACTING THROUGH THEIR REPRESENTATIVES FOR THE PURPOSE OF COLLECTIVE BARGAINING WITH A LABOR ORGANIZATION REPRESENTING SUCH LONGSHOREMEN 8 IΝ SUCH DISTRICT AND SUCH LABOR ORGANIZATION OR IN WRITING OF A STEVEDORE 9 10 OR ANOTHER EMPLOYER OF LONGSHOREMEN IN THE PORT OF NEW YORK DISTRICT WHICH DOES NOT HAVE A REPRESENTATIVE FOR THE PURPOSE OF COLLECTIVE 11 BARGAINING WITH A LABOR ORGANIZATION REPRESENTING SUCH LONGSHOREMEN. 12

S 2. If any part or provision of this act or the application thereof 13 any person or circumstances be adjudged invalid by any court of 14 to 15 competent jurisdiction, such judgment shall be confined in its operation to the part, provision or application directly involved in the contro-16 17 versy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this act or the appli-18 cation thereof to other persons or circumstances and the two 19 states hereby declare that they would have entered into this act or the remain-20 21 der thereof had the invalidity of such provisions or application thereof 22 been apparent.

1 S 3. This act constitutes an agreement between the states of New York 2 and New Jersey, supplementary to the waterfront commission compact and 3 amendatory thereof, and shall be liberally construed to effectuate the 4 purposes of said compact and the powers vested in the waterfront commis-5 sion hereby shall be construed to be in aid of and supplemental to and 6 not in limitation of or in derogation of any of the powers heretofore 7 conferred upon or delegated to the waterfront commission.

8 S 4. This act shall take effect upon the enactment into law by the state of New Jersey of legislation having an identical effect with this 9 10 act, but if the state of New Jersey shall have already enacted such legislation, then it shall take effect immediately; and provided that 11 the waterfront commission shall notify the legislative bill drafting commission upon the occurrence of the enactment of the legislation provided for in section one of this act in order that the commission may 12 13 14 15 maintain an accurate and timely effective data base of the official text laws of the state of New York in furtherance of effecting the 16 of provisions of section 44 of the legislative law and section 70-b of the 17 public officers law. 18
