AN ACT to amend the general municipal law, in relation to municipal regulation of the registration and licensing of taxicabs, limousines and livery vehicles

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Section 181 of the general municipal law, as amended by chapter 579 of the laws of 1993, subdivision 1 as amended by chapter 430 of the laws of 2003, is amended to read as follows:

- S 181. Ordinances to regulate taxicabs and limousines. 1. The municiofficers and boards in the several cities, towns and villages of this state now having the authority to enact LOCAL LAWS OR ordinances, may adopt ordinances regulating:
- The registration and licensing of taxicabs and may limit the number of taxicabs to be licensed and the county of Westchester AND THE COUNTY OF ROCKLAND, may adopt LOCAL LAWS OR ordinances regulating the registration and licensing of taxicabs [and], limousines AND LIVERY VEHICLES and may limit the number to be licensed; and the county of Nassau may adopt ordinances regulating the registration of taxicabs and limousines.
- 14 Parking and passenger pick-up and discharge by taxicabs, [2] B. limousines and livery vehicles. Establishment of such ordinances and regulations regulating parking and passenger pick-up and discharges may be based upon recommendations from municipal planning officials or other public entities and may address and take into consideration such factors, including, but not limited to, geographic areas, vehicle type, 20 limiting the number of parked vehicles and activities undertaken while 21 22 parked, and periods of idling.

- 2. EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, ANY LOCAL LAW OR ORDINANCE ADOPTED BY THE COUNTY OF WESTCHESTER OR THE COUNTY OF ROCKLAND PURSUANT TO SUBDIVISION ONE OF THIS SECTION SHALL SUPERSEDE ANY SUCH LOCAL LAW OR ORDINANCE ADOPTED BY A CITY, TOWN OR VILLAGE LOCATED WITHIN SUCH COUNTIES.
 - 3. THE COUNTY OF WESTCHESTER AND THE COUNTY OF ROCKLAND AFTER THE ADOPTION OF A LOCAL LAW OR ORDINANCE REGULATING THE LICENSING OF TAXI-CABS, LIMOUSINES AND LIVERY VEHICLES, MAY ENTER INTO AGREEMENTS WITH A MUNICIPAL CORPORATION OF ANOTHER STATE, OR WITH ANOTHER STATE, TO PROVIDE FOR THE RECIPROCAL RECOGNITION OF LICENSES ISSUED TO TAXICABS, LIMOUSINES AND LIVERY VEHICLES.
- 4. THE COUNTY OF WESTCHESTER MAY ENTER INTO AGREEMENTS WITH THE COUNTY
 OF ROCKLAND TO ISSUE LICENSES ON BEHALF OF EITHER OR BOTH OF THOSE COUNTIES PURSUANT TO THE AUTHORITY CONTAINED IN THIS SECTION AND TO IMPOSE
 PENALTIES FOR VIOLATIONS OF THE SAME.
- 16 5. ANY VILLAGE WITHIN THE COUNTY OF ROCKLAND THAT CURRENTLY REGISTERS 17 AND LICENSES TAXICABS SHALL HAVE CONCURRENT JURISDICTION WITH SUCH COUN-18 TY.
- 19 S 2. This act shall take effect immediately.
