AN ACT to amend the penal law, in relation to authorizing the county clerk to grant amendments to firearms licenses, under the Westchester county handgun record-keeping and accountability act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 5 and 9 of section 400.00 of the penal law, 2 subdivision 5 as amended by chapter 332 of the laws of 1994 and subdivi-3 sion 9 as amended by chapter 172 of the laws of 1973, are amended to 4 read as follows:

5 5. Filing of approved applications. The application for any license, if granted, shall be filed by the licensing officer with the clerk of 6 the county of issuance, except that in the city of New York and, in the 7 8 counties of Nassau and Suffolk, the licensing officer shall designate the place of filing in the appropriate division, bureau or unit of the 9 police department thereof, and in the county of Suffolk the county clerk 10 is hereby authorized to transfer all records or applications relating to 11 firearms to the licensing authority of that county. The name and address 12 13 of any person to whom an application for any license has been granted shall be a public record. Upon application by a licensee who has changed 14 15 OR HER place of residence such records or applications shall be his 16 transferred to the appropriate officer at the licensee's new place of residence. A duplicate copy of such application shall be filed by the 17 18 licensing officer in the executive department, division of state police, Albany, within ten days after issuance of the license; PROVIDED, 19 HOWEV-COUNTY OF WESTCHESTER THE COUNTY CLERK SHALL FILE A 20 THE ER, THAT IN DUPLICATE COPY OF SUCH APPLICATION WITH THE EXECUTIVE DEPARTMENT, 21 DIVI-22 POLICE, ALBANY WITHIN TEN DAYS AFTER ISSUANCE OF THE SION OF STATE 23 LICENSE. Elsewhere than in the city of New York OR COUN-TY OF WESTCHESTER, a person licensed to carry or possess a pistol or revolver may apply at any time to his OR HER licensing officer for 4 5 б amendment of his OR HER license to [include] ADD one or more such weap-7 ons or to [cancel] REMOVE weapons held under license. If granted, a 8 record of the amendment describing the weapons involved shall be filed 9 by the licensing officer in the executive department, division of state 10 Albany. IN THE COUNTY OF WESTCHESTER, A PERSON LICENSED TO police, CARRY OR POSSESS A PISTOL OR REVOLVER MAY APPLY AT ANY TIME TO THE COUN-11 TY CLERK OF SUCH COUNTY FOR AMENDMENT TO HIS OR HER LICENSE TO 12 ADD ONE MORE SUCH WEAPONS OR TO REMOVE WEAPONS HELD UNDER THE LICENSE. SUCH 13 OR 14 AMENDMENT SHALL BE GRANTED IMMEDIATELY BY THE COUNTY CLERK OF THE COUNTY 15 OF WESTCHESTER, AND A RECORD OF THE AMENDMENT DESCRIBING THE WEAPONS 16 INVOLVED SHALL BE FILED BY SUCH CLERK IN THE EXECUTIVE DEPARTMENT, DIVI-SION OF STATE POLICE, ALBANY. Notification of any change of residence 17 shall be made in writing by any licensee within ten days after such 18 19 change occurs, and a record of such change shall be inscribed by such 20 licensee on the reverse side of his OR HER license. Elsewhere than in 21 city of New York, and in the counties of Nassau [and], Suffolk AND the 22 WESTCHESTER, such notification shall be made to the executive depart-23 ment, division of state police, Albany, and in the city of New York to the police commissioner of that city, and in the county of Nassau to the 24 25 police commissioner of that county, and in the county of Suffolk to the 26 licensing officer of that county, who shall, within ten days after such notification shall be received by him OR HER, give notice in writing of 27 28 such change to the executive department, division of state police, at 29 Albany. IN THE COUNTY OF WESTCHESTER, A PERSON LICENSED TO CARRY OR POSSESS A PISTOL OR REVOLVER SHALL NOTIFY THE COUNTY CLERK OF SUCH COUN-30 31 OF HIS OR HER CHANGE OF RESIDENCE IN WRITING WITHIN TEN DAYS OF SUCH ΤY 32 CHANGE, AND SUCH COUNTY CLERK SHALL GIVE NOTICE IN WRITING OF SUCH CHANGE TO THE EXECUTIVE DEPARTMENT, DIVISION OF STATE POLICE, AT ALBANY, 33 TEN DAYS OF SUCH CLERK'S RECEIPT OF NOTIFICATION OF A CHANGE OF 34 WITHIN RESIDENCE. THE CHANGE OF RESIDENCE AMENDMENT SHALL BE GRANTED IMMEDIATE-35 LY BY THE COUNTY CLERK OF THE COUNTY OF WESTCHESTER. 36

37 S 2. This act shall take effect immediately and shall apply to 38 licenses issued on or after such date.
