AN ACT to amend the executive law, in relation to the establishment of the New York state disaster preparedness plan act of 2009

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act shall be known and may be cited as the "New York
2 state disaster preparedness plan act of 2009".
3 S 2. The executive law is amended by adding a new section 716 to read
4 as follows:
5 S 716. DISASTER PREPAREDNESS PLAN PROGRAM. THE NEW YORK STATE OFFICE
6 OF HOMELAND SECURITY IS HEREBY DIRECTED TO CONDUCT AN INVESTIGATION AND
7 STUDY ON THE ISSUE OF THE ESTABLISHMENT OF A NEW YORK STATE DISASTER
8 PREPAREDNESS PLAN PROGRAM. SUCH INVESTIGATION AND STUDY SHALL BE
9 COMPLETED ON OR BEFORE DECEMBER THIRTY-FIRST, TWO THOUSAND TEN. WITHIN
10 NINETY DAYS OF THE COMPLETION OF SUCH INVESTIGATION AND STUDY, THE NEW
11 YORK STATE OFFICE OF HOMELAND SECURITY SHALL COMPLETE AND DELIVER, TO
12 THE CHAIR OF THE SENATE STANDING COMMITTEE ON VETERANS, HOMELAND SECURI-
13 TY AND MILITARY AFFAIRS AND THE CHAIR OF THE ASSEMBLY STANDING COMMITTEE
14 ON GOVERNMENTAL OPERATIONS, A REPORT ON SUCH INVESTIGATION AND STUDY,
15 CONTAINING RECOMMENDATIONS TO THE LEGISLATURE ON THE ESTABLISHMENT OF A
16 NEW YORK STATE DISASTER PREPAREDNESS PLAN PROGRAM. SUCH RECOMMENDATIONS
17 SHALL INCLUDE WHAT MEASURES NEED TO BE TAKEN BY NEW YORK STATE TO ESTAB-
18 LISH SUCH A PROGRAM, WHAT LAWS SHOULD BE AMENDED OR ADDED TO ESTABLISH
19 SUCH A PROGRAM, AND WHAT FISCAL RESOURCES WOULD NEED TO BE APPROPRIATED
20 AND EXPENDED, IF ANY, TO ESTABLISH SUCH A PROGRAM.
21 S 3. This act shall take effect immediately.
