Introduced by Sens. SAVINO, LANZA -- read twice and ordered printed, and when printed to be committed to the Committee on Cultural Affairs, Tourism, Parks and Recreation

AN ACT to amend the navigation law, in relation to clarifying the continuity of a deck of a vessel for the determination of pilotage units used in calculating pilotage fees

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph (c) of subdivision 4 of section 88 of the naviga-  
2 tion law, as added by chapter 197 of the laws of 1990, is amended to  
3 read as follows:

4 (c) Definitions. "Overall length" is the distance between the forward  
5 and after extremities of the vessel.

6 "Extreme breadth" is the maximum breadth to the outside of the shell  
7 plating of the vessel.

8 "Depth" is the vertical distance at amidships from the top of the keel  
9 plate to the uppermost continuous deck, fore and aft, and which extends  
10 to the sides of the vessel. The continuity of a deck shall not be  
11 considered to be affected by the existence of OPENINGS, INCLUDING BUT  
12 NOT LIMITED TO tonnage openings, engine spaces or a step in the deck.

13 All measurements shall be in feet and inches (U.S.).

14 The board of commissioners of pilots shall be the sole arbiter with  
15 respect to a question concerning these definitions. The decision by the  
16 board shall be final.

17 S 2. Paragraph (c) of subdivision 4 of section 89-a of the navigation  
18 law, as added by chapter 197 of the laws of 1990, is amended to read as  
19 follows:

20 (c) Definitions: "Overall length" is the distance between the forward  
21 and after extremities of the vessel.

22 "Extreme breadth" is the maximum breadth to the outside of the shell  
23 plating of the vessel.
