AN ACT to authorize the county of Nassau to convey to the Manhasset-Lakeville water district, a special district of the town of North Hempstead, an easement through land located in the county's Leeds Pond Preserve to be used to install an underground water main, to extend and improve the existing public water supply system

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The county of Nassau, acting by and through its county
2 legislature, is hereby authorized to convey by appropriate instruments
3 to the board of commissioners of the Manhasset-Lakeville water district,
4 a special district of the town of North Hempstead, county of Nassau and
5 state of New York, a permanent easement over and under certain portions
6 of the lands located in the county's Leeds Pond Preserve described in
7 section two of this act, for the purpose of enabling such water district
8 to construct, operate and maintain a transmission main which will extend
9 the existing public water supply system. Upon completion of
10 construction, the water district shall restore the surface of the lands
11 and the lands shall continue to be used for park purposes. In exchange
12 for such conveyance, the water district shall provide to the county
13 consideration equal to the fair market value of the interest being
14 conveyed.

15 S 2. The area subject to the easement to be conveyed by the county of
16 Nassau pursuant to the provisions of this act is described as follows:

17 All that certain plot, piece or parcel of land with buildings and
18 improvements thereon erected, situate, lying and being located at
19 Manhasset, Town of North Hempstead, County of Nassau and State of New
20 York being more particularly bounded and described as follows:

21 Beginning at a point on the widened Easterly side of Plandome Road,
22 said point being the Southwest corner of Lot 151 as shown on the Map of

1 Plandome Wood, Section 1, filed August 1, 1956 as case number 6728. Said
2 point of beginning being South 01 Degrees 50 Minutes 30 Seconds West,
3 297.70 feet from the intersection of the Easterly side of Plandome Road
4 with the Southerly side of Elm Sea Lane.

5 Thence partly along the southerly line of the Map of Plandome Wood
6 Section 1, South 74 Degrees 24 Minutes 22 Seconds East a distance of
7 339.63 feet;

8 Thence along the Southerly line of the Map of Plandome Wood Section 1
9 and the Map of Plandome Wood Section 2, North 70 Degrees 54 Minutes 13
10 Seconds East a distance of 1140.27 feet to the Westerly line of the Map
11 of Manhasset Estates;

12 Thence along the Westerly line of Manhasset Estates, South 19 Degrees
13 03 Minutes 57 Seconds East a distance of 161.94 feet to the Northerly
14 line of the Map of Plandome Mill Amended Map Number 2;

15 Thence along the Northerly line of the Map of Plandome Mill, Amended
16 Map Number 2, South 63 Degrees 30 Minutes 53 Seconds West a distance of
17 15.13 feet;

18 Thence North 19 Degrees 03 Minutes 57 Seconds West a distance of
19 148.88 feet;

20 Thence South 70 Degrees 54 Minutes 13 Seconds West a distance of
21 1129.95 feet;

22 Thence North 74 Degrees 24 Minutes 22 Seconds West a distance of
23 368.45 feet to the Southerly line of Plandome Road;

24 Thence North 15 Degrees 35 Minutes 38 Seconds East, 15.00 feet;

25 Thence South 74 Degrees 24 Minutes 22 Seconds East a distance of 24.14
26 feet to the point or place of BEGINNING.

27 The described property having an area of 24,849.46 square feet or 0.57
28 acres.

29 S 3. If the parkland or recreational facility being alienated by this
30 act has received federal funding pursuant to the land and water conser-
31 vation fund, then the federal conversion process shall be followed prior
32 to the transfer of parkland as stated in this act.

33 S 4. If the parkland or recreational facility being alienated by this
34 act has received federal funding pursuant to the urban park and recre-
35 ation and recovery program, then the federal conversion process shall be
36 followed prior to the transfer of parklands as stated in this act.

37 S 5. This act shall take effect immediately.
