AN ACT to amend the environmental conservation law, in relation to allowing the use of rifles for hunting in Ontario county

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907
2 of the environmental conservation law, as amended by a chapter of the
3 laws of 2009 amending the environmental conservation law relating to the
4 use of rifles for hunting in Ontario county, as proposed in legislative
5 bills numbers S.6057 and A.7581-A, is amended to read as follows:

7 Allegany,	after November 15	muzzle loading
8 Cattaraugus, Chemung,	through first Tuesday	firearm,
9 Chenango, Herkimer,	after December 7	rifle or

19 S 3. This act shall take effect on the same date as a chapter of the
20 laws of 2009 amending the environmental conservation law relating to the
21 use of rifles for hunting in Ontario county, as proposed in legislative
22 bills numbers S.6057 and A.7581-A, takes effect; provided that the
23 amendment to item (i) of paragraph a of subdivision 2 of section 11-0907
24 of the environmental conservation law made by section one of this act
25 shall be subject to the expiration and reversion of such item pursuant
26 to section 13 of chapter 600 of the laws of 1993, as amended, when upon
27 such date the provisions of section two of this act shall take effect.
