AN ACT to amend the real property tax law and the tax law, in relation to the "Middle Class STAR" rebate program; to amend the tax law, in relation to creating the middle class circuit breaker tax credit; to amend the education law, in relation to establishing limitations upon school district tax levies; and to amend the administrative code of the city of New York, in relation to an enhanced personal income tax credit in New York city

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The real property tax law is amended by adding a new
2 section 1306-b to read as follows:
3 S 1306-B. "MIDDLE CLASS STAR" REBATE PROGRAM. 1. TAX REBATES. (A) IF A
4 PARCEL IS ENTITLED TO THE BASIC OR ENHANCED STAR EXEMPTION AUTHORIZED BY
5 SECTION FOUR HUNDRED TWENTY-FIVE OF THIS CHAPTER FOR THE TWO THOUSAND
6 TEN--TWO THOUSAND ELEVEN SCHOOL YEAR AND EACH YEAR THEREAFTER, EXCEPT AS
7 PROVIDED IN PARAGRAPH (G) OF SUBDIVISION THREE OF THIS SECTION, A LOCAL
8 PROPERTY TAX REBATE SHALL BE PROVIDED TO THE OWNER OR OWNERS OF SUCH
9 PARCEL AS SHOWN ON THE FINAL ASSESSMENT ROLL FOR SUCH YEAR, IN AN AMOUNT
10 COMPUTED AS PRESCRIBED BY THIS SECTION AND SECTION ONE HUNDRED SEVENTY-
11 EIGHT OF THE TAX LAW.
12 (B) IT SHALL BE THE RESPONSIBILITY OF THE STATE DEPARTMENT OF TAXATION
13 AND FINANCE TO ISSUE SUCH TAX REBATES TO SUCH OWNERS IN THE MANNER
14 PROVIDED BY SECTION ONE HUNDRED SEVENTY-EIGHT OF THE TAX LAW. NOTHING
15 CONTAINED HEREIN SHALL BE CONSTRUED AS PERMITTING PARTIAL OR INSTALLMENT

2 PURSUANT TO LAW.

3 2. PROCEDURE. (A) ON OR BEFORE AUGUST FIFTEENTH EACH YEAR, THE EXECU-
4 TIVE DIRECTOR OF THE OFFICE OF REAL PROPERTY SERVICES, OR HIS OR HER
5 DESIGNEE, OR ON OR BEFORE JULY FIRST EACH YEAR, IN THE CASE OF A CITY
6 WITH A POPULATION OF ONE MILLION OR MORE, THE COMMISSIONER OF FINANCE,
7 OR HIS OR HER DESIGNEE, SHALL PROVIDE TO THE COMMISSIONER OF TAXATION
8 AND FINANCE A REPORT IN A MUTUALLY AGREEABLE FORMAT CONCERNING THOSE
9 PARCELS WHICH HAVE BEEN GRANTED AN EXEMPTION AUTHORIZED BY SECTION FOUR
10 HUNDRED TWENTY-FIVE OF THIS CHAPTER ON THE ASSESSMENT ROLLS USED TO
11 GENERATE THE SCHOOL TAX BILLS FOR THE TWO THOUSAND TEN--TWO THOUSAND
12 ELEVEN SCHOOL TAX YEAR AND FOR EACH YEAR THEREAFTER; EXCEPT AS PROVIDED
13 IN PARAGRAPH (G) OF SUBDIVISION THREE OF THIS SECTION, PROVIDED HOWEVER
14 THE INFORMATION TO BE PROVIDED ON SUCH REPORT SHALL BE OBTAINED FROM THE
15 FINAL ASSESSMENT ROLL DATA FILES USED TO GENERATE THE TWO THOUSAND TEN-
16 -TWO THOUSAND ELEVEN SCHOOL TAX BILLS AND EACH YEAR THEREAFTER, FILED
17 WITH THE STATE BOARD PURSUANT TO SECTION FIFTEEN HUNDRED NINETY OF THIS
18 CHAPTER ON OR BEFORE JULY THIRTY-FIRST OF SUCH YEAR. SUCH REPORT SHALL
19 SET FORTH THE NAMES AND MAILING ADDRESSES OF THE OWNERS OF SUCH PARCELS
20 AS SHOWN ON SUCH ASSESSMENT ROLL DATA FILES, THE IDENTIFICATION NUMBERS
21 OF SUCH PARCELS AS SHOWN ON SUCH ASSESSMENT ROLL DATA FILES, AND SUCH
22 OTHER INFORMATION IN THE POSSESSION OF THE OFFICE OF REAL PROPERTY
23 SERVICES, OR IN THE CASE OF A CITY WITH A POPULATION OF ONE MILLION OR
24 MORE, THE COMMISSIONER OF FINANCE, AS THE COMMISSIONER OF TAXATION AND
25 FINANCE MAY DEEM NECESSARY FOR THE EFFECTIVE ADMINISTRATION OF THIS
26 PROGRAM, INCLUDING INFORMATION REGARDING COOPERATIVE APARTMENT BUILDINGS
27 AND MOBILE HOME PARKS OR SIMILAR PROPERTY. IT SHALL BE THE RESPONSIBIL-
28 ITY OF THE ASSESSOR OR ASSESSORS OF EACH ASSESSING UNIT TO ENSURE THAT
29 THE NAMES AND MAILING ADDRESSES OF SUCH OWNERS ARE ACCURATELY RECORDED
30 ON SUCH ROLLS AND FILES TO THE BEST OF HIS OR HER ABILITY, BASED UPON
31 THE INFORMATION CONTAINED IN HIS OR HER OFFICE. NOTHING CONTAINED IN
32 THIS SUBDIVISION SHALL BE CONSTRUED AS AFFECTING IN ANY WAY THE VALIDITY
33 OR ENFORCEABILITY OF A REAL PROPERTY TAX, OR THE APPLICABILITY OF INTER-
34 EST OR PENALTIES WITH RESPECT THERETO, WHEN AN OWNER'S NAME OR MAILING
35 ADDRESS HAS NOT BEEN ACCURATELY RECORDED.

36 (B) (I) NOTWITHSTANDING THE PROVISIONS OF PARAGRAPH (A) OF THIS SUBDI-
37 VISION, WHERE AN ASSESSING UNIT CONTAINS ONE OR MORE PROPERTIES WHICH
38 ARE RECEIVING SUCH EXEMPTION IN RELATION TO A PRIOR YEAR ASSESSMENT ROLL
39 PURSUANT TO PARAGRAPH (D) OF SUBDIVISION SIX OF SECTION FOUR HUNDRED
40 TWENTY-FIVE OF THIS CHAPTER, OR CONTAINS ONE OR MORE PARCELS WITH
41 RESPECT TO WHICH SUCH EXEMPTION WAS DULY ADDED OR REMOVED AFTER THE
42 FILING OF THE FINAL ASSESSMENT ROLL PURSUANT TO THE PROVISIONS OF TITLE
43 THREE OF ARTICLE FIVE OF THIS CHAPTER, THE OFFICE OF REAL PROPERTY
44 SERVICES MAY REQUIRE THE ASSESSOR TO FILE WITH IT, ON OR BEFORE JULY
45 THIRTY-FIRST EACH YEAR, OR SUCH LATER DATE AS SUCH OFFICE MAY SPECIFY, A
46 SUPPLEMENTAL REPORT RELATING TO SUCH PROPERTY OR PROPERTIES, SO THAT
47 INFORMATION PERTAINING TO THE OWNERS THEREOF MAY BE INCLUDED IN THE
48 REPORT TO BE MADE TO THE COMMISSIONER OF TAXATION AND FINANCE PURSUANT
49 TO THIS PARAGRAPH. WHEN ANY INFORMATION REQUIRED BY THIS PARAGRAPH IS
50 RECEIVED BY THE OFFICE OF REAL PROPERTY SERVICES AFTER JULY THIRTY-FIRST
51 EACH YEAR, SUCH INFORMATION SHALL BE TRANSMITTED AS SOON AS REASONABLY
52 PRACTICABLE TO THE COMMISSIONER OF TAXATION AND FINANCE FOR USE IN ISSU-
53 ING LOCAL PROPERTY TAX REBATES PURSUANT TO SECTION ONE HUNDRED SEVENTY-
54 EIGHT OF THE TAX LAW.

55 (II) WHERE THE OWNERSHIP OF A PARCEL THAT HAD BEEN ELIGIBLE FOR A
56 REBATE PURSUANT TO THIS SECTION CHANGES OR AN EXEMPTION UNDER SECTION

1 FOUR HUNDRED TWENTY-FIVE OF THIS CHAPTER HAS BEEN GRANTED OR REMOVED,
2 THE ASSESSOR SHALL NOTIFY THE STATE BOARD OF THE CHANGE NO LATER THAN
3 AUGUST FIRST OF THE FOLLOWING YEAR. THE STATE BOARD SHALL FORWARD SUCH
4 REPORT TO THE DEPARTMENT OF TAXATION AND FINANCE IN A TIMELY MANNER AND
5 IN A MUTUALLY-AGREEABLE FORMAT.

6 3. REBATE BASE. (A) THE STATE BOARD SHALL CALCULATE THE REBATE BASE
7 AS PROVIDED HEREIN AND CERTIFY THE SAME TO THE DEPARTMENT OF TAXATION
8 AND FINANCE NO LATER THAN JULY FIRST EACH YEAR.

9 (B) TWO REBATE BASES FOR THE BASIC STAR EXEMPTION SHALL BE DETERMINED
10 FOR EACH SEGMENT FOR THE TWO THOUSAND TEN--TWO THOUSAND ELEVEN AND
11 SUBSEQUENT SCHOOL YEARS. SUCH REBATE BASES SHALL BE COMPUTED BY DETER-
12 MINING THE EXEMPT AMOUNT ESTABLISHED FOR THE SEGMENT FOR PURPOSES OF THE
13 BASIC STAR EXEMPTION FOR THE TWO THOUSAND TEN--TWO THOUSAND ELEVEN AND
14 SUBSEQUENT SCHOOL YEARS, MULTIPLYING THAT AMOUNT BY THE SCHOOL DISTRICT
15 TAX RATE APPLICABLE WITHIN THAT SEGMENT FOR PURPOSES OF THE TWO THOUSAND
16 TEN--TWO THOUSAND ELEVEN AND SUBSEQUENT SCHOOL YEARS, AS REPORTED BY THE
17 SCHOOL DISTRICT. FOR THE TWO THOUSAND TEN--TWO THOUSAND ELEVEN AND
18 SUBSEQUENT SCHOOL YEARS, SUCH REBATE BASES SHALL BE COMPUTED BY MULTI-
19 PLYING THE PRODUCT BY SIXTY PERCENT AND FORTY-FIVE PERCENT, RESPECTIVE-
20 LY. THE RESULTS SHALL BE ASSOCIATED WITH THE FIRST AND SECOND INCOME
21 BRACKETS, RESPECTIVELY, THAT ARE APPLICABLE WITHIN THAT SEGMENT.

22 (B-1) (I) THE FIRST INCOME BRACKET SHALL BE UP TO AND INCLUDING ONE
23 HUNDRED TWENTY THOUSAND DOLLARS; THE SECOND INCOME BRACKET SHALL BE OVER
24 ONE HUNDRED TWENTY THOUSAND DOLLARS UP TO AND INCLUDING ONE HUNDRED
25 FIFTY THOUSAND DOLLARS.

26 (II) SUCH BRACKETS ARE SUBJECT TO INDEXING FOR INFLATION PURSUANT TO
27 SUBDIVISION FIFTEEN OF SECTION ONE HUNDRED SEVENTY-EIGHT OF THE TAX LAW.

28 (C) ONE REBATE BASE FOR THE ENHANCED STAR EXEMPTION SHALL BE DETER-
29 MINED FOR EACH SEGMENT FOR THE TWO THOUSAND TEN--TWO THOUSAND ELEVEN AND
30 SUBSEQUENT SCHOOL YEARS. SUCH REBATE BASES SHALL BE COMPUTED BY DETER-
31 MINING THE EXEMPT AMOUNT ESTABLISHED FOR THE SEGMENT FOR PURPOSES OF THE
32 ENHANCED STAR EXEMPTION FOR THE TWO THOUSAND TEN--TWO THOUSAND ELEVEN
33 SCHOOL YEAR. SUCH REBATE BASES SHALL BE COMPUTED BY MULTIPLYING THAT
34 AMOUNT BY THE SCHOOL DISTRICT TAX RATE APPLICABLE WITHIN THAT SEGMENT
35 FOR PURPOSES OF THAT SCHOOL YEAR, AS REPORTED BY THE SCHOOL DISTRICT,
36 AND THEN MULTIPLYING THE PRODUCT.

37 (D) FOR PURPOSES OF THIS SECTION, THE TERM "SEGMENT" MEANS THE PART OF
38 A CITY OR TOWN THAT IS WITHIN A SCHOOL DISTRICT.

39 (E) IN THE CASE OF SCHOOL DISTRICTS WITHIN SPECIAL ASSESSING UNITS AS
40 DEFINED IN SECTION EIGHTEEN HUNDRED ONE OF THIS CHAPTER, THE SCHOOL
41 DISTRICT TAX RATE TO BE USED FOR THIS PURPOSE SHALL BE THE TAX RATE
42 APPLICABLE TO CLASS ONE PROPERTIES AS DEFINED IN ARTICLE EIGHTEEN OF
43 THIS CHAPTER, AS REPORTED BY THE SCHOOL DISTRICT AND THE EXEMPT AMOUNT
44 SHALL BE ESTABLISHED FOR THE SEGMENT. IN THE CASE OF SCHOOL DISTRICTS
45 WITHIN APPROVED ASSESSING UNITS AS DEFINED IN SECTION NINETEEN HUNDRED
46 ONE OF THIS CHAPTER WHICH HAVE ADOPTED THE PROVISIONS OF SECTION NINE-
47 TEEN HUNDRED THREE OF THIS CHAPTER, THE SCHOOL DISTRICT TAX RATE TO BE
48 USED FOR THIS PURPOSE SHALL BE THE TAX RATE APPLICABLE TO THE HOMESTEAD
49 CLASS, AS DEFINED IN ARTICLE NINETEEN OF THIS CHAPTER, AS REPORTED BY
50 THE SCHOOL DISTRICT.

51 (F) WHERE THE PROVISIONS OF SUBPARAGRAPH (IV) OF PARAGRAPH (K) OF
52 SUBDIVISION TWO OF SECTION FOUR HUNDRED TWENTY-FIVE OF THIS CHAPTER ARE
53 APPLICABLE, THE APPLICABLE REBATE AMOUNT SHALL BE ONE-THIRD OF THE
54 OTHERWISE APPLICABLE REBATE AMOUNT SET FORTH IN PARAGRAPH (B) OR (C) OF
55 THIS SUBDIVISION. THE STATE BOARD SHALL CALCULATE AND CERTIFY TO THE
56 DEPARTMENT OF TAXATION AND FINANCE THE REBATE AMOUNTS APPLICABLE IN SUCH

1 CASES, ALONG WITH THE CERTIFICATION REQUIRED BY PARAGRAPH (A) OF THIS
2 SUBDIVISION.

3 (G) FOR THE PURPOSES OF THE TWO THOUSAND TEN--TWO THOUSAND ELEVEN
4 SCHOOL YEAR AND EACH YEAR THEREAFTER, TAX REBATES AUTHORIZED PURSUANT TO
5 THIS SECTION SHALL APPLY ONLY TO THOSE OWNERS WHO:

6 (I) HAVE ATTAINED THE AGE OF SIXTY-FIVE YEARS OR OLDER; AND

7 (II) HAVE "AFFILIATED INCOME" AS DEFINED IN PARAGRAPH (B) OF SUBDIVI-
8 SION SIX OF SECTION ONE HUNDRED SEVENTY-EIGHT OF THE TAX LAW EQUAL TO OR
9 LESS THAN ONE HUNDRED FIFTY THOUSAND DOLLARS.

10 S 2. The real property tax law is amended by adding a new section 1307
11 to read as follows:

12 S 1307. LIMITATIONS UPON SCHOOL DISTRICT TAX LEVIES. 1. GENERALLY.
13 UNLESS OTHERWISE PROVIDED BY LAW, THE AMOUNT OF TAXES THAT MAY BE LEVIED
14 BY OR ON BEHALF OF ANY SCHOOL DISTRICT, OTHER THAN A CITY SCHOOL
15 DISTRICT OF A CITY WITH ONE HUNDRED TWENTY-FIVE THOUSAND INHABITANTS OR
16 MORE, SHALL NOT EXCEED THE TAX LEVY LIMITATIONS ESTABLISHED PURSUANT TO
17 SECTION TWO THOUSAND TWENTY-THREE-A OF THE EDUCATION LAW. IT SHALL BE
18 THE RESPONSIBILITY OF THE COMMISSIONER OF EDUCATION TO ANNUALLY DETER-
19 MINE THE TAX LEVY LIMIT OF EACH SCHOOL DISTRICT IN ACCORDANCE WITH THE
20 PROVISIONS OF THIS SECTION.

21 2. DEFINITIONS. AS USED IN THIS SECTION:

22 (A) "AVAILABLE CARRYOVER" MEANS THE SUM OF THE AMOUNTS BY WHICH THE
23 TAX LEVY FOR EACH SCHOOL YEAR FROM THE TWO THOUSAND TEN--TWO THOUSAND
24 ELEVEN SCHOOL YEAR THROUGH THE PRIOR SCHOOL YEAR WAS BELOW THE APPLICA-
25 BLE TAX LEVY LIMIT FOR SUCH SCHOOL YEAR, IF ANY.

26 (B) "CAPITAL LOCAL EXPENDITURES" MEANS THE TAXES ASSOCIATED WITH BUDG-
27 ETED EXPENDITURES RESULTING FROM THE CONSTRUCTION, ACQUISITION, RECON-
28 STRUCTION, REHABILITATION OR IMPROVEMENT OF SCHOOL BUILDINGS, INCLUDING
29 DEBT SERVICE AND LEASE EXPENDITURES, SUBJECT TO THE APPROVAL OF THE
30 QUALIFIED VOTERS WHERE REQUIRED BY LAW.

31 (C) "CAPITAL TAX LEVY" MEANS THE TAX LEVY NECESSARY TO SUPPORT CAPITAL
32 LOCAL EXPENDITURES, IF ANY.

33 (D) "COMING SCHOOL YEAR" MEANS THE SCHOOL YEAR FOR WHICH TAX LEVY
34 LIMITS ARE BEING DETERMINED PURSUANT TO THIS SECTION.

35 (E) "INFLATION FACTOR" MEANS THE PERCENTAGE THAT REPRESENTS THE PROD-
36 UCT OF ONE HUNDRED AND THE QUOTIENT OF: (I) THE AVERAGE OF THE NATIONAL
37 CONSUMER PRICE INDEXES DETERMINED BY THE UNITED STATES DEPARTMENT OF
38 LABOR FOR THE TWELVE MONTH PERIOD PRECEDING JANUARY FIRST OF THE CURRENT
39 YEAR MINUS THE AVERAGE OF THE NATIONAL CONSUMER PRICE INDEXES DETERMINED
40 BY THE UNITED STATES DEPARTMENT OF LABOR FOR THE TWELVE-MONTH PERIOD
41 PRECEDING JANUARY FIRST OF THE PRIOR YEAR, DIVIDED BY: (II) THE AVERAGE
42 OF THE NATIONAL CONSUMER PRICE INDEXES DETERMINED BY THE UNITED STATES
43 DEPARTMENT OF LABOR FOR THE TWELVE-MONTH PERIOD PRECEDING JANUARY FIRST
44 OF THE PRIOR YEAR, WITH THE RESULT EXPRESSED AS A DECIMAL TO TWO PLACES.

45 (F) "LEVY GROWTH FACTOR" SHALL BE THE LESSER OF: (I) FOUR PERCENT; OR
46 (II) ONE HUNDRED TWENTY PERCENT OF THE INFLATION FACTOR.

47 (G) "PRIOR SCHOOL YEAR" MEANS THE SCHOOL YEAR IMMEDIATELY PRECEDING
48 THE COMING SCHOOL YEAR.

49 (H) "SCHOOL DISTRICT" MEANS A COMMON SCHOOL DISTRICT, UNION FREE
50 SCHOOL DISTRICT, CENTRAL SCHOOL DISTRICT, CENTRAL HIGH SCHOOL DISTRICT
51 OR A CITY SCHOOL DISTRICT IN A CITY WITH LESS THAN ONE HUNDRED
52 TWENTY-FIVE THOUSAND INHABITANTS.

53 (I) "TAX LEVY BASE" MEANS THE AMOUNT OF TAXES A SCHOOL DISTRICT WOULD
54 BE AUTHORIZED TO LEVY WITHOUT THE ADDITION OF ANY AVAILABLE CARRYOVER
55 AMOUNT.

1 (J) "TAX LEVY LIMIT" MEANS THE AMOUNT OF TAXES A SCHOOL DISTRICT IS
2 AUTHORIZED TO LEVY PURSUANT TO THIS SECTION, PROVIDED, HOWEVER, THAT THE
3 TAX LEVY LIMIT SHALL NOT INCLUDE THE DISTRICT'S CAPITAL TAX LEVY, IF
4 ANY.

5 3. TAX BASE GROWTH FACTOR. (A) NO LATER THAN MARCH FIRST OF EACH YEAR,
6 THE STATE BOARD SHALL IDENTIFY THOSE SCHOOL DISTRICTS FOR WHICH TAX BASE
7 GROWTH FACTORS MUST BE DETERMINED FOR THE COMING SCHOOL YEAR, AND SHALL
8 NOTIFY THE COMMISSIONER OF EDUCATION OF THE TAX BASE GROWTH FACTORS SO
9 DETERMINED, IF ANY.

10 (B) THE STATE BOARD SHALL CALCULATE A QUANTITY CHANGE FACTOR FOR EACH
11 SCHOOL DISTRICT FOR THE COMING SCHOOL YEAR BASED UPON THE PHYSICAL OR
12 QUANTITY CHANGE, AS DEFINED BY SECTION TWELVE HUNDRED TWENTY OF THIS
13 CHAPTER, REPORTED TO THE STATE BOARD BY THE ASSESSOR OR ASSESSORS PURSU-
14 ANT TO SECTION FIVE HUNDRED SEVENTY-FIVE OF THIS CHAPTER. THE QUANTITY
15 CHANGE FACTOR SHALL SHOW THE PERCENTAGE BY WHICH THE FULL VALUE OF THE
16 TAXABLE REAL PROPERTY IN THE SCHOOL DISTRICT HAS CHANGED DUE TO PHYSICAL
17 OR QUANTITY CHANGE BETWEEN THE SECOND FINAL ASSESSMENT ROLL OR ROLLS
18 PRECEDING THE FINAL ASSESSMENT ROLL OR ROLLS UPON WHICH TAXES ARE TO BE
19 LEVIED, AND THE FINAL ASSESSMENT ROLL OR ROLLS IMMEDIATELY PRECEDING THE
20 FINAL ASSESSMENT ROLL OR ROLLS UPON WHICH TAXES ARE TO BE LEVIED.

21 (C) AFTER DETERMINING THE QUANTITY CHANGE FACTOR FOR A SCHOOL
22 DISTRICT, THE STATE BOARD SHALL PROCEED AS FOLLOWS:

23 (I) IF THE QUANTITY CHANGE FACTOR IS NEGATIVE, THE STATE BOARD SHALL
24 NOT DETERMINE A TAX BASE GROWTH FACTOR FOR THE SCHOOL DISTRICT.

25 (II) IF THE QUANTITY CHANGE FACTOR IS POSITIVE, THE STATE BOARD SHALL
26 DETERMINE A TAX BASE GROWTH FACTOR FOR THE SCHOOL DISTRICT WHICH IS
27 EQUAL TO THE QUANTITY CHANGE FACTOR, PROVIDED THAT IN NO CASE SHALL A
28 TAX BASE GROWTH FACTOR BE IN EXCESS OF TEN PERCENT.

29 4. COMPUTATION OF TAX LEVY LIMITS. (A) THE TAX LEVY BASE FOR EACH
30 SCHOOL YEAR SHALL BE DETERMINED AS FOLLOWS:

31 (I) ASCERTAIN THE TOTAL AMOUNT OF TAXES LEVIED FOR THE PRIOR SCHOOL
32 YEAR.

33 (II) ADD ANY PAYMENTS IN LIEU OF TAXES THAT WERE RECEIVABLE IN THE
34 PRIOR SCHOOL YEAR.

35 (III) SUBTRACT THE CAPITAL TAX LEVY FOR THE PRIOR SCHOOL YEAR, IF ANY.

36 (IV) MULTIPLY THE RESULT BY THE LEVY GROWTH FACTOR.

37 (V) MULTIPLY THE RESULT BY THE TAX BASE GROWTH FACTOR, IF ANY.

38 (B) THE TAX LEVY BASE SHALL BE ADJUSTED BY ADDING THE AVAILABLE CARRY-
39 OVER, IF ANY, PROVIDED THAT IN NO EVENT SHALL THE AMOUNT OF ADDED CARRY-
40 OVER EXCEED ONE AND ONE-HALF PERCENT OF THE TAX LEVY FOR THE PRIOR
41 SCHOOL YEAR.

42 (C) THE TAX LEVY LIMIT FOR THE COMING SCHOOL YEAR SHALL BE THE
43 ADJUSTED TAX LEVY BASE, LESS ANY PAYMENTS IN LIEU OF TAXES RECEIVABLE IN
44 THE COMING SCHOOL YEAR. NO LATER THAN MARCH FIRST OF EACH YEAR, THE
45 COMMISSIONER OF EDUCATION SHALL CALCULATE THE TAX LEVY LIMIT FOR EACH
46 SCHOOL DISTRICT, AND SHALL NOTIFY EACH SCHOOL DISTRICT OF THE LEVY
47 GROWTH FACTOR, THE DISTRICT'S TAX BASE GROWTH FACTOR, IF ANY, THE
48 DISTRICT'S TAX LEVY BASE AND THE DISTRICT'S TAX LEVY LIMIT.

49 5. VOTER UNDERRIDES. THE QUALIFIED VOTERS OF A SCHOOL DISTRICT MAY
50 VOTE TO REDUCE (OR UNDERRIDE) THE LIMITATIONS IMPOSED BY THIS SECTION
51 FOR SUCH SCHOOL DISTRICT FOR THE COMING SCHOOL YEAR IN THE MANNER
52 PROVIDED BY SECTION TWO THOUSAND TWENTY-THREE-A OF THE EDUCATION LAW.

53 6. REORGANIZED SCHOOL DISTRICTS. WHEN TWO OR MORE SCHOOL DISTRICTS
54 REORGANIZE, THE COMMISSIONER OF EDUCATION SHALL DETERMINE THE TAX LEVY
55 LIMIT FOR THE REORGANIZED SCHOOL DISTRICT BASED ON THE RESPECTIVE TAX
56 LEVY LIMITS OF THE SCHOOL DISTRICTS THAT FORMED THE REORGANIZED DISTRICT

1 FROM THE LAST SCHOOL YEAR IN WHICH THEY WERE SEPARATE DISTRICTS,
2 PROVIDED THAT IN THE EVENT OF FORMATION OF A NEW CENTRAL HIGH SCHOOL
3 DISTRICT, THE TAX LEVY LIMITS FOR THE NEW CENTRAL HIGH SCHOOL DISTRICT
4 AND ITS COMPONENT SCHOOL DISTRICTS SHALL BE DETERMINED IN ACCORDANCE
5 WITH A METHODOLOGY PRESCRIBED BY THE COMMISSIONER OF EDUCATION.

6 7. ERRONEOUS LEVIES. IN THE EVENT A SCHOOL DISTRICT'S ACTUAL TAX LEVY
7 FOR A GIVEN SCHOOL YEAR EXCEEDS THE MAXIMUM ALLOWABLE LEVY AS ESTAB-
8 LISHED PURSUANT TO SECTION TWO THOUSAND TWENTY-THREE-A OF THE EDUCATION
9 LAW DUE TO CLERICAL OR TECHNICAL ERRORS, THE SCHOOL DISTRICT SHALL PLACE
10 THE EXCESS AMOUNT OF THE LEVY IN RESERVE IN ACCORDANCE WITH SUCH
11 REQUIREMENTS AS THE STATE COMPTROLLER MAY PRESCRIBE, AND SHALL USE SUCH
12 FUNDS AND ANY INTEREST EARNED THEREON TO OFFSET THE TAX LEVY FOR THE
13 ENSUING SCHOOL YEAR.

14 S 3. The tax law is amended by adding a new section 178 to read as
15 follows:

16 S 178. "MIDDLE CLASS STAR" REBATE PROGRAM. 1. THE COMMISSIONER SHALL
17 ISSUE THE LOCAL PROPERTY TAX REBATES AUTHORIZED BY SECTION THIRTEEN
18 HUNDRED SIX-B OF THE REAL PROPERTY TAX LAW EXCEPT AS PROVIDED IN PARA-
19 GRAPH (G) OF SUBDIVISION THREE OF SUCH SECTION. FOR PURPOSES OF THIS
20 SECTION THE REBATE SHALL BE CALCULATED USING THE COMPUTATION FORMULA SET
21 FORTH IN SUBDIVISION THREE OF SECTION THIRTEEN HUNDRED SIX-B OF THE REAL
22 PROPERTY TAX LAW.

23 2. ON OR BEFORE AUGUST FIFTEENTH EACH YEAR, THE EXECUTIVE DIRECTOR OF
24 THE OFFICE OF REAL PROPERTY SERVICES, OR HIS OR HER DESIGNEE, OR ON OR
25 BEFORE JULY FIRST EACH YEAR IN THE CASE OF A CITY WITH A POPULATION OF
26 ONE MILLION OR MORE, THE COMMISSIONER OF FINANCE, SHALL PROVIDE TO THE
27 COMMISSIONER A REPORT IN A MUTUALLY AGREEABLE FORMAT CONCERNING THOSE
28 PARCELS WHICH SATISFY THE CRITERIA SET FORTH IN SECTION THIRTEEN HUNDRED
29 SIX-B OF THE REAL PROPERTY TAX LAW.

30 3. THE COMMISSIONER IN CONSULTATION WITH THE OFFICE OF REAL PROPERTY
31 SERVICES AND IN THE CASE OF A CITY WITH A POPULATION OF ONE MILLION OR
32 MORE, THE COMMISSIONER OF FINANCE, IS AUTHORIZED TO DEVELOP PROCEDURES
33 NECESSARY TO PROVIDE FOR THE ISSUANCE OF LOCAL PROPERTY TAX REBATES TO
34 QUALIFYING PROPERTY OWNERS, AND THOSE QUALIFYING PROPERTY OWNERS THAT
35 DID NOT RECEIVE THEM INITIALLY. IF THE COMMISSIONER IS NOT SATISFIED
36 THAT THE PROPERTY OWNER IS QUALIFIED FOR THE LOCAL PROPERTY TAX REBATE,
37 THE COMMISSIONER SHALL NOT ISSUE SUCH REBATE.

38 4. WHEN THE PROPER PAYMENT OF A TAX REBATE UNDER THIS SECTION DEPENDS
39 UPON CONSTRUCTION OF THE MEANING OF THE PROVISIONS OF SECTION THIRTEEN
40 HUNDRED SIX-B OF THE REAL PROPERTY TAX LAW (AND ANY RELATED PROVISIONS
41 OF SUCH LAW) OR INTERPRETATION OF THE TERMS CONTAINED THEREIN, IT SHALL
42 BE THE RESPONSIBILITY OF THE STATE BOARD OF REAL PROPERTY SERVICES TO
43 PROVIDE TO THE DEPARTMENT THE CONSTRUCTION OR INTERPRETATION OF ANY SUCH
44 PROVISIONS OR TERMS.

45 5. BY DEPOSITING A REBATE ISSUED PURSUANT TO THIS SECTION AND AUTHOR-
46 IZED BY SECTION THIRTEEN HUNDRED SIX-B OF THE REAL PROPERTY TAX LAW, THE
47 PAYEE IS CERTIFYING THAT HE OR SHE IS THE PROPERTY OWNER, AND THAT THE
48 PRIMARY RESIDENCE OF SUCH PROPERTY OWNER IS NOT SUBJECT TO ANY DELIN-
49 QUENT SCHOOL TAXES.

50 6. VERIFICATION OF "AFFILIATED INCOME" FOR "MIDDLE CLASS STAR" REBATE
51 PROGRAM. (A) GENERALLY. THE DETERMINATION OF THE "AFFILIATED INCOME" OF
52 PARCELS FOR PURPOSES OF THE "MIDDLE CLASS STAR" REBATE PROGRAM AS
53 AUTHORIZED BY SUBDIVISION THREE OF SECTION THIRTEEN HUNDRED SIX-B OF THE
54 REAL PROPERTY TAX LAW SHALL BE MADE AS PROVIDED BY THIS SECTION.

55 (B) FOR PURPOSES OF THIS SUBDIVISION, THE TERM "INCOME" SHALL HAVE THE
56 SAME MEANING AS SET FORTH IN SUBPARAGRAPH (II) OF PARAGRAPH (B) OF

SUBDIVISION FOUR OF SECTION FOUR HUNDRED TWENTY-FIVE OF THE REAL PROPERTY TAX LAW. THE TERM "AFFILIATED INCOME" SHALL MEAN THE COMBINED INCOME OF ALL OF THE OWNERS OF THE PARCEL WHO RESIDED PRIMARILY THEREON ON THE TAXABLE STATUS DATE FOR THE ASSESSMENT ROLL USED TO GENERATE THE APPLICABLE SCHOOL TAX BILLS, AND OF ANY OWNERS' SPOUSES FILING JOINTLY OR SPOUSES' RESIDING PRIMARILY THEREON IN THE CASES OF SPOUSES' FILING SEPARATE RETURNS ON SUCH TAXABLE STATUS DATE AND SHALL BE DETERMINED AS FOLLOWS:

(I) FOR THE TWO THOUSAND TEN--TWO THOUSAND ELEVEN SCHOOL YEAR, AFFILIATED INCOME SHALL BE DETERMINED BASED UPON THE PARTIES' INCOMES FOR THE INCOME TAX YEAR ENDING IN TWO THOUSAND NINE. IN EACH SUBSEQUENT YEAR, THE APPLICABLE INCOME TAX YEAR SHALL BE ADVANCED BY ONE YEAR.

(II) THE DEPARTMENT SHALL DETERMINE THE AFFILIATED INCOME FOR EACH PARCEL AND SHALL ASSIGN A REBATE AMOUNT FOR EACH PARCEL BASED UPON SUCH DETERMINATION. IN ANY CASE WHERE AFFILIATED INCOME CANNOT BE DETERMINED, A REBATE SHALL NOT BE ISSUED.

7. NOTIFICATION REQUIREMENT. THE DEPARTMENT SHALL MAIL INFORMATION CONCERNING THE "MIDDLE CLASS STAR" REBATE PROGRAM TO OWNERS OF PARCELS RECEIVING A BASIC STAR EXEMPTION ON THE ASSESSMENT ROLL USED TO GENERATE THE TWO THOUSAND TEN--TWO THOUSAND ELEVEN SCHOOL TAX BILL. SUCH NOTIFICATION SHALL EXPLAIN THAT PROPERTY OWNERS MUST FILE APPLICATIONS WITH THE DEPARTMENT IN ORDER TO OBTAIN THE REBATE AVAILABLE UNDER THE "MIDDLE CLASS STAR" REBATE PROGRAM. SUCH NOTICE SHALL FURTHER EXPLAIN HOW TO OBTAIN THE APPLICATION.

8. APPLICATIONS. (A) IN ORDER TO OBTAIN THE BENEFITS OF THE "MIDDLE CLASS STAR" REBATE PROGRAM, THE PROPERTY OWNER MUST SUBMIT AN APPLICATION TO THE DEPARTMENT NO LATER THAN DECEMBER THIRTY-FIRST, TWO THOUSAND TEN. THE APPLICANT SHALL PROVIDE THE DEPARTMENT WITH SUCH INFORMATION AS MAY BE NECESSARY TO DETERMINE THE PARCEL'S AFFILIATED INCOME. THE PERSONS OTHER THAN THE APPLICANT WHOSE INCOMES ARE NECESSARY TO THE DETERMINATION OF THE PARCEL'S AFFILIATED INCOME SHALL BE REFERRED TO IN THIS SECTION AS "AFFILIATED PERSONS." RECIPIENTS OF THE ENHANCED STAR EXEMPTION SHALL NOT FILE AN APPLICATION TO RECEIVE A REBATE. THE DEPARTMENT SHALL MAIL ENHANCED STAR REBATE RECIPIENTS THEIR REBATES IN A TIMELY MANNER.

(B) IF THE APPLICANT OR ANY AFFILIATED PERSONS WERE NOT REQUIRED TO FILE NEW YORK STATE INCOME TAX RETURNS FOR THE TWO THOUSAND NINE INCOME TAX YEAR BECAUSE THEIR INCOMES WERE BELOW THE THRESHOLD THAT NECESSITATED SUCH FILING, THE APPLICATION SHALL SO INDICATE.

(C) IF THE APPLICANT OR ANY AFFILIATED PERSONS WERE NOT REQUIRED TO FILE NEW YORK STATE INCOME TAX RETURNS FOR THE TWO THOUSAND NINE INCOME TAX YEAR BECAUSE THEY DID NOT RESIDE IN NEW YORK STATE IN SUCH TAXABLE YEAR, THE APPLICATION SHALL SO INDICATE. SUCH PERSONS SHALL PROVIDE WITH THE APPLICATION ANY INFORMATION THAT THE DEPARTMENT DETERMINES IS NECESSARY TO CALCULATE THE PARCEL'S AFFILIATED INCOME UNDER THE "MIDDLE CLASS STAR" REBATE PROGRAM.

(D) AFTER TWO THOUSAND TEN, APPLICATIONS SHALL BE REQUIRED ONLY WHEN A NEW APPLICATION FOR A BASIC STAR EXEMPTION FOR REAL PROPERTY TAXATION IS FILED PURSUANT TO SECTION FOUR HUNDRED TWENTY-FIVE OF THE REAL PROPERTY TAX LAW, OR WHEN THERE IS A CHANGE OF OWNERSHIP WHICH DOES NOT NECESSITATE THE FILING OF A NEW APPLICATION FOR A BASIC STAR EXEMPTION. IN EITHER INSTANCE, AN APPLICATION SHALL BE SUBMITTED TO THE DEPARTMENT ON A TIMELY BASIS.

(E) IF AN APPLICATION FOR A "MIDDLE CLASS STAR" REBATE IS RECEIVED AFTER DECEMBER THIRTY-FIRST, TWO THOUSAND TEN, AN OTHERWISE ELIGIBLE PROPERTY OWNER SHALL NOT RECEIVE A REBATE FOR SUCH YEAR. HOWEVER, SUCH

APPLICATION SHALL BE CONSIDERED TIMELY FILED FOR A REBATE IN SUBSEQUENT YEARS PROVIDED THE OWNERSHIP OF THE PARCEL REMAINS UNCHANGED.

9. PROCESSING OF APPLICATIONS. (A) AFTER RECEIVING A TIMELY APPLICATION, THE DEPARTMENT SHALL ATTEMPT TO DETERMINE THE AFFILIATED INCOME OF THE PARCEL AND THE REBATE AMOUNT TO WHICH THE PARCEL IS ENTITLED, IF ANY.

(B) IN THE CASE OF AN APPLICATION WHICH INDICATES THAT THE APPLICANT AND ANY AFFILIATED PERSONS WERE NOT REQUIRED TO FILE NEW YORK STATE INCOME TAX RETURNS FOR THE TWO THOUSAND NINE INCOME TAX YEAR BECAUSE THEIR INCOMES WERE BELOW THE THRESHOLD WHICH NECESSITATED THE FILING OF A STATE INCOME TAX RETURN, THE DEPARTMENT MAY, SUBJECT TO AUDIT, ISSUE A REBATE EQUAL TO THE HIGHEST AMOUNT AVAILABLE FOR THAT SCHOOL DISTRICT SEGMENT.

(C) IN THE CASE OF AN APPLICATION WHICH INDICATES THAT THE APPLICANT AND ANY AFFILIATED PERSONS WERE NOT REQUIRED TO FILE NEW YORK STATE INCOME TAX RETURNS FOR THE TWO THOUSAND NINE INCOME TAX YEAR BECAUSE THEY DID NOT RESIDE IN NEW YORK STATE IN SUCH TAXABLE YEAR, THE APPLICANT SHALL PROVIDE SUCH INFORMATION REGARDING INCOME AS IS REQUESTED BY THE DEPARTMENT. THE DEPARTMENT SHALL ISSUE A REBATE BASED UPON THE INFORMATION PROVIDED BY THE APPLICANT AND ANY OTHER INFORMATION TO WHICH THE DEPARTMENT MAY HAVE ACCESS CONCERNING THE INCOME OF SUCH PERSON OR PERSONS.

10. RECONSIDERATION OF REBATE AMOUNT. IN THE EVENT THE DEPARTMENT IS UNABLE TO DETERMINE THE AFFILIATED INCOME FOR A PARCEL OR THE DEPARTMENT DETERMINES THAT A REBATE SHALL NOT BE ISSUED FOR A PARCEL, THE DEPARTMENT SHALL NOTIFY THE APPLICANT OF THAT FACT. A PROPERTY OWNER MAY SEEK RECONSIDERATION OF THE REBATE AMOUNT DETERMINATION FOR HIS OR HER PARCEL ON THE GROUNDS THAT THE PARCEL'S AFFILIATED INCOME WAS DETERMINED ERRORNEOUSLY. A PROPERTY OWNER MAY ALSO SEEK RECONSIDERATION IF NO REBATE WAS ISSUED BECAUSE THE PARCEL'S AFFILIATED INCOME WAS UNDETERMINED. AN APPLICATION FOR RECONSIDERATION OF REBATE AMOUNT SHALL BE MADE IN A MANNER PRESCRIBED BY THE DEPARTMENT, AND SHALL BE ACCOMPANIED BY SUCH DOCUMENTATION AS THE DEPARTMENT MAY REQUIRE. SUCH APPLICATION SHALL BE FILED NO LATER THAN MARCH THIRTY-FIRST, TWO THOUSAND ELEVEN. IF THE DEPARTMENT FINDS AFTER REVIEWING SUCH AN APPLICATION THAT THE REBATE AMOUNT DETERMINATION FOR A PARCEL SHOULD BE CORRECTED, IT SHALL ISSUE AN AMENDED OR INITIAL REBATE CHECK. IF THE DEPARTMENT FINDS AFTER REVIEWING SUCH AN APPLICATION THAT THE REBATE AMOUNT DETERMINATION FOR THE PARCEL WAS CORRECTLY DETERMINED, IT SHALL SO NOTIFY THE APPLICANT. SUCH NOTIFICATION SHALL INCLUDE AN EXPLANATION OF THE DEPARTMENT'S FINDINGS, INDICATE THAT THE APPLICANT HAS THE RIGHT TO A PROCEEDING UNDER ARTICLE SEVENTY-EIGHT OF THE CIVIL PRACTICE LAW AND RULES, AND INDICATE THE STATUTE OF LIMITATIONS ASSOCIATED WITH SUCH PROCEEDINGS. SUCH FINDING SHALL BE SUBJECT TO REVIEW PURSUANT ONLY TO A PROCEEDING UNDER ARTICLE SEVENTY-EIGHT OF THE CIVIL PRACTICE LAW AND RULES.

11. SPECIAL PROVISIONS RELATING TO CO-OPERATIVE APARTMENT UNITS AND MOBILE HOMES. THE DEPARTMENT'S DETERMINATION OF AFFILIATED INCOME SHALL BE MADE WITH RESPECT TO THE TENANT-SHAREHOLDERS OR OWNERS OF THE UNIT IN QUESTION RATHER THAN OF THE PARCEL.

12. SUBSEQUENT YEARS. IN EACH YEAR SUBSEQUENT TO TWO THOUSAND TEN, AFFILIATED INCOMES SHALL CONTINUE TO BE DETERMINED AS PROVIDED BY THIS SECTION FOR PURPOSES OF THE "MIDDLE CLASS STAR" REBATE PROGRAM, EXCEPT THAT:

(A) THE NOTIFICATION REQUIREMENT OF SUBDIVISION SEVEN OF THIS SECTION SHALL NOT BE APPLICABLE;

(B) APPLICATIONS SHALL BE REQUIRED ONLY AS PROVIDED IN SUBDIVISION EIGHT OF THIS SECTION; AND

(C) IN EACH SUBSEQUENT YEAR, THE APPLICABLE INCOME TAX YEAR FOR DETERMINATIONS UNDER THIS SECTION SHALL BE ADVANCED ONE YEAR. ALL OTHER APPLICABLE DATES AND DEADLINES WHICH REFERENCE A DATE IN TWO THOUSAND TEN SHALL BE ADVANCED AND SHALL BE DEEMED TO REFERENCE DATES IN THAT SUBSEQUENT YEAR, EXCEPT THAT APPLICATIONS FOR RECONSIDERATION OF REBATE AMOUNT DETERMINATIONS SHALL BE SUBMITTED NO LATER THAN MARCH THIRTY-FIRST OF THE ENSUING YEAR.

13. CONFIDENTIAL INFORMATION; DISCLOSURE PROHIBITION. INFORMATION REGARDING REBATES ISSUED TO INDIVIDUALS SHALL NOT BE SUBJECT TO DISCLOSURE; INCLUDING NAMES, ADDRESSES, AND DOLLAR AMOUNTS OF REBATES. IN ADDITION, ALL APPLICATIONS SUBMITTED FOR REBATES SHALL NOT BE SUBJECT TO DISCLOSURE.

14. DEADLINE. IF ANY APPLICABLE DEADLINE SHALL FALL ON A SATURDAY, SUNDAY OR LEGAL HOLIDAY, SUCH DEADLINE SHALL BE ADVANCED TO THE NEXT BUSINESS DAY.

15. AFFILIATED INCOME BRACKETS; INDEXING. THE DEPARTMENT SHALL ESTABLISH THE AFFILIATED INCOME BRACKETS TO BE ASSOCIATED WITH THE REBATE AMOUNTS FOR THE TWO THOUSAND FIFTEEN--TWO THOUSAND SIXTEEN SCHOOL YEAR AND EACH SCHOOL YEAR THEREAFTER BY APPLYING THE INFLATION FACTOR SET FORTH IN THIS SUBDIVISION TO THE FIGURES THAT DEFINED THE INCOME BRACKETS THAT WERE APPLICABLE TO THE TWO THOUSAND FOURTEEN--TWO THOUSAND FIFTEEN SCHOOL YEAR, AND ROUNDING EACH RESULT TO THE NEAREST MULTIPLE OF ONE HUNDRED DOLLARS. FOR PURPOSES OF THIS SUBDIVISION, THE "INFLATION FACTOR" FOR EACH INCOME BRACKET SHALL BE DETERMINED BY THE PERCENTAGE INCREASE IN THE CONSUMER PRICE INDEX FOR URBAN WAGE EARNERS AND CLERICAL WORKERS (CPI-W) PUBLISHED BY THE UNITED STATES DEPARTMENT OF LABOR, BUREAU OF LABOR STATISTICS, FOR THE THIRD QUARTER OF THE CALENDAR YEAR PRECEDING THE APPLICABLE SCHOOL YEAR, AS COMPARED TO THE THIRD QUARTER OF THE PRIOR CALENDAR YEAR. IF A BASE FIGURE AS SO DETERMINED IS NOT EXACTLY EQUAL TO A MULTIPLE OF ONE HUNDRED DOLLARS, IT SHALL BE ROUNDED TO THE NEAREST MULTIPLE OF ONE HUNDRED DOLLARS. IN EACH SUBSEQUENT SCHOOL YEAR, THE PRIOR YEAR'S INCOME BRACKETS SHALL BE INDEXED USING THE ABOVE FORMULA WITH EACH YEAR ADVANCED BY ONE YEAR.

S 4. Section 606 of the tax law is amended by adding a new subsection (qq) to read as follows:

(QQ) MIDDLE CLASS CIRCUIT BREAKER CREDIT. (1) DEFINITIONS. FOR THE PURPOSES OF THIS SUBSECTION:

(C) "HOUSEHOLD GROSS INCOME" MEANS THE AGGREGATE ADJUSTED GROSS INCOME OF ALL MEMBERS OF THE HOUSEHOLD FOR THE TAXABLE YEAR AS REPORTED FOR FEDERAL INCOME TAX PURPOSES, OR WHICH WOULD BE REPORTED AS ADJUSTED GROSS INCOME IF A FEDERAL INCOME TAX RETURN WERE REQUIRED TO BE FILED, WITH THE MODIFICATIONS IN SUBSECTION (B) OF SECTION SIX HUNDRED TWELVE OF THIS ARTICLE BUT WITHOUT THE MODIFICATIONS IN SUBSECTION (C) OF SUCH SECTION, PLUS ANY PORTION OF THE GAIN FROM THE SALE OR EXCHANGE OF PROP-

1 ERTY OTHERWISE EXCLUDED FROM SUCH AMOUNT; EARNED INCOME FROM SOURCES
2 WITHOUT THE UNITED STATES EXCLUDABLE FROM FEDERAL GROSS INCOME BY
3 SECTION NINE HUNDRED ELEVEN OF THE INTERNAL REVENUE CODE; SUPPORT MONEY
4 NOT INCLUDED IN ADJUSTED GROSS INCOME; NONTAXABLE STRIKE BENEFITS;
5 SUPPLEMENTAL SECURITY INCOME PAYMENTS; THE GROSS AMOUNT OF ANY PENSION
6 OR ANNUITY BENEFITS TO THE EXTENT NOT INCLUDED IN SUCH ADJUSTED GROSS
7 INCOME (INCLUDING, BUT NOT LIMITED TO, RAILROAD RETIREMENT BENEFITS AND

13 SATION; THE GROSS AMOUNT OF "LOSS-OF-TIME" INSURANCE; AND THE AMOUNT OF

22 TWO THOUSAND ONE. PROVIDED, FURTHER, HOUSEHOLD GROSS INCOME SHALL ONLY
23 INCLUDE ALL SUCH INCOME RECEIVED BY ALL MEMBERS OF THE HOUSEHOLD WHILE
24 MEMBERS OF SUCH HOUSEHOLD. FOR FARM FAMILIES EARNING AT LEAST FIFTY
25 PERCENT OF THEIR INCOME FROM FARMING, "ADJUSTED GROSS INCOME" SHALL BE
26 REPLACED WITH "MODIFIED ADJUSTED GROSS INCOME" FOR FEDERAL TAX PURPOSES
27 AS REPORTED ON THE APPLICANT'S FEDERAL AND STATE INCOME TAX RETURNS FOR

29 (D) "ADJUSTED RENT" MEANS RENT PAID FOR THE RIGHT OF OCCUPANCY OF A

31 (E) "REAL PROPERTY TAX EQUIVALENT" MEANS FOR TAXABLE YEARS BEGINNING
32 IN TWO THOUSAND TEN, FIFTEEN PERCENT OF THE ADJUSTED RENT ACTUALLY PAID
33 IN THE TAXABLE YEAR BY A HOUSEHOLD SOLELY FOR THE RIGHT OF OCCUPANCY OF
34 ITS NEW YORK RESIDENCE FOR THE TAXABLE YEAR. IF (I) A RESIDENCE IS RENT-

S 1608. Estimated expenses for ensuing year. 1. It shall be the duty of the trustees of each common school district to present at the annual budget hearing a detailed statement in writing of the amount of money which will be required for the ensuing year for school purposes, specifying the several purposes and the amount for each. WHERE A PROPOSITION TO UNDERRIDE A TAX LEVY LIMITATION HAS BEEN APPROVED PURSUANT TO SECTION TWO THOUSAND TWENTY-THREE-A OF THIS TITLE, THE TRUSTEES SHALL PRESENT AT THE ANNUAL BUDGET HEARING A BUDGET THAT COMPLIES WITH THE APPROVED UNDERRIDE PROPOSITION. The amount for each purpose estimated necessary for payments to boards of cooperative educational services shall be shown in full, with no deduction of estimated state aid. The amount of state aid provided and its percentage relationship to the total expenditures shall also be shown. This section shall not be construed to prevent the trustees from presenting such statement at a budget hearing held not less than seven nor more than fourteen days prior to a special meeting called for the purpose, nor from presenting a supplementary and amended statement or estimate at any time.

2. Such statement shall be completed at least seven days before the budget hearing at which it is to be presented and copies thereof shall be prepared and made available, upon request and at the school district offices, at any public library or free association library within the district and on the school district's internet website, if one exists, to residents within the district during the period of fourteen days immediately preceding the annual meeting [and election or special district meeting at which the budget vote will occur] and at such meeting or hearing. The board shall also as a part of the notice required by section two thousand three of this [chapter] TITLE give notice of the date, time and place of the budget hearing and that a copy of such statement may be obtained by any resident in the district at each schoolhouse in the district in which school is maintained during certain designated hours on each day other than a Saturday, Sunday or holiday during the fourteen days immediately preceding such meeting. The board shall include notice of the availability of such statement at least once during the school year in any district-wide mailing distributed.

3. Commencing with the proposed budget for the nineteen hundred ninety-seven--ninety-eight school year, such proposed budget shall be in plain language and shall be consistent with regulations promulgated by the commissioner pursuant to subdivision twenty-six of section three hundred five of this chapter. Categorization of and format for revenue, including payments in lieu of taxes, property tax refunds from certiorari proceedings, expenditure, transfer, and fund balance information and changes in such data from the prior year and, in the case of [a resub-

mitted or] AN amended budget, changes in such information from the prior year's submitted budget, shall be complete and accurate and set forth in such a manner as to best promote public comprehension and readability.

4. Commencing with the proposed budget for the nineteen hundred ninety-eight--ninety-nine school year, such proposed budget shall be presented in three components: a program component, a capital component and an administrative component which shall be separately delineated in accordance with regulations of the commissioner after consultation with local school district officials. The administrative component shall include, but need not be limited to, office and central administrative expenses, traveling expenses and all compensation, salaries and benefits of all school administrators and supervisors, including business administrators, superintendents of schools and deputy, assistant, associate or other superintendents under all existing employment contracts or collective bargaining agreements, any and all expenditures associated with the operation of the office of trustee or board of trustees, the office of the superintendent of schools, general administration, the school business office, consulting costs not directly related to direct student services and programs, planning and all other administrative activities. The program component shall include, but need not be limited to, all program expenditures of the school district, including the salaries and benefits of teachers and any school administrators or supervisors who spend a majority of their time performing teaching duties, and all transportation operating expenses. The capital component shall include, but need not be limited to, all transportation capital, debt service, and lease expenditures; costs resulting from judgments in tax certiorari proceedings or the payment of awards from court judgments, administrative orders or settled or compromised claims; and all facilities costs of the school district, including facilities lease expenditures, the annual debt service and total debt for all facilities financed by bonds and notes of the school district, and the costs of construction, acquisition, reconstruction, rehabilitation or improvement of school buildings, provided that such budget shall include a rental, operations and maintenance section that includes base rent costs, total rent costs, operation and maintenance charges, cost per square foot for each facility leased by the school district, and any and all expenditures associated with custodial salaries and benefits, service contracts, supplies, utilities, and maintenance and repairs of school facilities. [For the purposes of the development of a budget for the nineteen hundred ninety-eight--ninety-nine school year, the trustee or board of trustees shall separate the district's program, capital and administrative costs for the nineteen hundred ninety-seven--ninety-eight school year in the manner as if the budget for such year had been presented in three components.]

5. The trustee or board of trustees shall append to the statement of estimated expenditures a detailed statement of the total compensation to be paid to the superintendent of schools, and any assistant or associate superintendents of schools in the ensuing school year, including a delineation of the salary, annualized cost of benefits and any in-kind or other form of remuneration. The trustees shall also append a list of all other school administrators and supervisors, if any, whose annual salary will be eighty-five thousand dollars or more in the ensuing school year, with the title of their positions and annual salary identified; provided however, that the commissioner may adjust such salary level to reflect increases in administrative salaries after June thirtieth, nineteen hundred ninety-eight. The trustees shall submit a copy of

1 such list and statement, in a form prescribed by the commissioner, of
2 compensation to the commissioner within five days after their prepara-
3 tion. The commissioner shall compile such data, together with the data

37 S. 1716. Estimated expenses for ensuing year. 1. It shall be the duty
38 of the board of education of each district to present at the annual
39 budget hearing a detailed statement in writing of the amount of money
40 which will be required for the ensuing year for school purposes, speci-
41 fying the several purposes and the amount for each. WHERE A PROPOSITION
42 TO UNDERRIDE A TAX LEVY LIMITATION HAS BEEN APPROVED PURSUANT TO SECTION
43 TWO THOUSAND TWENTY-THREE-A OF THIS TITLE, THE BOARD OF EDUCATION SHALL
44 PRESENT AT THE ANNUAL BUDGET HEARING A BUDGET THAT COMPLIES WITH THE
45 APPROVED UNDERRIDE PROPOSITION. The amount for each purpose estimated
46 necessary for payments to boards of cooperative educational services
47 shall be shown in full, with no deduction of estimated state aid. The
48 amount of state aid provided and its percentage relationship to the
49 total expenditures shall also be shown. This section shall not be
50 construed to prevent the board from presenting such statement at a budg-
51 et hearing held not less than seven nor more than fourteen days prior to
52 a special meeting called for the purpose, nor from presenting a supple-
53 mentary and amended statement or estimate at any time.

54 2. Such statement shall be completed at least seven days before the
55 budget hearing at which it is to be presented and copies thereof shall
56 be prepared and made available, upon request and at the school district

1 offices, at any public library or free association library within the
2 district and on the school district's internet website, if one exists,
3 to residents within the district during the period of fourteen days
4 immediately preceding the annual meeting [and election or special
5 district meeting at which the budget vote will occur] and at such meet-
6 ing or hearing. The board shall also as a part of the notice required by
7 section two thousand four of this [chapter] TITLE give notice of the
8 date, time and place of the budget hearing and that a copy of such
9 statement may be obtained by any resident in the district at each
10 schoolhouse in the district in which school is maintained during certain
11 designated hours on each day other than a Saturday, Sunday or holiday
12 during the fourteen days immediately preceding such meeting. The board
13 shall include notice of the availability of such statement at least once
14 during the school year in any district-wide mailing distributed.

15 3. Commencing with the proposed budget for the nineteen hundred nine-
16 ty-seven--ninety-eight school year, such proposed budget shall be in
17 plain language and shall be consistent with regulations promulgated by
18 the commissioner pursuant to subdivision twenty-six of section three
19 hundred five of this chapter. Categorization of and format for revenue,
20 including payments in lieu of taxes, property tax refunds from certior-
21 ari proceedings, expenditure, transfer, and fund balance information and
22 changes in such data from the prior year and, in the case of [a resub-
23 mitted or] AN amended budget, changes in such information from the prior
24 year submitted budget, shall be complete and accurate and set forth in
25 such a manner as to best promote public comprehension and readability.

26 4. Commencing with the proposed budget for the nineteen hundred nine-
27 ty-eight--ninety-nine school year, such proposed budget shall be
28 presented in three components: a program component, a capital component
29 and an administrative component which shall be separately delineated in
30 accordance with regulations of the commissioner after consultation with
31 local school district officials. The administrative component shall
32 include, but need not be limited to, office and central administrative
33 expenses, traveling expenses and all compensation, salaries and benefits
34 of all school administrators and supervisors, including business admin-
35 istrators, superintendents of schools and deputy, assistant, associate
36 or other superintendents under all existing employment contracts or
37 collective bargaining agreements, any and all expenditures associated
38 with the operation of the board of education, the office of the super-
39 intendent of schools, general administration, the school business
40 office, consulting costs not directly related to direct student services
41 and programs, planning and all other administrative activities. The
42 program component shall include, but need not be limited to, all program
43 expenditures of the school district, including the salaries and benefits
44 of teachers and any school administrators or supervisors who spend a
45 majority of their time performing teaching duties, and all transporta-
46 tion operating expenses. The capital component shall include, but need
47 not be limited to, all transportation capital, debt service, and lease
48 expenditures; costs resulting from judgments in tax certiorari
49 proceedings or the payment of awards from court judgments, administra-
50 tive orders or settled or compromised claims; and all facilities costs
51 of the school district, including facilities lease expenditures, the
52 annual debt service and total debt for all facilities financed by bonds
53 and notes of the school district, and the costs of construction, acqui-
54 sition, reconstruction, rehabilitation or improvement of school build-
55 ings, provided that such budget shall include a rental, operations and
56 maintenance section that includes base rent costs, total rent costs,

1 operation and maintenance charges, cost per square foot for each facili-
2 ty leased by the school district, and any and all expenditures associ-
3 ated with custodial salaries and benefits, service contracts, supplies,
4 utilities, and maintenance and repairs of school facilities. [For the
5 purposes of the development of a budget for the nineteen hundred nine-
6 ty-eight--ninety-nine school year, the board of education shall separate
7 the district's program, capital and administrative costs for the nine-
8 teen hundred ninety-seven--ninety-eight school year in the manner as if
9 the budget for such year had been presented in three components.]

10 5. The board of education shall append to the statement of estimated
11 expenditures a detailed statement of the total compensation to be paid
12 to the superintendent of schools, and any assistant or associate super-
13 intendents of schools in the ensuing school year, including a deline-
14 ation of the salary, annualized cost of benefits and any in-kind or
15 other form of remuneration. The board shall also append a list of all
16 other school administrators and supervisors, if any, whose annual salary
17 will be eighty-five thousand dollars or more in the ensuing school year,
18 with the title of their positions and annual salary identified; provided
19 however, that the commissioner may adjust such salary level to reflect
20 increases in administrative salaries after June thirtieth, nineteen
21 hundred ninety-eight. The board of education shall submit a copy of such
22 list and statement, in a form prescribed by the commissioner, of compen-
23 sation to the commissioner within five days after their preparation. The
24 commissioner shall compile such data, together with the data submitted
25 pursuant to subdivision four of section sixteen hundred eight of this
26 [chapter] TITLE, into a single statewide compilation, which shall be
27 made available to the governor, the legislature, and other interested
28 parties upon request.

29 6. Each year, the board of education shall prepare a school district
30 report card, pursuant to regulations of the commissioner, and shall make
31 it publicly available by transmitting it to local newspapers of general
32 circulation, appending it to copies of the proposed budget made publicly
33 available as required by law, making it available for distribution at
34 the annual meeting, and otherwise disseminating it as required by the
35 commissioner. Such report card shall include measures of the academic
36 performance of the school district, on a school by school basis, and
37 measures of the fiscal performance of the district, as prescribed by the
38 commissioner. Pursuant to regulations of the commissioner, the report
39 card shall also compare these measures to statewide averages for all
40 public schools, and statewide averages for public schools of comparable
41 wealth and need, developed by the commissioner. Such report card shall
42 include, at a minimum, any information of the school district regarding
43 pupil performance and expenditure per pupil required to be included in
44 the annual report by the regents to the governor and the legislature
45 pursuant to section two hundred fifteen-a of this chapter; and any other
46 information required by the commissioner. School districts (i) identi-
47 fied as having fifteen percent or more of their students in special
48 education, or (ii) which have fifty percent or more of their students
49 with disabilities in special education programs or services sixty
50 percent or more of the school day in a general education building, or
51 (iii) which have eight percent or more of their students with disabili-
52 ties in special education programs in public or private separate educa-
53 tional settings shall indicate on their school district report card
54 their respective percentages as defined in this paragraph and paragraphs
55 (i) and (ii) of this subdivision as compared to the statewide average.

1 7. a. Each year, commencing with the proposed budget for the two thou-
2 sand--two thousand one school year, the board of education shall prepare
3 a property tax report card, pursuant to regulations of the commissioner,
4 and shall make it publicly available by transmitting it to local newspa-
5 pers of general circulation, appending it to copies of the proposed
6 budget made publicly available as required by law, making it available
7 for distribution at the annual [meeting] BUDGET HEARING, and otherwise
8 disseminating it as required by the commissioner. Such report card shall
9 include: (i) the amount of total spending and total estimated school tax
10 levy that would result from adoption of the proposed budget and the
11 percentage increase or decrease in total spending and total school tax
12 levy from the school district budget for the preceding school year; and
13 (ii) THE DISTRICT'S TAX LEVY LIMIT AND TAX LEVY BASE DETERMINED PURSUANT
14 TO SECTION THIRTEEN HUNDRED SEVEN OF THE REAL PROPERTY TAX LAW, AND THE
15 TAX LEVY PROPOSED BY THE DISTRICT, AND THE PROPOSED CAPITAL TAX LEVY, IF
16 ANY; AND (III) the projected enrollment growth for the school year for
17 which the budget is prepared, and the percentage change in enrollment
18 from the previous year; and [(iii)] (IV) the percentage increase in the
19 consumer price index, as defined in paragraph c of this subdivision; and
20 [(iv)] (V) the projected amount of the unappropriated unreserved fund
21 balance that will be retained if the proposed budget is adopted, the
22 projected amount of the reserved fund balance, the projected amount of
23 the appropriated fund balance, the percentage of the proposed budget
24 that the unappropriated unreserved fund balance represents, the actual
25 unappropriated unreserved fund balance retained in the school district
26 budget for the preceding school year, and the percentage of the school
27 district budget for the preceding school year that the actual unappro-
28 priated unreserved fund balance represents.

29 b. A copy of the property tax report card prepared for the annual
30 [district meeting] BUDGET HEARING shall be submitted to the department
31 in the manner prescribed by the department by the end of the business
32 day next following approval of the report card by the board of educa-
33 tion, but no later than twenty-four days prior to the statewide uniform
34 voting day. The department shall compile such data for all school
35 districts [whose budgets are subject to a vote of the qualified voters]
36 SUBJECT TO A TAX LEVY LIMITATION PURSUANT TO SECTION THIRTEEN HUNDRED
37 SEVEN OF THE REAL PROPERTY TAX LAW and shall make such compilation
38 available electronically at least ten days prior to the statewide
39 uniform voting day.

40 c. For purposes of this subdivision, "percentage increase in the
41 consumer price index" shall mean the percentage that represents the
42 product of one hundred and the quotient of: (i) the average of the
43 national consumer price indexes determined by the United States depart-
44 ment of labor for the twelve-month period preceding January first of the
45 current year minus the average of the national consumer price indexes
46 determined by the United States department of labor for the twelve-month
47 period preceding January first of the prior year, divided by (ii) the
48 average of the national consumer price indexes determined by the United
49 States department of labor for the twelve-month period preceding January
50 first of the prior year, with the result expressed as a decimal to two
51 places.

52 S 9. Section 2008 of the education law is amended by adding a new
53 subdivision 3 to read as follows:

54 3. NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, IT
55 SHALL NOT BE WITHIN THE POWERS OF THE VOTERS OF A SCHOOL DISTRICT TO

4 TATIONS ON TRANSPORTATION PURSUANT TO SUBDIVISION NINETEEN OF SECTION
5 TWO THOUSAND TWENTY-ONE OF THIS PART.

6 S 10. Section 2022 of the education law, as amended by section 23 of
7 part A of chapter 436 of the laws of 1997, subdivisions 1 and 3 as
8 amended by section 8 of part C of chapter 58 of the laws of 1998, subdi-
9 vision 2-a as amended by section 3 of part A of chapter 60 of the laws
10 of 2000, paragraph b of subdivision 2-a as amended by section 5 of part
11 W of chapter 57 of the laws of 2008, subdivision 4 as amended by section
12 7 of part M of chapter 57 of the laws of 2005 and subdivision 6 as added
13 by chapter 61 of the laws of 2003, is amended to read as follows:

14 S 2022. [Vote on] ADOPTION OF school district budgets [and on the];
15 ANNUAL DISTRICT MEETING AND election of school district trustees and
16 board of education members. 1. Notwithstanding any law, rule or regu-
17 lation to the contrary, the ANNUAL DISTRICT MEETING AND election of
18 trustees or members of the board of education, and the TAX LEVY PROPOSI-
19 TION vote [upon the appropriation of the necessary funds to meet the
20 estimated expenditures,] in any common school district, union free
21 school district, central school district or central high school district
22 shall be held [at the annual meeting and election] on the third Tuesday
23 in May, provided, however, that such election shall be held on the
24 second Tuesday in May if the commissioner at the request of a local
25 school board certifies no later than March first that such election
26 would conflict with religious observances. [When such election or vote
27 is taken by recording the ayes and noes of the qualified voters attend-
28 ing, a majority of the qualified voters present and voting, by a hand or
29 voice vote, may determine to take up the question of voting the neces-
30 sary funds to meet the estimated expenditures for a specific item sepa-
31 rately, and the qualified voters present and voting may increase the

41 ensuing school year. IF THE QUALIFIED VOTERS HAVE APPROVED A TAX LEVY
42 PROPOSITION OR UNDERRIDE PROPOSITION IN ACCORDANCE WITH SECTION TWO
43 THOUSAND TWENTY-THREE-A OF THIS PART, SUCH TRUSTEES OR BOARD OF EDUCA-
44 TION SHALL ADOPT A BUDGET THAT COMPLIES WITH SUCH PROPOSITION. IF NO
45 TAX LEVY PROPOSITION OR UNDERRIDE PROPOSITION HAS BEEN APPROVED BY THE
46 QUALIFIED VOTERS, THEN THE TRUSTEES OR BOARD OF EDUCATION SHALL ADOPT A
47 BUDGET THAT REQUIRES A TAX LEVY, EXCLUDING ANY CAPITAL TAX LEVY, THAT IS
48 NO GREATER THAN THE TAX LEVY BASE DETERMINED PURSUANT TO SECTION THIR-
49 TEEN HUNDRED SEVEN OF THE REAL PROPERTY TAX LAW.

50 2. [Except as provided in subdivision four of this section, nothing]
51 NOTHING in this section shall preclude the trustees or board of educa-
52 tion, in their discretion, from submitting additional items of expendi-
53 ture to the voters for approval as separate propositions or the voters
54 from submitting propositions pursuant to [section] SECTIONS two thousand
55 eight and two thousand thirty-five of this [article] PART.

1 2-a. Every common, union free, central, central high school district
2 and city school district to which this article applies shall mail a
3 school budget notice to all qualified voters of the school district
4 after the date of the budget hearing, but no later than six days prior
5 to the annual meeting and election [or special district meeting at which
6 a school budget vote will occur]. The school budget notice shall compare
7 the percentage increase or decrease in total spending under the proposed
8 budget over total spending under the school district budget adopted for

19 [a. Commencing with the proposed budget for the two thousand one--two
20 thousand two school year, such notice shall also include a description
21 of how total spending and the tax levy resulting from the proposed budg-
22 et would compare with a projected contingency budget adopted pursuant to
23 section two thousand twenty-three of this article, assuming that such
24 contingency budget is adopted on the same day as the vote on the
25 proposed budget. Such comparison shall be in total and by component
26 (program, capital and administrative), and shall include a statement of
27 the assumptions made in estimating the projected contingency budget.

28 b.] Commencing with the proposed budget for the two thousand eight--
29 two thousand nine school year, such notice shall also include, in a
30 format prescribed by the commissioner, an estimate of the tax savings
31 that would be available to an eligible homeowner under the basic school
32 tax relief (STAR) exemption authorized by section four hundred twenty-
33 five of the real property tax law if the proposed budget were adopted.
34 Such estimate shall be made in the manner prescribed by the commission-
35 er, in consultation with the office of real property services.

36 3. In all elections for trustees or members of boards of education or
37 votes ON PROPOSITIONS involving the expenditure of money, or authorizing
38 the levy of taxes, OR VOTES ON PROPOSITIONS TO UNDERRIDE A TAX LEVY
39 LIMITATION PURSUANT TO SECTION TWO THOUSAND TWENTY-THREE-A OF THIS PART,
40 the vote thereon shall be by ballot, or, in school districts that prior
41 to nineteen hundred ninety-eight conducted their vote at the annual
42 meeting, may be ascertained by taking and recording the ayes and noes of
43 such qualified voters attending and voting at such district meetings.

44 4. [In the event that the original proposed budget is not approved by
45 the voters, the sole trustee, trustees or board of education may adopt a
46 final budget pursuant to subdivision five of this section or resubmit to
47 the voters the original or a revised budget pursuant to subdivision
48 three of section two thousand seven of this part. Upon one defeat of
49 such resubmitted budget, the sole trustee, trustees or board of educa-
50 tion shall adopt a final budget pursuant to subdivision five of this
51 section.] Notwithstanding any other provision of law to the contrary,
52 [the school district budget for any school year, or any part of such
53 budget or] any propositions involving the expenditure of money for such
54 school year shall not be submitted for a vote of the qualified voters

1 [5. If the qualified voters fail to approve the proposed school
2 district budget upon resubmission or upon a determination not to resub-

10 6. Notwithstanding the provisions of subdivision four of section eigh-
11 teen hundred four and subdivision five of section nineteen hundred six

14 ty-six hundred one-a of this title and any other provision of law to the
15 contrary, the annual district meeting and election of every common,
16 union free, central and central high school district and the annual
17 meeting of every city school district in a city having a population of
18 less than one hundred twenty-five thousand inhabitants that is scheduled
19 to be held on the third Tuesday of May, two thousand three is hereby
20 adjourned until the first Tuesday in June, two thousand three. The trus-
21 tees or board of education of each such school district shall provide
22 notice of such adjourned meeting to the qualified voters in the manner
23 prescribed for notice of the annual meeting, and such notice shall
24 provide for an adjourned budget hearing. The adjourned district meeting
25 or district meeting and election shall be deemed the annual meeting or
26 annual meeting and election of the district for all purposes under this
27 title and the date of the adjourned meeting shall be deemed the state-
28 wide uniform voting day for all purposes under this title. Notwith-
29 standing the provisions of subdivision seven of section sixteen hundred
30 eight or subdivision seven of section seventeen hundred sixteen of this
31 title or any other provision of law, rule or regulation to the contrary,

36 S 11. The education law is amended by adding a new section 2023-a to
37 read as follows:

38 S 2023-A. VOTER APPROVAL OF TAX LEVY LIMITATIONS. 1. THE TAX LEVY FOR
39 ANY SCHOOL DISTRICT SUBJECT TO THE TAX LEVY LIMITATIONS ESTABLISHED BY
40 SECTION THIRTEEN HUNDRED SEVEN OF THE REAL PROPERTY TAX LAW SHALL BE
41 APPROVED BY THE QUALIFIED VOTERS OF THE SCHOOL DISTRICT AS PROVIDED IN
42 THIS SECTION. AS USED IN THIS SECTION, THE TERM "TAX LEVY PROPOSITION"
43 MEANS A PROPOSITION TO AUTHORIZE A TAX LEVY SUFFICIENT TO SUPPORT THE
44 PROPOSED SCHOOL DISTRICT BUDGET, EXCLUDING ANY PROPOSED CAPITAL TAX
45 LEVY; THE TERM "UNDERRIDE PROPOSITION" MEANS A PROPOSITION TO IMPOSE A
46 MORE RESTRICTIVE TAX LEVY LIMIT UPON A SCHOOL DISTRICT THAN THE TAX LEVY
47 LIMIT ESTABLISHED PURSUANT TO SECTION THIRTEEN HUNDRED SEVEN OF THE REAL
48 PROPERTY TAX LAW; AND THE TERM "GENERAL PURPOSE STATE AID" MEANS ALL
49 FORMS OF STATE AID WHICH ARE PAYABLE TO A SCHOOL DISTRICT AS GENERAL
50 SUPPORT FOR THE PUBLIC SCHOOLS, WITH THE EXCEPTION OF BUILDING AID,
51 LIBRARY AID, COMPUTER HARDWARE AND SOFTWARE AID, UNIVERSAL PRE-KINDER-
52 GARTEN AID AND TEXTBOOK AID. THE DIRECTOR OF THE BUDGET SHALL ANNUALLY
53 CERTIFY THE AMOUNT OF GENERAL PURPOSE STATE AID PAYABLE TO EACH SCHOOL
54 DISTRICT.

55 2. A. THE QUALIFIED VOTERS OF A COMMON SCHOOL DISTRICT, UNION FREE
56 SCHOOL DISTRICT, CENTRAL SCHOOL DISTRICT, CENTRAL HIGH SCHOOL DISTRICT

1 OR A CITY SCHOOL DISTRICT IN A CITY WITH LESS THAN ONE HUNDRED
2 TWENTY-FIVE THOUSAND INHABITANTS, UPON FILING OF A VALID PETITION PURSU-
3 ANT TO PARAGRAPH B OF THIS SUBDIVISION, MAY VOTE TO IMPOSE TAX LEVY
4 LIMITS FOR THE ENSUING SCHOOL YEAR THAT ARE MORE RESTRICTIVE THAN THOSE
5 OTHERWISE IMPOSED BY SECTION THIRTEEN HUNDRED SEVEN OF THE REAL PROPERTY
6 TAX LAW. NO SUCH VOTE SHALL APPLY TO MORE THAN ONE SCHOOL YEAR.

7 B. UPON THE FILING WITH THE TRUSTEE, TRUSTEES OR BOARD OF EDUCATION OF
8 ONE OR MORE PETITIONS PURSUANT TO THIS SUBDIVISION REQUESTING THAT AN
9 UNDERRIDE PROPOSITION BE SUBMITTED FOR A VOTE AT A SPECIAL DISTRICT
10 MEETING, SUCH OFFICERS SHALL CALL A SPECIAL DISTRICT MEETING TO BE HELD
11 ON THE FIRST TUESDAY IN MAY, OR THE LAST TUESDAY IN APRIL WHERE THERE
12 WOULD BE A CONFLICT WITH RELIGIOUS OBSERVANCES, IN ACCORDANCE WITH THE
13 APPLICABLE PROVISIONS OF SUBDIVISION THREE OF SECTION TWO THOUSAND SEVEN
14 OF THIS PART, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS AN
15 UNDERRIDE PROPOSITION. SUCH OFFICERS SHALL SUBMIT FOR A VOTE OF THE
16 QUALIFIED VOTERS THE PROPOSITION THAT WAS SIGNED BY THE GREATEST NUMBER
17 OF QUALIFIED VOTERS, OR, IF THERE IS A TIE, THE PROPOSITION SIGNED BY
18 THE GREATEST NUMBER OF QUALIFIED VOTERS THAT WAS FILED FIRST. A PETITION
19 FOR AN UNDERRIDE PROPOSITION SHALL BE SIGNED BY: (I) AT LEAST TEN
20 PERCENT OF THE REGISTERED VOTERS OF THE SCHOOL DISTRICT BASED ON THE
21 REGISTER PREPARED AT THE LAST ANNUAL MEETING AND ELECTION OF THE SCHOOL
22 DISTRICT; OR (II) IF THE SCHOOL DISTRICT DOES NOT PROVIDE FOR THE
23 PERSONAL REGISTRATION OF VOTERS, BY TWO HUNDRED FIFTY QUALIFIED VOTERS
24 OR TWENTY PERCENT OF THE NUMBER OF VOTERS WHO VOTED IN THE PREVIOUS
25 ANNUAL ELECTION OF THE MEMBERS OF THE BOARD OF EDUCATION OR TRUSTEES,
26 WHICHEVER IS LESS. SUCH PETITION SHALL BE FILED IN THE OFFICE OF THE
27 CLERK OF THE DISTRICT BETWEEN THE HOURS OF NINE A.M. AND FIVE P.M., NOT
28 LATER THAN THE TWENTIETH DAY PRECEDING THE SPECIAL DISTRICT MEETING AT
29 WHICH AN UNDERRIDE VOTE MAY OCCUR.

30 C. WHERE A PROPOSITION TO UNDERRIDE A TAX LEVY LIMITATION IS TO BE
31 SUBMITTED FOR A VOTE AT A SPECIAL DISTRICT MEETING CALLED FOR THIS
32 PURPOSE, THE CLERK OF THE DISTRICT SHALL GIVE NOTICE OF THE TIME AND
33 PLACE OF THE SPECIAL DISTRICT MEETING BY PUBLISHING A NOTICE AT LEAST
34 FOURTEEN DAYS PRIOR TO THE SPECIAL DISTRICT MEETING IN TWO NEWSPAPERS IF
35 THERE SHALL BE TWO, OR IN ONE NEWSPAPER IF THERE SHALL BE BUT ONE,
36 HAVING GENERAL CIRCULATION WITHIN SUCH DISTRICT, PROVIDED, HOWEVER, THAT
37 IF THERE IS NO NEWSPAPER HAVING GENERAL CIRCULATION WITHIN THE DISTRICT,
38 THE SAID NOTICE SHALL BE POSTED IN AT LEAST TWENTY OF THE MOST PUBLIC
39 PLACES IN SAID DISTRICT FOURTEEN DAYS BEFORE THE TIME OF SUCH MEETING.

40 D. AN UNDERRIDE PROPOSITION SHALL BE A SEPARATE PROPOSITION IN
41 SUBSTANTIALLY THE FOLLOWING FORM:

42 "SHALL THE SCHOOL DISTRICT BE REQUIRED TO IMPOSE A TAX LEVY
43 FOR THE SCHOOL YEAR, EXCLUDING ANY CAPITAL TAX LEVY, THAT IS NO
44 GREATER THAN , EVEN THOUGH THE STATUTORY TAX LEVY LIMIT FOR THAT
45 SCHOOL YEAR IS ?"

46 E. AN UNDERRIDE PROPOSITION SHALL BE APPROVED IF OVER FIFTY PERCENT OF
47 THE VOTES CAST THEREON ARE IN THE AFFIRMATIVE. IF SUCH UNDERRIDE PROPO-
48 SITION IS APPROVED BY THE QUALIFIED VOTERS, THE TAX LEVY LIMIT IMPOSED
49 THEREBY SHALL BE DEEMED TO BE THE TAX LEVY LIMIT FOR THE SCHOOL DISTRICT
50 FOR THE COMING SCHOOL YEAR FOR PURPOSES OF SECTION THIRTEEN HUNDRED
51 SEVEN OF THE REAL PROPERTY TAX LAW, AND THE TRUSTEES OR BOARD OF EDUCA-
52 TION SHALL ADOPT A BUDGET THAT COMPLIES WITH SUCH TAX LEVY LIMIT. UPON
53 APPROVAL OF AN UNDERRIDE PROPOSITION, NO OTHER TAX LEVY PROPOSITION MAY
54 BE SUBMITTED TO THE VOTERS FOR THAT SAME SCHOOL YEAR.

55 3. A. UNLESS AN UNDERRIDE PROPOSITION HAS BEEN APPROVED PURSUANT TO
56 SUBDIVISION TWO OF THIS SECTION, THE TRUSTEE, TRUSTEES OR BOARD OF

1 EDUCATION OF A SCHOOL DISTRICT SHALL PRESENT AT THE ANNUAL MEETING AND
2 ELECTION A TAX LEVY PROPOSITION IN SUBSTANTIALLY THE FOLLOWING FORM:
3 "SHALL THE SCHOOL DISTRICT BE AUTHORIZED TO IMPOSE A TAX
4 LEVY FOR THE SCHOOL YEAR, EXCLUDING ANY CAPITAL TAX LEVY,
5 OF , WHEN THE STATUTORY TAX LEVY LIMIT FOR THAT SCHOOL YEAR
6 IS ?"

7 B. EXCEPT AS OTHERWISE PROVIDED IN SECTION THIRTEEN HUNDRED SEVEN OF
8 THE REAL PROPERTY TAX LAW, IF THE PROPOSED TAX LEVY DOES NOT EXCEED THE
9 TAX LEVY LIMIT DETERMINED PURSUANT TO SECTION THIRTEEN HUNDRED SEVEN OF
10 THE REAL PROPERTY TAX LAW, THEN THE PROPOSITION SHALL BE APPROVED IF
11 OVER FIFTY PERCENT OF THE VOTES CAST THEREON ARE IN THE AFFIRMATIVE. IF
12 THE PROPOSED TAX LEVY WOULD EXCEED THE TAX LEVY LIMIT DETERMINED PURSU-
13 ANT TO SECTION THIRTEEN HUNDRED SEVEN OF THE REAL PROPERTY TAX LAW, THEN
14 THE PROPOSITION SHALL BE APPROVED IF OVER FIFTY-FIVE PERCENT OF VOTES
15 CAST THEREON ARE IN THE AFFIRMATIVE.

16 IF THE AMOUNT OF GENERAL PURPOSE STATE AID WHICH WILL BE PAYABLE TO A
17 SCHOOL DISTRICT FOR THE COMING SCHOOL YEAR HAS NOT BEEN CERTIFIED BY THE
18 DIRECTOR OF THE BUDGET, THEN FIFTY PERCENT OF THE VOTES CAST ON THE
19 PROPOSITION BY QUALIFIED VOTERS MUST BE IN THE AFFIRMATIVE IN ORDER FOR
20 THE PROPOSITION TO BE APPROVED.

21 C. IF THE TAX LEVY PROPOSITION IS APPROVED BY THE QUALIFIED VOTERS,
22 THE TAX LEVY LIMIT IMPOSED THEREBY SHALL BE DEEMED TO BE THE TAX LEVY
23 LIMIT FOR THE SCHOOL DISTRICT FOR THE COMING SCHOOL YEAR, AND THE TRUS-
24 TEES OR BOARD OF EDUCATION SHALL ADOPT A BUDGET THAT COMPLIES WITH SUCH
25 TAX LEVY LIMIT. IF, HOWEVER, THE TAX LEVY PROPOSITION IS NOT APPROVED BY
26 THE QUALIFIED VOTERS, THEN THE TRUSTEES OR BOARD OF EDUCATION SHALL
27 ADOPT A BUDGET THAT REQUIRES A TAX LEVY EXCLUDING ANY CAPITAL TAX LEVY,
28 THAT IS NO GREATER THAN THE TAX LEVY BASE DETERMINED PURSUANT TO SECTION
29 THIRTEEN HUNDRED SEVEN OF THE REAL PROPERTY TAX LAW.

30 S 12. This act shall take effect immediately.
