AN ACT to amend the vehicle and traffic law, in relation to authorizing the issuance of license plates bearing the logo of Suffolk county community college and to amend the state finance law, in relation to establishing the Suffolk county community college revolving fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new
2 section 404-x to read as follows:

3 S 404-X. DISTINCTIVE "SUFFOLK COUNTY COMMUNITY COLLEGE" LICENSE
4 PLATES. 1. ANY PERSON RESIDING IN THIS STATE SHALL UPON REQUEST BE
5 ISSUED A DISTINCTIVE LICENSE PLATE BEARING THE LOGO OF SUFFOLK COUNTY
6 COMMUNITY COLLEGE. APPLICATION FOR SAID LICENSE PLATES SHALL BE FILED
7 WITH THE COMMISSIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL
8 PRESCRIBE.

9 2. ANY DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE
10 ISSUED IN THE SAME MANNER AS OTHER NUMBER PLATES UPON THE PAYMENT OF THE
11 REGULAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS
12 ARTICLE PROVIDED, HOWEVER, THAT AN ADDITIONAL ANNUAL SERVICE CHARGE OF
13 TWENTY-FIVE DOLLARS SHALL BE CHARGED FOR SUCH PLATE. SUCH ANNUAL SERVICE
14 CHARGE SHALL BE DEPOSITED PURSUANT TO THE PROVISIONS OF SECTION FOUR
15 HUNDRED FOUR-00 OF THIS ARTICLE TO THE CREDIT OF THE "SUFFOLK COUNTY
16 COMMUNITY COLLEGE FOUNDATION REVOLVING FUND" ESTABLISHED BY SECTION
17 NINETY-NINE-Q OF THE STATE FINANCE LAW, AND SHALL BE USED FOR CONTRIB-
18 UTIONS TO STUDENT SCHOLARSHIP AWARDS. PROVIDED, HOWEVER, THAT ONE YEAR
19 AFTER THE EFFECTIVE DATE OF THIS SECTION, FUNDS IN THE AMOUNT OF FIVE
20 THOUSAND DOLLARS, OR SO MUCH THEREOF AS MAY BE AVAILABLE SHALL BE ALLO-
21 CATED FROM SUCH FUND TO THE DEPARTMENT TO OFFSET COSTS ASSOCIATED WITH
22 THE PRODUCTION OF SUCH LICENSE PLATE.

1 S 2. The state finance law is amended by adding a new section 99-q to
2 read as follows:

3 S 99-Q. SUFFOLK COUNTY COMMUNITY COLLEGE FOUNDATION REVOLVING FUND. 1.
4 THERE IS HEREBY ESTABLISHED IN THE JOINT CUSTODY OF THE COMMISSIONER OF
5 TAXATION AND FINANCE AND THE COMPTROLLER, A SPECIAL FUND TO BE KNOWN AS
6 THE "SUFFOLK COUNTY COMMUNITY COLLEGE FOUNDATION REVOLVING FUND".

7 2. SUCH FUND SHALL CONSIST OF ALL REVENUES RECEIVED PURSUANT TO THE
8 PROVISIONS OF SECTION FOUR HUNDRED FOUR-X OF THE VEHICLE AND TRAFFIC LAW
9 AND ALL OTHER MONEYS APPROPRIATED, CREDITED, OR TRANSFERRED THERETO FROM
10 ANY OTHER FUND OR SOURCE PURSUANT TO LAW. NOTHING CONTAINED IN THIS
11 SECTION SHALL PREVENT THE STATE FROM RECEIVING GRANTS, GIFTS OR BEQUESTS
12 FOR THE PURPOSES OF THE FUND AS DEFINED IN THIS SECTION AND DEPOSITING
13 THEM INTO THE FUND ACCORDING TO LAW.

14 3. MONIES OF THE FUND SHALL BE EXPENDED ONLY FOR CONTRIBUTIONS TOWARDS
15 STUDENT SCHOLARSHIP AWARDS.

16 S 3. This act shall take effect on the one hundred eightieth day after
17 it shall have become a law. Effective immediately, the addition, amend-
18 ment and/or repeal of any rule or regulation necessary for the implemen-
19 tation of this act on its effective date is authorized to be made on or
20 before such effective date.
