AN ACT to amend the retirement and social security law, in relation to the reporting requirements of public entities; and to repeal section 217 of such law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 217 of the retirement and social security law is  
2 REPEALED and a new section 217 is added to read as follows:

3 S 217. REPORTING REQUIREMENTS; PUBLIC ENTITY SALARY TRANSPARENCY AND  
4 DISCLOSURE. 1. AS USED IN THIS SECTION, THE TERM PUBLIC ENTITY SHALL  
5 MEAN: (I) THE STATE; (II) A COUNTY, CITY, TOWN, VILLAGE OR ANY OTHER  
6 POLITICAL SUBDIVISION OR CIVIL DIVISION OF THE STATE; (III) A SCHOOL  
7 DISTRICT, BOARD OF COOPERATIVE EDUCATIONAL SERVICES, OR ANY OTHER  
8 GOVERNMENTAL ENTITY OR COMBINATION OR ASSOCIATION OF GOVERNMENTAL ENTI-  
9 TIES OPERATING A PUBLIC SCHOOL, COLLEGE, COMMUNITY COLLEGE OR UNIVERSI-  
10 TY; (IV) A PUBLIC IMPROVEMENT OR SPECIAL DISTRICT; (V) A PUBLIC AUTHORI-  
11 TY, COMMISSION, AGENCY OR PUBLIC BENEFIT CORPORATION; (VI) A DISTRICT  
12 CORPORATION; OR (VII) ANY OTHER SEPARATE CORPORATE INSTRUMENTALITY OR  
13 UNIT OF GOVERNMENT.

14 2. A PUBLIC ENTITY SHALL REPORT ALL MONEY EARNED BY A RETIRED PERSON  
15 IN ITS EMPLOY THAT IS IN EXCESS OF THE EARNINGS LIMITATION OUTLINED IN  
16 SECTION TWO HUNDRED TWELVE OF THIS ARTICLE TO THE RETIREMENT SYSTEM  
17 ADMINISTERED BY THE STATE OR ANY OF ITS POLITICAL SUBDIVISIONS FROM WHOM  
18 SUCH RETIRED PERSON IS COLLECTING THEIR RETIREMENT ALLOWANCE.

19 3. A PUBLIC ENTITY EMPLOYING A RETIRED PERSON WHO IS ELIGIBLE TO  
20 COLLECT OR IS ALREADY COLLECTING A RETIREMENT ALLOWANCE FROM A RETIRE-  
21 MENT SYSTEM ADMINISTERED BY THE STATE OR ANY OF ITS POLITICAL SUBDIVI-  
22 SIONS SHALL REPORT ON AN ANNUAL BASIS TO THE RETIREMENT SYSTEM PAYING  
23 SUCH RETIREMENT ALLOWANCE TO SUCH RETIRED PERSON AND TO THE STATE COMP-  
24 TROLLER. THIS REPORT SHALL CONSIST OF THE RE-EMPLOYED RETIREE'S NAME,  
25 DATE OF BIRTH, PLACE OF EMPLOYMENT, CURRENT POSITION AND ALL EARNINGS.

FISCAL NOTE.--PURSUANT TO LEGISLATIVE LAW, SECTION 50:

This bill would require the state of New York and the participating employers in a public retirement system which employs any retiree of a public retirement system to annually file a report to the retirement system from which such employee retired. Such report shall consist of the retiree's name, date of birth, place of employment, current position and all earnings.

If this bill is enacted, we anticipate that there would be a small annual administrative cost to the New York State and Local Employees' Retirement System and the New York State and Local Police and Fire Retirement System.

This estimate, dated January 4, 2010, and intended for use only during the 2010 Legislative Session, is Fiscal Note No. 2010-2, prepared by the Actuary for the New York State and Local Employees' Retirement System and the New York State and Local Police and Fire Retirement System.
