AN ACT to amend the civil rights law, in relation to enacting the religious freedom restoration act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The civil rights law is amended by adding a new section
2 79-n to read as follows:
3 S 79-N. RELIGIOUS FREEDOM RESTORATION ACT. 1. THE LEGISLATURE HEREBY
4 FINDS AND DECLARES THAT THE INALIENABLE RIGHT TO THE FREE EXERCISE OF
5 RELIGION IS SECURED BY THE NEW YORK STATE AND FEDERAL CONSTITUTIONS AND
6 MAY NOT BE BURDENED BY GOVERNMENT ABSENT COMPELLING INTEREST AND JUSTI-
7 FICATION, AND THAT SUCH COMPELLING INTEREST MUST MEET THE TESTS OF BEING
8 MORE THAN ROUTINE, MUST RELATE DIRECTLY TO CORE CONSTITUTIONAL ISSUES,
9 AND MUST DO MORE THAN MERELY IMPROVE GOVERNMENT EFFICIENCY. THE LEGISLA-
10 TURE FURTHER FINDS IT TO BE IN EVERY SENSE IN THE PUBLIC INTEREST TO
11 REQUIRE, AND HEREBY REQUIRES, AS A MATTER OF STATE POLICY, THAT THE
12 APPLICATION OF ANY RULE IN FURTHERANCE OF SUCH COMPELLING INTEREST BE
13 PERFORMED IN THE LEAST RESTRICTIVE MANNER.
14 THE LEGISLATURE DECLARES THAT THE PURPOSES OF THIS SECTION ARE IN
15 EVERY SENSE IN THE PUBLIC INTEREST AND FOR THE BENEFIT OF THE PEOPLE OF
16 THE STATE OF NEW YORK, THOSE INTERESTS BEING: TO PROVIDE A STANDARDIZED
17 AND WORKABLE TEST FOR BALANCING RELIGIOUS LIBERTY AND GOVERNMENT INTER-
18 ESTS; TO GUARANTEE APPLICATION OF SUCH TEST IN ALL CASES WHERE EXERCISE
19 OF RELIGION IS SUBSTANTIALLY BURDENED; TO REQUIRE AS A MATTER OF STATE
20 POLICY THAT THE APPLICATION OF ANY RULE OR ACTION BY THE GOVERNMENT IN
21 ANY SUCH CASES BE EXECUTED IN THE LEAST RESTRICTIVE MANNER POSSIBLE; AND
22 TO PROVIDE A CLAIM OR DEFENSE TO PERSONS WHOSE RELIGIOUS EXERCISE IS
23 SUBSTANTIALLY BURDENED BY GOVERNMENT ACTIONS.
24 2. AS USED IN THIS SECTION:
25 A. "STATE GOVERNMENT" MEANS ANY DEPARTMENT, BUREAU, COMMISSION, BOARD,
26 PUBLIC AUTHORITY OR OTHER AGENCY OF THE STATE, INCLUDING ANY PUBLIC
27 BENEFIT CORPORATION ANY MEMBER OF WHOSE BOARD IS APPOINTED BY THE GOVER-
28 NOR, OR ANY OFFICIAL OF ANY SUCH ENTITY DESCRIBED IN THIS SECTION.
29 B. "LOCAL GOVERNMENT" MEANS ANY VILLAGE, TOWN (OUTSIDE THE AREA OF ANY
30 INCORPORATED VILLAGE), CITY, OR ANY PUBLIC BENEFIT CORPORATION ANY
31 MEMBER OF WHOSE BOARD IS APPOINTED BY A LOCAL GOVERNMENT, OR ANY OFFI-

1 CIAL OF ANY SUCH ENTITY. WHERE A BOARD INCLUDES MEMBERS APPOINTED BY
2 THE GOVERNOR AND BY A LOCAL GOVERNMENT, THE BOARD SHALL BE CONSIDERED AS
3 INCLUDED IN THE DEFINITION OF STATE GOVERNMENT.

4 C. "GOVERNMENT" WHEN USED SINGLY MEANS STATE AND LOCAL GOVERNMENT.

5 D. "EXERCISE OF RELIGION" MEANS AND INCLUDES ANY EXERCISE OF RELIGION,
6 WHETHER OR NOT COMPELLED BY, OR CENTRAL TO, A SYSTEM OF RELIGIOUS
7 BELIEF, AND INCLUDES ANY ACT OR REFUSAL TO ACT THAT IS SUBSTANTIALLY
8 MOTIVATED BY SUCH RELIGIOUS BELIEF, AS WELL AS THE USE, BUILDING, OR
9 CONVERSION OF REAL PROPERTY FOR THE PURPOSE OF RELIGIOUS EXERCISE OF THE
10 PERSON OR ENTITY THAT USES OR INTENDS TO USE THE PROPERTY FOR THAT
11 PURPOSE.

12 3. STATE AND LOCAL GOVERNMENT SHALL NOT SUBSTANTIALLY BURDEN A
13 PERSON'S EXERCISE OF RELIGION BY ANY ACT OR FAILURE TO ACT.

14 A. A PERSON WHOSE RELIGIOUS EXERCISE IS, HAS BEEN, OR IS PROPOSED TO
15 BE SUBSTANTIALLY BURDENED IN VIOLATION OF THIS SECTION BY STATE OR LOCAL
16 GOVERNMENT SHALL NOTIFY SUCH GOVERNMENT, WHICH SHALL ACCOMMODATE SUCH
17 PERSON'S RELIGIOUS NEEDS OR ELSE PROVIDE CREDIBLE EVIDENCE THAT APPLICA-
18 TION OF THE BURDEN TO THE PERSON (1) FURTHERS A COMPELLING GOVERNMENTAL
19 INTEREST, AND (2) IS THE LEAST RESTRICTIVE MEANS OF FURTHERING SUCH
20 COMPELLING GOVERNMENTAL INTEREST.

21 B. A PERSON WHOSE RELIGIOUS EXERCISE HAS BEEN SUBSTANTIALLY BURDENED
22 IN VIOLATION OF THIS SECTION MAY ASSERT SUCH VIOLATION AS A CLAIM OR
23 DEFENSE IN A JUDICIAL PROCEEDING, PROVIDED, HOWEVER, THAT IT SHALL BE AN
24 EXCEPTION TO THE PROHIBITION ENACTED BY THIS SECTION IN ANY CASE IN
25 WHICH GOVERNMENT PROVIDES CREDIBLE EVIDENCE THAT APPLICATION OF THE
26 BURDEN TO THE PERSON (1) FURTHERS A COMPELLING GOVERNMENTAL INTEREST;
27 AND (2) IS THE LEAST RESTRICTIVE MEANS OF FURTHERING SUCH COMPELLING
28 GOVERNMENTAL INTEREST.

29 C. A PARTY WHO PREVAILS IN AN ACTION TO ENFORCE THIS SECTION AGAINST A
30 GOVERNMENT SHALL BE ENTITLED TO RECOVER ATTORNEY'S FEES AND COSTS
31 INCURRED IN MAINTAINING SUCH CLAIM OR DEFENSE.

32 4. NOTHING IN THIS SECTION SHALL BE CONSTRUED TO AUTHORIZE ANY GOVERN-
33 MENT TO SUBSTANTIALLY BURDEN ANY RELIGIOUS BELIEF, NOR SHALL THE GRANT-
34 ING OF GOVERNMENT FUNDING, BENEFITS, OR EXEMPTIONS BE CONSTRUED AS A
35 VIOLATION HEREUNDER, PROVIDED HOWEVER THAT THE WORD "GRANTING" SHALL NOT
36 BE DEEMED TO MEAN OR INCLUDE A DENIAL OF GOVERNMENT FUNDING, BENEFITS,
37 OR EXEMPTIONS.

38 5. ANY OTHER PROVISION OF ANY OTHER LAW TO THE CONTRARY NOTWITHSTAND-
39 ING, ANY VILLAGE, TOWN (OUTSIDE THE AREA OF ANY INCORPORATED VILLAGE) OR
40 CITY MAY ENACT ORDINANCES, STANDARDS, RULES, OR REGULATIONS THAT PROTECT
41 THE FREE EXERCISE OF RELIGION IN A MANNER OR TO AN EXTENT EQUAL TO OR
42 GREATER THAN THE PROTECTION PROVIDED IN THIS SECTION.

43 6. ANY IMPLICATION IN THE FOREGOING TO THE CONTRARY NOTWITHSTANDING,
44 "COMPELLING GOVERNMENT INTEREST" SHALL BE DEEMED TO INCLUDE ACTIVITIES
45 BY GOVERNMENT WHICH PREVENT OR PUNISH ANY ACT WHICH ON ITS FACE WOULD OR
46 IF UNDERTAKEN WOULD CONSTITUTE A VIOLATION, MISDEMEANOR, OR FELONY UNDER
47 THE PENAL OR ANY OTHER LAW OF THIS STATE.

48 S 2. Severability. If any clause, sentence, paragraph, section or part
49 of this act shall be adjudged by any court of competent jurisdiction to
50 be invalid and after exhaustion of all further judicial review, the
51 judgment shall not affect, impair or invalidate the remainder thereof,
52 but shall be confined in its operation to the clause, sentence, para-
53 graph, section or part of this act directly involved in the controversy
54 in which such judgment shall have been rendered.

55 S 3. This act shall take effect immediately.
