AN ACT to amend the transportation law, in relation to the membership of the Stewart airport commission

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 401 of the transportation law, as  
2 amended by chapter 55 of the laws of 1992, is amended to read as  
3 follows:  
4 1. Upon assumption by the department of transportation of jurisdiction  
5 over the airport facility and surrounding area located in the county of  
6 Orange, known as Stewart airport, there shall thereupon be created a  
7 Stewart airport commission. This commission will be an advisory council  
8 to the commissioner with respect to administration and management of the  
9 Stewart airport facilities and its surrounding areas with respect to  
10 projects to be undertaken and operations and management of the facili-  
11 ties at such airport. The commission shall be composed of ten members of  
12 which six must be residents of Orange county, two must be residents of  
13 Dutchess county and two residents from Ulster county. By virtue of their  
14 offices, the commissioner of transportation or the commissioner's desig-  
15 nee, the Orange county executive, the Dutchess county executive and the  
16 [chairperson of the Ulster county legislature] *ULSTER COUNTY EXECUTIVE*  
17 shall be ex officio members of the commission. The members of the  
18 commission shall be appointed by the governor with the advice and  
19 consent of the senate and, except for the initial appointment terms,  
20 shall serve for a term of four years. However, two of the appointments  
21 must be from a list submitted by the temporary president and majority  
22 leader of the senate, and two must be from a list submitted by the  
23 speaker of the assembly. Initial appointments shall be to staggered  
24 terms with three of the nominees of the governor being made to initial  
25 one-year terms and the other three nominees to initial four-year terms,  
26 the members nominated by the speaker of the assembly to initial two-year  
27 and three-year terms, respectively, and the members nominated by the

1 temporary president and majority leader of the senate to initial two-  
2 year and three-year terms, respectively. If any member shall thereafter  
3 no longer meet the residency requirement of his or her appointment, such  
4 position shall be declared vacant. In the event of a vacancy, the vacan-  
5 cy shall be filled in the same manner as the initial appointments except  
6 that the term shall be for the unexpired portion of the term of such  
7 members. All such members shall be deemed officers of the state in  
8 connection with the provisions of section seventeen of the public offi-  
9 cers law. The members of the commission shall appoint a chairman from  
10 among their number. Members shall not receive a salary or other compen-  
11 sation, but shall be reimbursed for their actual and necessary expenses  
12 incurred in the performance of their official duties.

13 S 2. This act shall take effect immediately.
