



1 BARNs. OUTDOOR WOOD BOILERS ARE USED TO HEAT WATER OR A WATER AND ANTI-  
2 FREEZE MIXTURE THAT IS DISTRIBUTED THROUGH PIPES GIVING OFF HEAT IN THE  
3 PROCESS.

4 (D) "NUISANCE" AS USED IN THIS SECTION MEANS THE OPERATION OF AN  
5 OUTDOOR WOOD BOILER IN SUCH A WAY AS TO CREATE A CONDITION THAT INTER-  
6 FERES WITH THE QUIET USE AND ENJOYMENT OF NEIGHBORING PROPERTY BY THE  
7 OWNER AND/OR OCCUPANT OF SUCH PROPERTY.

8 2. IT SHALL BE UNLAWFUL TO OPERATE AN OUTDOOR WOOD BOILER USING ANY  
9 FUEL SOURCE OTHER THAN CLEAN WOOD OR OTHER BIOMASS THAT IS CONSISTENT  
10 WITH THE RECOMMENDATIONS OF THE MANUFACTURER OF SUCH OUTDOOR WOOD BOIL-  
11 ER.

12 3. OPERATION OF AN OUTDOOR WOOD BOILER IN SUCH A WAY AS TO CREATE A  
13 CONDITION THAT INTERFERES WITH THE QUIET USE AND ENJOYMENT OF NEIGHBOR-  
14 ING LAND BY THE OWNER OF SUCH LAND SHALL CONSTITUTE A NUISANCE AND THE  
15 VIOLATOR SHALL BE SUBJECT TO THE ENFORCEMENT ACTIONS UNDER THE NUISANCE  
16 PROVISIONS OF SECTION EIGHT HUNDRED FORTY-ONE OF THE REAL PROPERTY  
17 ACTIONS AND PROCEEDINGS LAW AND/OR SECTION THIRTEEN HUNDRED FOUR OF THE  
18 PUBLIC HEALTH LAW.

19 4. NO PERSON SHALL OFFER FOR SALE, INSTALL OR ALLOW TO BE INSTALLED  
20 ANY OUTDOOR WOOD BOILER THAT DOES NOT MEET THE STANDARDS ESTABLISHED  
21 PURSUANT TO THE U.S. ENVIRONMENTAL PROTECTION AGENCY PHASE II VOLUNTARY  
22 PARTNERSHIP PROGRAM FOR EMISSIONS FROM OUTDOOR WOOD BOILERS OF .32  
23 POUNDS PER MILLION BRITISH THERMAL UNITS AFTER JANUARY FIRST, TWO THOU-  
24 SAND ELEVEN.

25 5. THE DEPARTMENT SHALL PREPARE AND MAKE AVAILABLE TO THE PUBLIC GUID-  
26 ANCE ON THE BEST PRACTICES TO FOLLOW INCLUDING BUT NOT LIMITED TO THE  
27 OPERATION, SITING, AND RECOMMENDED STACK HEIGHT FOR OUTDOOR WOOD BOIL-  
28 ERS.

29 6. NOTHING IN THIS SECTION SHALL PRECLUDE A LOCAL GOVERNMENT FROM  
30 ENACTING MORE STRINGENT STANDARDS THAN THOSE ESTABLISHED HEREIN.

31 7. ANY MORE STRINGENT REGULATION OF OUTDOOR WOOD BOILERS BEYOND THAT  
32 WHICH IS CONTAINED IN THIS SECTION SHALL BE LEFT TO THE GOVERNING BODIES  
33 OF THE STATE'S CITIES, TOWNS AND VILLAGES.

34 S 3. This act shall take effect immediately.
