AN ACT to amend the alcoholic beverage control law, in relation to requiring notice to the appropriate community board of any application for liquor store license in the city of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Section 105 of the alcoholic beverage 1 control law is amended by adding a new subdivision 2-a to read as follows:

3 2-A. NOTWITHSTANDING ANY OTHER PROVISION OF THIS CHAPTER, UPON RECEIPT 4 THE CITY OF NEW YORK OF AN APPLICATION FOR A LICENSE UNDER THIS IN SECTION, THE APPLICANT SHALL 5 NOTIFY THE COMMUNITY BOARD ESTABLISHED б SECTION TWENTY-EIGHT HUNDRED OF THE NEW YORK CITY CHARTER PURSUANT TO 7 WITH JURISDICTION OVER THE AREA IN WHICH SUCH LICENSED PREMISES IS TO BE LOCATED BY CERTIFIED MAIL, RETURN RECEIPT REQUESTED, NOT LESS THAN THIR-8 9 TY DAYS PRIOR TO THE SUBMISSION OF ITS APPLICATION FOR A LICENSE UNDER 10 THIS SECTION. SUCH COMMUNITY BOARD MAY EXPRESS AN OPINION FOR OR AGAINST THE GRANTING OF SUCH LICENSE. ANY SUCH OPINION SHALL 11 BE DEEMED PART OF THE RECORD UPON WHICH THE LIQUOR BOARD MAKES ITS DETERMINATION 12 13 TO GRANT OR DENY SUCH LICENSE.

The opening paragraph of section 17-a of the alcoholic beverage 14 S 2. 15 control law, as added by chapter 101 of the laws of 2008, is amended to read as follows: 16

17 The notification required upon receipt of an application for a license 18 pursuant to sections fifty-four, fifty-four-a, fifty-five, sixty-three, 19 sixty-four, sixty-four-a, sixty-four-b, sixty-four-c, eighty-one [and], 20 eighty-one-a AND ONE HUNDRED FIVE or for a renewal under section one 21 hundred nine of this chapter shall be made in such form as shall be prescribed by the rules of the liquor authority. The liquor authority 22 shall require such notification to be on a standardized form that can be 23 24 obtained on the internet or from the liquor authority and such notifica-25 tion to include:

26 S 3. This act shall take effect immediately.
