- AN ACT to amend the executive law and the state finance law, in relation to authorizing municipal governments hosting tribal casinos to receive payments directly from Native American nations or tribes

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 12 of the executive law is amended by adding a new 2 subdivision (d) to read as follows:

3 (D) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, ANY MUNICIPAL GOVERN-4 MENT THAT HOSTS GAMING AND RELATED FACILITIES OF THE NATION MAY RECEIVE 5 PAYMENTS DIRECTLY FROM THE NATION PURSUANT TO SUBDIVISION TWO-A OF ADDED 6 SECTION NINETY-NINE-H OF THE STATE FINANCE LAW, AS ΒY CHAPTER 7 THREE HUNDRED EIGHTY-THREE OF THE LAWS OF TWO THOUSAND ONE. ANY PAYMENTS 8 BY THE NATION DIRECTLY TO A MUNICIPAL GOVERNMENT THAT HOSTS GAMING MADE 9 AND RELATED FACILITIES PURSUANT TO THIS SUBDIVISION SHALL BE DEEMED TΟ HAVE BEEN MADE IN SATISFACTION OF THE COMPACT, AND SUCH PAYMENTS SHALL 10 BE DEDUCTED FROM THE AMOUNTS THE STATE IS REQUIRED TO PAY SUCH MUNICIPAL 11 12 GOVERNMENT PURSUANT TO SUBDIVISION THREE OR FOUR OF SUCH SECTION NINE-13 TY-NINE-H.

14 S 2. Subdivision 2 of section 99-h of the state finance law, as 15 amended by chapter 747 of the laws of 2006, is amended and a new subdi-16 vision 2-a is added to read as follows:

17 2. Such account shall consist of all revenues resulting from tribal-18 state compacts executed pursuant to article two of the executive law and a tribal-state compact with the St. Regis Mohawk tribe executed pursuant 19 20 to chapter five hundred ninety of the laws of two thousand four, LESS PAYMENTS MADE DIRECTLY BY A NATIVE AMERICAN NATION OR TRIBE, PURSU-21 ANY ANT TO SUBDIVISION TWO-A OF THIS SECTION, TO A MUNICIPAL GOVERNMENT THAT 22 23 HOSTS A TRIBAL CASINO.

24 2-A. A MUNICIPAL GOVERNMENT THAT HOSTS A TRIBAL CASINO MAY RECEIVE 25 PAYMENTS DIRECTLY FROM A NATIVE AMERICAN NATION OR TRIBE; PROVIDED, 26 HOWEVER, THAT THE CHIEF FISCAL OFFICER OF THE MUNICIPAL GOVERNMENT

SHALL, WITHIN SEVEN DAYS OF THE RECEIPT OF SUCH PAYMENTS, NOTIFY THE 1 2 STATE COMPTROLLER THAT SUCH PAYMENTS HAVE BEEN RECEIVED BY SUCH MUNICI-3 PAL GOVERNMENT. ALL PAYMENTS RECEIVED BY A MUNICIPAL GOVERNMENT THAT 4 HOSTS A TRIBAL CASINO SHALL BE DEEMED TO HAVE BEEN MADE IN SATISFACTION 5 OF THE PROVISIONS OF THE TRIBAL-STATE COMPACT EXECUTED PURSUANT TO ARTI-6 CLE TWO OF THE EXECUTIVE LAW AND A TRIBAL-STATE COMPACT WITH THE ST. 7 REGIS MOHAWK TRIBE EXECUTED PURSUANT TO CHAPTER FIVE HUNDRED NINETY OF 8 THE LAWS OF TWO THOUSAND FOUR, AND SUCH PAYMENTS SHALL BE DEDUCTED FROM THOSE AMOUNTS THE STATE IS REQUIRED TO MAKE TO SUCH MUNICIPAL GOVERNMENT 9 10 PURSUANT TO SUBDIVISION THREE OR FOUR THIS SECTION.

11 S 3. Subdivision 2 of section 99-h of the state finance law, as 12 amended by section 1 of part V of chapter 59 of the laws of 2006, is 13 amended and a new subdivision 2-a is added to read as follows:

14 Such account shall consist of all revenues resulting from tribal-2. 15 state compacts executed pursuant to article two of the executive law and a tribal-state compact with the St. Regis Mohawk tribe executed pursuant 16 to chapter five hundred ninety of the laws of two thousand four, LESS 17 PAYMENTS MADE DIRECTLY BY A NATIVE AMERICAN NATION OR TRIBE, PURSU-18 ANY 19 ANT TO SUBDIVISION TWO-A OF THIS SECTION, TO A MUNICIPAL GOVERNMENT THAT 20 HOSTS A TRIBAL CASINO.

21 2-A. A MUNICIPAL GOVERNMENT THAT HOSTS A TRIBAL CASINO MAY RECEIVE PAYMENTS FROM A NATIVE AMERICAN NATION OR TRIBE; PROVIDED, HOWEVER, THAT 22 23 THE CHIEF FISCAL OFFICER OF THE MUNICIPAL GOVERNMENT SHALL, WITHIN SEVEN DAYS OF THE RECEIPT OF SUCH PAYMENTS, NOTIFY THE STATE COMPTROLLER THAT 24 25 SUCH PAYMENTS HAVE BEEN RECEIVED BY SUCH MUNICIPAL GOVERNMENT. ALL 26 PAYMENTS RECEIVED BY A MUNICIPAL GOVERNMENT THAT HOSTS A TRIBAL CASINO 27 SHALL BE DEEMED TO HAVE BEEN MADE IN SATISFACTION OF THE TRIBAL-STATE 28 EXECUTED PURSUANT TO ARTICLE TWO OF THE EXECUTIVE LAW AND A COMPACT 29 TRIBAL-STATE COMPACT WITH THE ST. REGIS MOHAWK TRIBE EXECUTED PURSUANT CHAPTER FIVE HUNDRED NINETY OF THE LAWS OF TWO THOUSAND FOUR, AND 30 TO SUCH PAYMENTS SHALL BE DEDUCTED FROM THOSE PAYMENTS THE STATE 31 IS 32 REQUIRED TO MAKE TO THE MUNICIPAL GOVERNMENT PURSUANT TO SUBDIVISION 33 THREE OF THIS SECTION.

34 S 4. This act shall take effect immediately; provided, however, that 35 the amendments to subdivision 2 of section 99-h of the state finance 36 law, made by section two of this act, shall not affect the expiration 37 and reversion of such section and the provisions of section two of this 38 act shall expire and be deemed repealed therewith; when upon such date 39 section three of this act shall take effect.
