AN ACT to amend the tax law and the state finance law, in relation to providing a tax checkoff box on personal income tax returns for gifts to the love your library fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The tax law is amended by adding a new section 630-b to
2 read as follows:
3 S 630-B. GIFT FOR LOVE YOUR LIBRARY FUND. EFFECTIVE FOR ANY TAX YEAR
4 COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND ELEVEN, AN INDIVIDUAL
5 IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE LOVE YOUR LIBRARY
6 FUND ESTABLISHED PURSUANT TO SECTION NINETY-NINE-L OF THE STATE FINANCE
7 LAW. SUCH CONTRIBUTION SHALL BE IN ANY WHOLE DOLLAR AMOUNT AND SHALL NOT
8 REDUCE THE AMOUNT OF STATE TAX OWED BY SUCH INDIVIDUAL. THE COMMISSIONER
9 SHALL INCLUDE SPACE ON THE PERSONAL INCOME TAX RETURN TO ENABLE A
10 TAXPAYER TO MAKE SUCH CONTRIBUTION. NOTWITHSTANDING ANY OTHER PROVISION
11 OF LAW ALL REVENUES COLLECTED PURSUANT TO THIS SECTION SHALL BE CREDITED
12 TO THE LOVE YOUR LIBRARY FUND AND USED ONLY FOR THOSE PURPOSES ENUMER-
13 ATED IN SECTION NINETY-NINE-L OF THE STATE FINANCE LAW.
14 S 2. Subdivision 2 of section 99-l of the state finance law, as added
15 by chapter 303 of the laws of 2004, is amended to read as follows:
16 2. Such fund shall consist of all revenues received by the department
17 of motor vehicles pursuant to section four hundred four-v of the vehicle
18 and traffic law, SECTION SIX HUNDRED THIRTY-B OF THE TAX LAW, and all
19 other moneys appropriated, credited, or transferred thereto from any
20 other fund or source pursuant to law.
21 S 3. This act shall take effect immediately.
