AN ACT to amend the agriculture and markets law, in relation to dogs engaged in hunting or training

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 122 of the agriculture and markets law is amended 2 by adding a new subdivision 3 to read as follows:
- 3. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISIONS ONE AND TWO OF SECTION OR SECTION ONE HUNDRED THIRTEEN OF THIS ARTICLE, A DOG THAT HAS 5 BEEN RELEASED FROM ITS CONFINEMENT FOR HUNTING OR TRAINING PURPOSES, WITH SECTION 11-0923 OF THE ENVIRONMENTAL CONSERVATION LAW, ACCORDANCE SHALL BE DEEMED TO BE UNDER THE REASONABLE CONTROL OF 8 TRAINER, AND NOT BE DEEMED TO BE RUNNING AT LARGE. A DOG CONTROL OFFI-9 CER, PEACE OFFICER ACTING PURSUANT TO HIS OR HER SPECIAL DUTIES 10 POLICE OFFICER, WHO IS AUTHORIZED BY A MUNICIPALITY TO ENFORCE ANY LOCAL LAW OR ORDINANCE RELATED TO THE KEEPING AND RUNNING AT LARGE OF DOGS AND 11 SEIZURE THEREOF, SHALL MAKE A FAIR AND REASONABLE EFFORT TO DETER-12 13 MINE WHETHER ANY DOG FOUND OR SUSPECTED OF RUNNING AT LARGE IS A DOG IN HUNTING, TRAINING OR OTHER ACTIVITIES IN ACCORDANCE WITH 14 SECTION 11-0923 OF THE ENVIRONMENTAL CONSERVATION LAW, AND IF SO DETER-15 OWNER OR TRAINER OF SUCH DOG WITH ANY 16 SHALL NOT CHARGE THE VIOLATION OF ANY LOCAL LAW OR ORDINANCE ENACTED PURSUANT TO THIS SECTION 17 18 RELATED TO THE KEEPING AND RUNNING AT LARGE OF DOGS.
- 19 S 2. This act shall take effect immediately.
