AN ACT to amend the civil service law, in relation to reduction of positions based upon seniority with an employer

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 80 of the civil service law is amended by adding a 2 new subdivision 1-e to read as follows:

3 NOTWITHSTANDING THE PROVISIONS OF SUBDIVISION ONE OF SWORN MEMBERS OF THE DIVISION OF CORRECTION OF THE SHER-SECTION, THEIFF'S DEPARTMENT OF THE COUNTY OF NASSAU SHALL BE SUBJECT TO THE FOLLOW-ING PROCEDURE. WHERE, BECAUSE OF ECONOMY, CONSOLIDATION OR ABOLITION OF 7 ACTIVITIES OR OTHERWISE, POSITIONS IN THE FUNCTIONS, CURTAILMENT OF COMPETITIVE CLASS ARE ABOLISHED OR REDUCED IN RANK OR SALARY GRADE, SUSPENSION OR DEMOTION, AS THE CASE MAY BE, AMONG INCUMBENTS HOLDING THE 9 SAME OR SIMILAR POSITIONS SHALL BE MADE IN THE INVERSE ORDER OF ORIGINAL 10 11 APPOINTMENT ON A PERMANENT BASIS IN THE GRADE OR TITLE IN THE SERVICE OF GOVERNMENTAL JURISDICTION IN WHICH SUCH ABOLITION OR REDUCTION OF 12 POSITIONS OCCURS, SUBJECT TO THE PROVISIONS OF SUBDIVISION SEVEN OF 13 SECTION EIGHT-FIVE OF THIS CHAPTER. NOTWITHSTANDING THE PROVISIONS OF 14 THIS SUBDIVISION, HOWEVER, UPON THE ABOLITION OR REDUCTION OF POSITIONS, 15 16 THOSE EMPLOYEES WHO HAVE NOT COMPLETED THEIR PROBATIONARY SERVICE BE SUSPENDED OR DEMOTED, AS THE CASE MAY BE, BEFORE ANY PERMANENT INCUM-17 BENTS, AND AMONG SUCH PROBATIONARY EMPLOYEES THE ORDER OF SUSPENSION OR 18

DEMOTION SHALL BE DETERMINED AS IF SUCH EMPLOYEES WERE PERMANENT
