AN ACT to amend the penal law, in relation to assault on district attorneys and assistant district attorneys

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 120.05 of the penal law, as sepa-2 rately amended by chapters 318 and 345 of the laws of 2010, is amended 3 to read as follows:

4 With intent to prevent a peace officer, a police officer, DISTRICT 3. 5 ATTORNEY, ASSISTANT DISTRICT ATTORNEY, registered nurse, licensed practical nurse, sanitation enforcement agent, a firefighter, including a 6 7 firefighter acting as a paramedic or emergency medical technician admin-8 istering first aid in the course of performance of duty as such fire-9 fighter, an emergency medical service paramedic or emergency medical service technician, or medical or related personnel in a hospital emer-10 11 gency department, a city marshal, a traffic enforcement officer or traffic enforcement agent, from performing a lawful duty, by means including 12 releasing or failing to control an animal under circumstances evincing 13 14 the actor's intent that the animal obstruct the lawful activity of such 15 peace officer, police officer, DISTRICT ATTORNEY, ASSISTANT DISTRICT 16 ATTORNEY, registered nurse, licensed practical nurse, sanitation 17 enforcement agent, firefighter, paramedic, technician, city marshal, traffic enforcement officer or traffic enforcement agent, he or 18 she 19 causes physical injury to such peace officer, police officer, DISTRICT 20 ATTORNEY, ASSISTANT DISTRICT ATTORNEY, registered nurse, licensed prac-21 tical nurse, sanitation enforcement agent, firefighter, paramedic, tech-22 nician or medical or related personnel in a hospital emergency depart-23 ment, city marshal, traffic enforcement officer or traffic enforcement 24 agent; or

25 S 2. Subdivision 11 of section 120.05 of the penal law, as separately 26 amended by chapters 318 and 345 of the laws of 2010, is amended to read 27 as follows:

With intent to cause physical injury to a train operator, ticket 1 11. 2 inspector, conductor, signalperson, bus operator or station agent 3 employed by any transit agency, authority or company, public or private, 4 whose operation is authorized by New York state or any of its political subdivisions, a city marshal, a traffic enforcement officer, traffic enforcement agent, DISTRICT ATTORNEY, ASSISTANT DISTRICT ATTORNEY or 5 б 7 sanitation enforcement agent, registered nurse or licensed practical 8 nurse he or she causes physical injury to such train operator, ticket 9 inspector, conductor, signalperson, bus operator or station agent, city 10 marshal, traffic enforcement officer, traffic enforcement agent, 11 DISTRICT ATTORNEY, ASSISTANT DISTRICT ATTORNEY, registered nurse [or], 12 licensed practical nurse or sanitation enforcement agent, while such 13 employee is performing an assigned duty on, or directly related to, the 14 operation of a train or bus, or such city marshal, traffic enforcement officer, traffic enforcement agent, DISTRICT ATTORNEY, DISTRICT ATTORNEY, registered nurse [or], licensed practical 15 ASSISTANT 16 nurse or sanitation enforcement agent is performing an assigned duty. 17

18 S 3. This act shall take effect on the one hundred eightieth day after 19 it shall have become a law.
