AN ACT to amend the penal law, in relation to the commission of certain weapons offenses on school grounds

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 265.00 of the penal law is amended by adding a new 2 subdivision 24 to read as follows:

3 24. "SCHOOL GROUNDS" MEANS (A) ANY AREA IN, ON OR WITHIN ANY BUILDING, 4 STRUCTURE, ATHLETIC PLAYING FIELD, PLAYGROUND OR LAND CONTAINED WITHIN THE REAL PROPERTY BOUNDARY LINE OF A PUBLIC OR PRIVATE ELEMENTARY, PARO-5 6 CHIAL, INTERMEDIATE, JUNIOR HIGH, VOCATIONAL, OR HIGH SCHOOL, OR (B) ANY 7 AREA ACCESSIBLE TO THE PUBLIC LOCATED WITHIN ONE THOUSAND FEET OF THE REAL PROPERTY BOUNDARY LINE COMPRISING ANY SUCH 8 SCHOOL OR ANY PARKED 9 AUTOMOBILE OR OTHER PARKED VEHICLE LOCATED WITHIN ONE THOUSAND FEET OF 10 THE REAL PROPERTY BOUNDARY LINE COMPRISING ANY SUCH SCHOOL. FOR THE THIS SECTION AN "AREA ACCESSIBLE TO THE PUBLIC" SHALL MEAN 11 PURPOSES OF 12 SIDEWALKS, STREETS, PARKING LOTS, PARKS, PLAYGROUNDS, STORES AND RESTAU-13 RANTS.

14 S 2. Section 265.02 of the penal law is amended by adding a new subdi-15 vision 9 to read as follows:

16 (9) HE OR SHE COMMITS THE CRIME OF CRIMINAL POSSESSION OF A WEAPON IN 17 THE FOURTH DEGREE AS DEFINED IN SECTION 265.01 OF THIS ARTICLE AND SUCH 18 CRIME TAKES PLACE UPON SCHOOL GROUNDS.

19 S 3. Section 265.03 of the penal law, as amended by chapter 742 of the 20 laws of 2006, subdivisions 1 and 3 as amended by chapter 745 of the laws 21 of 2006, is amended to read as follows:

22 S 265.03 Criminal possession of a weapon in the second degree.

23 A person is guilty of criminal possession of a weapon in the second 24 degree when:

(1) with intent to use the same unlawfully against another, such 1 2 person: 3 (a) possesses a machine-gun; or 4 (b) possesses a loaded firearm; or 5 (c) possesses a disguised gun; or 6 (D) COMMITS THE CRIME OF CRIMINAL POSSESSION OF A WEAPON IN THE THIRD 7 DEGREE AS DEFINED IN SUBDIVISION ONE, TWO, THREE, FIVE, SIX, SEVEN, OR SECTION 265.02 OF THIS ARTICLE AND SUCH CRIME TAKES PLACE ON 8 EIGHT OF 9 SCHOOL GROUNDS; OR 10 (2) such person possesses five or more firearms; or (3) such person possesses any loaded firearm. Section 265.04 of the penal law, as amended by chapter 764 of the laws of 2005, is amended to read as follows: 18 19 S 265.04 Criminal possession of a weapon in the first degree. 20 A person is guilty of criminal possession of a weapon in the first 21 degree when such person: 22 (1) possesses any explosive substance with intent to use the same 23 unlawfully against the person or property of another; or 24 (2) possesses ten or more firearms[.]; OR 25 (3) COMMITS THE CRIME OF CRIMINAL POSSESSION OF A WEAPON IN THE SECOND 26 DEGREE AS DEFINED IN SUBDIVISION ONE OF SECTION 265.03 OF THIS ARTICLE AND SUCH CRIME TAKES PLACE ON SCHOOL GROUNDS. 27 28 Criminal possession of a weapon in the first degree is a class B felo-29 ny. S 5. Section 265.12 of the penal law, as amended by chapter 764 of the 30 laws of 2005, is amended to read as follows: 31 32 S 265.12 Criminal sale of a firearm in the second degree. 33 A person is guilty of criminal sale of a firearm in the second degree 34 when such person: (1) unlawfully sells, exchanges, gives or disposes of to another five 35 or more firearms; or 36 37 (2) unlawfully sells, exchanges, gives or disposes of to another 38 person or persons a total of five or more firearms in a period of not more than one year[.]; OR 39 (3) COMMITS THE CRIME OF CRIMINAL SALE OF A FIREARM 40 IN THE THIRD DEGREE AS DEFINED IN SUBDIVISION ONE OR TWO OF SECTION 265.11 OF THIS 41 ARTICLE AND SUCH CRIME TAKES PLACE ON SCHOOL GROUNDS. 42 43 Criminal sale of a firearm in the second degree is a class C felony. 44 S 6. This act shall take effect on the first of November next succeed-45 ing the date on which it shall have become a law.
