AN ACT to require a workgroup to investigate and report about licensing and the difficulties encountered by military spouses (Part A); to amend the education law, in relation to the authority of the state to certify persons to teach who are not graduates of teacher education programs (Part B); to amend the education law, in relation to adopting the interstate nursing licensure compact (Part C); to amend the education law, the general business law, the insurance law and the real property law, in relation to licensing of military spouses with out-of-state licenses in equivalent occupations (Part D)

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. This act enacts into law components of legislation relating to the "Military Spouse Act of 2011". Each component is wholly contained within a Part identified as Parts A through D. The effective date for each particular provision contained within such Part is set forth in the last section of such Part. Any provision in any section contained within a Part, including the effective date of the Part, which makes reference to a section "of this act", when used in connection with that particular component, shall be deemed to mean and refer to the corresponding section of the Part in which it is found. Section three of this act sets forth the general effective date of this act.

reserves transfer teaching certificates or professional certifications to their new home state.

- S 2. The department of labor and the division of veterans' affairs shall establish a workgroup to identify licensing requirements for workforce shortage areas and to study, in conjunction with the relevant licensing entities, whether comparable military training could substitute for current licensing requirements, and manners in which state agencies, regulatory bodies and licensing entities can adopt procedures sensitive to the difficulties encountered by military spouses. The workgroup shall submit any findings, including any recommendations for legislative action to the governor, the temporary president of the 11 senate and the speaker of the assembly by January 1, 2013. 12
- S 3. This act shall take effect immediately. 13

14 PART B

Section 1. Subdivision 1 of section 3006 of the education is amended by adding a new paragraph f to read as follows:

- F. AN ALTERNATIVE PLACEMENT CERTIFICATE TO ANY PERSON:
- (1) WHO MEETS THE ELIGIBILITY REQUIREMENTS OF THE TROOPS FOR TEACHERS PROGRAM OPERATED BY THE UNITED STATES DEPARTMENT OF DEFENSE AND THE DEFENSE ACTIVITY FOR NON-TRADITIONAL EDUCATION SUPPORT ORGANIZA-TION; AND
- (2) WHO MEETS THE REQUIREMENTS SET FORTH INSECTION THREE THOUSAND EIGHT-A OF THIS ARTICLE.
- The education law is amended by adding a new section 3008-a to read as follows:
- S 3008-A. ALTERNATIVE TEACHING CERTIFICATION. 1. THECOMMISSIONER SHALL ISSUE A ONE-YEAR, NONRENEWABLE MIDDLE OR SECONDARY LEVEL ALTERNA-TIVE TEACHING CERTIFICATION TO TEACH TO ANY PERSON WHO HAS CERTIFICATION BY AN ALTERNATIVE TEACHER CERTIFICATION ORGANIZATION AS SET FORTH IN SUBDIVISION THREE OF THIS SECTION AND HAS MET THE REQUIRE-MENTS OF SECTION THREE THOUSAND FOUR-B OF THIS ARTICLE.
- NOTWITHSTANDING ANY PROVISION OF LAW TO THE CONTRARY, TEACHERS ISSUED AN ALTERNATIVE TEACHING CERTIFICATION PURSUANT TO THIS SHALL PARTICIPATE IN THE MENTORING PROGRAM PROVIDED BY THE ALTERNATIVE TEACHER CERTIFICATION ORGANIZATION AS SET FORTH IN SUBDIVISION THREE SECTION. UPON SUCCESSFUL COMPLETION OF SUCH MENTORING PROGRAM, COMPLETION OF THE APPLICATION AND PAYMENT OF THE CERTIFICATION SET FORTH IN SECTION THREE THOUSAND SIX OF THIS ARTICLE OR AS PRESCRIBED THE COMMISSIONER, THE COMMISSIONER SHALL ISSUE THE TEACHER A CERTIF-ICATE TO TEACH.
- 3. FOR PURPOSES OF THIS SECTION, THE COMMISSIONER SHALL IDENTIFY TEACHER CERTIFICATION ORGANIZATION THAT WAS FOUNDED WITH GRANT FUNDING FROM THE UNITED STATES DEPARTMENT OF EDUCATION AND DEVELOPED PURSUANT TO THE PASSPORT TO TEACHING PROGRAM ADMINISTERED BY THE AMERICAN BOARD FOR CERTIFICATION OF TEACHER EXCELLENCE. IZATION SHALL REQUIRE CANDIDATES TO HOLD A BACHELOR'S DEGREE, PASS A PROFESSIONAL TEACHING KNOWLEDGE EXAM, PASS A SUBJECT AREA EXAM AND PASS BACKGROUND CHECK. THE ORGANIZATION SHALL PROVIDE CANDIDATES WITH ACCESS TO WORKSHOPS, AN EXPERIENCED TEACHER-ADVISOR AND OPTIONAL ACCESS COMPREHENSIVE SUBJECT MATTER REFRESHER COURSES. THE ORGANIZATION SHALL ALSO PROVIDE AN INTENSIVE MENTORING AND INDUCTION PROGRAM.
- 52 S 3. This act shall take effect on the ninetieth day after it 53 have become a law; provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary 54

for the implementation of this act on its effective date are authorized and directed to be made and completed on or before such effective date.

S 6911. INTERSTATE NURSE LICENSURE COMPACT. 1. THE INTERSTATE NURSE COMPACT IS HEREBY ENACTED INTO LAW AND ENTERED INTO WITH ALL JURISDICTIONS LEGALLY JOINING THEREIN IN THE FORM SUBSTANTIALLY 9 FOLLOWS:

10 INTERSTATE NURSE LICENSURE COMPACT 11 ARTICLE I. 12

FINDINGS AND DECLARATION OF PURPOSE

- (A) THE PARTY STATES FIND THAT:
- THE HEALTH AND SAFETY OF THE PUBLIC ARE AFFECTED BY THE DEGREE OF 14 15 COMPLIANCE WITH AND THE EFFECTIVENESS OF ENFORCEMENT ACTIVITIES TO STATE NURSE LICENSURE LAWS; 16
 - VIOLATIONS OF NURSE LICENSURE AND OTHER LAWS REGULATING THE PRAC-TICE OF NURSING MAY RESULT IN INJURY OR HARM TO THE PUBLIC;
 - (3) THE EXPANDED MOBILITY OF NURSES AND THE USE OF ADVANCED COMMUNI-CATION TECHNOLOGIES AS PART OF OUR NATION'S HEALTHCARE DELIVERY SYSTEM REQUIRE GREATER COORDINATION AND COOPERATION AMONG STATES IN OF NURSE LICENSURE AND REGULATION;
 - NEW PRACTICE MODALITIES AND TECHNOLOGY MAKE COMPLIANCE WITH INDI-VIDUAL STATE NURSE LICENSURE LAWS DIFFICULT AND COMPLEX; AND
 - (5) THE CURRENT SYSTEM OF DUPLICATIVE LICENSURE FOR NURSES PRACTICING MULTIPLE STATES IS CUMBERSOME AND REDUNDANT TO BOTH NURSES AND STATES.
 - (B) THE GENERAL PURPOSES OF THIS COMPACT ARE TO:
 - (1) FACILITATE THE STATES' RESPONSIBILITY TO PROTECT HEALTH AND SAFETY;
 - ENSURE AND ENCOURAGE THE COOPERATION OF PARTY STATES IN THE AREAS OF NURSE LICENSURE AND REGULATION;
 - (3) FACILITATE THE EXCHANGE OF INFORMATION BETWEEN PARTY STATES IN THE AREAS OF NURSE REGULATION, INVESTIGATION, AND ADVERSE ACTIONS;
 - (4) PROMOTE COMPLIANCE WITH THE LAWS GOVERNING THE PRACTICE OF NURSING IN EACH JURISDICTION; AND
- (5) INVEST ALL PARTY 37 STATES WITH THE AUTHORITY TO HOLD NURSE 38 FOR MEETING ALL STATE PRACTICE LAWS IN THE STATE IN WHICH ACCOUNTABLE 39 THE PATIENT IS LOCATED AT THE TIME CARE IS RENDERED THROUGH THE MUTUAL RECOGNITION OF PARTY STATE LICENSES.

41 ARTICLE II. 42 **DEFINITIONS**

AS USED IN THIS COMPACT:

- (A) "ADVERSE ACTION" MEANS A HOME OR REMOTE STATE ACTION.
- 45 (B) "ALTERNATIVE PROGRAM" MEANS A VOLUNTARY, NON-DISCIPLINARY MONITOR-46 ING PROGRAM APPROVED BY A NURSE LICENSING BOARD.
- "COORDINATED LICENSURE INFORMATION SYSTEM" MEANS AN INTEGRATED 47 48 PROCESS FOR COLLECTING, STORING, AND SHARING INFORMATION ON NURSE LICEN-SURE AND ENFORCEMENT ACTIVITIES RELATED TO NURSE LICENSURE LAWS, 49

1 IS ADMINISTERED BY A NON-PROFIT ORGANIZATION COMPOSED OF AND CONTROLLED 2 BY STATE NURSE LICENSING BOARDS.

- (D) "CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION" MEANS:
- (1) INVESTIGATIVE INFORMATION THAT A LICENSING BOARD, AFTER A PRELIMINARY INQUIRY THAT INCLUDES NOTIFICATION AND AN OPPORTUNITY FOR THE NURSE TO RESPOND IF REQUIRED BY STATE LAW, HAS REASON TO BELIEVE IS NOT GROUNDLESS AND, IF PROVED TRUE, WOULD INDICATE MORE THAN A MINOR INFRACTION; OR
- (2) INVESTIGATIVE INFORMATION THAT INDICATES THAT THE NURSE REPRESENTS AN IMMEDIATE THREAT TO PUBLIC HEALTH AND SAFETY REGARDLESS OF WHETHER THE NURSE HAS BEEN NOTIFIED AND HAD AN OPPORTUNITY TO RESPOND.
- (E) "HOME STATE" MEANS THE PARTY STATE WHICH IS THE NURSE'S PRIMARY STATE OF RESIDENCE.
- (F) "HOME STATE ACTION" MEANS ANY ADMINISTRATIVE, CIVIL, EQUITABLE OR CRIMINAL ACTION PERMITTED BY THE HOME STATE'S LAWS WHICH ARE IMPOSED ON A NURSE BY THE HOME STATE'S LICENSING BOARD OR OTHER AUTHORITY INCLUDING ACTIONS AGAINST AN INDIVIDUAL'S LICENSE SUCH AS: REVOCATION, SUSPENSION, PROBATION OR ANY OTHER ACTION WHICH AFFECTS THE NURSE'S AUTHORIZATION TO PRACTICE.
- (G) "LICENSING BOARD" MEANS A PARTY STATE'S REGULATORY BODY RESPONSIBLE FOR ISSUING NURSE LICENSES.
- (H) "MULTISTATE LICENSURE PRIVILEGE" MEANS CURRENT, OFFICIAL AUTHORITY FROM A REMOTE STATE PERMITTING THE PRACTICE OF NURSING AS EITHER A REGISTERED NURSE OR A LICENSED PRACTICAL/VOCATIONAL NURSE IN SUCH PARTY STATE. ALL PARTY STATES HAVE THE AUTHORITY, IN ACCORDANCE WITH EXISTING STATE DUE PROCESS LAW, TO TAKE ACTIONS AGAINST THE NURSE'S PRIVILEGE SUCH AS: REVOCATION, SUSPENSION, PROBATION OR ANY OTHER ACTION WHICH AFFECTS A NURSE'S AUTHORIZATION TO PRACTICE.
- (I) "NURSE" MEANS A REGISTERED NURSE OR LICENSED PRACTICAL/VOCATIONAL NURSE, AS THOSE TERMS ARE DEFINED BY EACH PARTY'S STATE PRACTICE LAWS.
 - (J) "PARTY STATE" MEANS ANY STATE THAT HAS ADOPTED THIS COMPACT.
 - (K) "REMOTE STATE" MEANS A PARTY STATE, OTHER THAN THE HOME STATE,
- (1) WHERE THE PATIENT IS LOCATED AT THE TIME NURSING CARE IS PROVIDED, $\ensuremath{\mathsf{OR}}$
- (2) IN THE CASE OF THE PRACTICE OF NURSING NOT INVOLVING A PATIENT, IN SUCH PARTY STATE WHERE THE RECIPIENT OF NURSING PRACTICE IS LOCATED.
 - (L) "REMOTE STATE ACTION" MEANS
- (1) ANY ADMINISTRATIVE, CIVIL, EQUITABLE OR CRIMINAL ACTION PERMITTED BY A REMOTE STATE'S LAWS WHICH ARE IMPOSED ON A NURSE BY THE REMOTE STATE'S LICENSING BOARD OR OTHER AUTHORITY INCLUDING ACTIONS AGAINST AN INDIVIDUAL'S MULTISTATE LICENSURE PRIVILEGE TO PRACTICE IN THE REMOTE STATE, AND
- (2) CEASE AND DESIST AND OTHER INJUNCTIVE OR EQUITABLE ORDERS ISSUED BY REMOTE STATES OR THE LICENSING BOARDS THEREOF.
- (M) "STATE" MEANS A STATE, TERRITORY OR POSSESSION OF THE UNITED STATES, THE DISTRICT OF COLUMBIA OR THE COMMONWEALTH OF PUERTO RICO.
- 47 (N) "STATE PRACTICE LAWS" MEANS THOSE INDIVIDUAL PARTY STATE'S LAWS
 48 AND REGULATIONS THAT GOVERN THE PRACTICE OF NURSING, DEFINE THE SCOPE OF
 49 NURSING PRACTICE, AND CREATE THE METHODS AND GROUNDS FOR IMPOSING DISCI50 PLINE. "STATE PRACTICE LAWS" DOES NOT INCLUDE THE INITIAL QUALIFICATIONS
 51 FOR LICENSURE OR REQUIREMENTS NECESSARY TO OBTAIN AND RETAIN A LICENSE,
 52 EXCEPT FOR QUALIFICATIONS OR REQUIREMENTS OF THE HOME STATE.

(A) A LICENSE TO PRACTICE REGISTERED NURSING ISSUED BY A HOME STATE TO A RESIDENT IN THAT STATE WILL BE RECOGNIZED BY EACH PARTY STATE AS AUTHORIZING A MULTISTATE LICENSURE PRIVILEGE TO PRACTICE AS A REGISTERED NURSE IN SUCH PARTY STATE. Α LICENSE TOPRACTICE PRACTICAL/VOCATIONAL NURSING ISSUED BY A HOME STATE TO A RESIDENT IN THAT STATE WILL BE RECOGNIZED BY EACH PARTY STATE AS AUTHORIZING A LICENSURE PRIVILEGE TO PRACTICE AS A PRACTICAL/VOCATIONAL NURSE IN SUCH PARTY STATE. IN ORDER TO OBTAIN OR RETAIN A LICENSE, AN APPLICANT MUST MEET THE HOME STATE'S QUALIFICATIONS FOR LICENSURE AND LICENSE RENEWAL AS WELL AS ALL OTHER APPLICABLE STATE

- (B) PARTY STATES MAY, IN ACCORDANCE WITH STATE DUE PROCESS LAWS, LIMIT OR REVOKE THE MULTISTATE LICENSURE PRIVILEGE OF ANY NURSE TO PRACTICE IN THEIR STATE AND MAY TAKE ANY OTHER ACTIONS UNDER THEIR APPLICABLE STATE LAWS NECESSARY TO PROTECT THE HEALTH AND SAFETY OF THEIR CITIZENS. IF A PARTY STATE TAKES SUCH ACTION, IT SHALL PROMPTLY NOTIFY THE ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM. THE ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM SHALL PROMPTLY NOTIFY THE HOME STATE OF ANY SUCH ACTIONS BY REMOTE STATES.
- (C) EVERY NURSE PRACTICING IN A PARTY STATE MUST COMPLY WITH THE STATE PRACTICE LAWS OF THE STATE IN WHICH THE PATIENT IS LOCATED AT THE TIME CARE IS RENDERED. IN ADDITION, THE PRACTICE OF NURSING IS NOT LIMITED TO PATIENT CARE, BUT SHALL INCLUDE ALL NURSING PRACTICE AS DEFINED BY THE STATE PRACTICE LAWS OF A PARTY STATE. THE PRACTICE OF NURSING WILL SUBJECT A NURSE TO THE JURISDICTION OF THE NURSE LICENSING BOARD AND THE COURTS, AS WELL AS THE LAWS, IN THAT PARTY STATE.
- (D) THIS COMPACT DOES NOT AFFECT ADDITIONAL REQUIREMENTS IMPOSED BY STATES FOR ADVANCED PRACTICE REGISTERED NURSING. HOWEVER, A MULTISTATE LICENSURE PRIVILEGE TO PRACTICE REGISTERED NURSING GRANTED BY A PARTY STATE SHALL BE RECOGNIZED BY OTHER PARTY STATES AS A LICENSE TO PRACTICE REGISTERED NURSING IF ONE IS REQUIRED BY STATE LAW AS A PRECONDITION FOR QUALIFYING FOR ADVANCED PRACTICE REGISTERED NURSE AUTHORIZATION.
- (E) INDIVIDUALS NOT RESIDING IN A PARTY STATE SHALL CONTINUE TO BE ABLE TO APPLY FOR NURSE LICENSURE AS PROVIDED FOR UNDER THE LAWS OF EACH PARTY STATE. HOWEVER, THE LICENSE GRANTED TO THESE INDIVIDUALS WILL NOT BE RECOGNIZED AS GRANTING THE PRIVILEGE TO PRACTICE NURSING IN ANY OTHER PARTY STATE UNLESS EXPLICITLY AGREED TO BY THAT PARTY STATE.

38 ARTICLE IV. 39 APPLICATIONS FOR LICENSURE IN A PARTY STATE

- (A) UPON APPLICATION FOR A LICENSE, THE LICENSING BOARD IN A PARTY STATE SHALL ASCERTAIN, THROUGH THE COORDINATED LICENSURE INFORMATION SYSTEM, WHETHER THE APPLICANT HAS EVER HELD, OR IS THE HOLDER OF, A LICENSE ISSUED BY ANY OTHER STATE, WHETHER THERE ARE ANY RESTRICTIONS ON THE MULTISTATE LICENSURE PRIVILEGE, AND WHETHER ANY OTHER ADVERSE ACTION BY ANY STATE HAS BEEN TAKEN AGAINST THE LICENSE.
- (B) A NURSE IN A PARTY STATE SHALL HOLD LICENSURE IN ONLY ONE PARTY STATE AT A TIME ISSUED BY THE HOME STATE.
- 48 (C) A NURSE WHO INTENDS TO CHANGE PRIMARY STATE OF RESIDENCE MAY APPLY
 49 FOR LICENSURE IN THE NEW HOME STATE IN ADVANCE OF SUCH CHANGE. HOWEVER,
 50 NEW LICENSES WILL NOT BE ISSUED BY A PARTY STATE UNTIL AFTER A NURSE
 51 PROVIDES EVIDENCE OF CHANGE IN PRIMARY STATE OF RESIDENCE SATISFACTORY
 52 TO THE NEW HOME STATE'S LICENSING BOARD.
 - (D) WHEN A NURSE CHANGES PRIMARY STATE OF RESIDENCE BY:

(1) MOVING BETWEEN TWO PARTY STATES, AND OBTAINS A LICENSE FROM THE NEW HOME STATE, THE LICENSE FROM THE FORMER HOME STATE IS NO LONGER VALID;

- (2) MOVING FROM A NON-PARTY STATE TO A PARTY STATE, AND OBTAINS A LICENSE FROM THE NEW HOME STATE, THE INDIVIDUAL STATE LICENSE ISSUED BY THE NON-PARTY STATE IS NOT AFFECTED AND WILL REMAIN IN FULL FORCE IF SO PROVIDED BY THE LAWS OF THE NON-PARTY STATE;
- 8 (3) MOVING FROM A PARTY STATE TO A NON-PARTY STATE, THE LICENSE ISSUED 9 BY THE PRIOR HOME STATE CONVERTS TO AN INDIVIDUAL STATE LICENSE, VALID 10 ONLY IN THE FORMER HOME STATE, WITHOUT THE MULTISTATE LICENSURE PRIVI- 11 LEGE TO PRACTICE IN OTHER PARTY STATES.

12 ARTICLE V. 13 ADVERSE ACTIONS

14 IN ADDITION TO THE GENERAL PROVISIONS DESCRIBED IN ARTICLE III, THE 15 FOLLOWING PROVISIONS APPLY:

- (A) THE LICENSING BOARD OF A REMOTE STATE SHALL PROMPTLY REPORT TO THE ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM ANY REMOTE STATE ACTIONS INCLUDING THE FACTUAL AND LEGAL BASIS FOR SUCH ACTION, IF KNOWN. THE LICENSING BOARD OF A REMOTE STATE SHALL ALSO PROMPTLY REPORT ANY SIGNIFICANT CURRENT INVESTIGATIVE INFORMATION YET TO RESULT IN A REMOTE STATE ACTION. THE ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM SHALL PROMPTLY NOTIFY THE HOME STATE OF ANY SUCH REPORTS.
- (B) THE LICENSING BOARD OF A PARTY STATE SHALL HAVE THE AUTHORITY TO COMPLETE ANY PENDING INVESTIGATIONS FOR A NURSE WHO CHANGES PRIMARY STATE OF RESIDENCE DURING THE COURSE OF SUCH INVESTIGATIONS. IT SHALL ALSO HAVE THE AUTHORITY TO TAKE APPROPRIATE ACTION OR ACTIONS, AND SHALL PROMPTLY REPORT THE CONCLUSIONS OF SUCH INVESTIGATIONS TO THE ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM. THE ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM SHALL PROMPTLY NOTIFY THE NEW HOME STATE OF ANY SUCH ACTIONS.
- (C) A REMOTE STATE MAY TAKE ADVERSE ACTION AFFECTING THE MULTISTATE LICENSURE PRIVILEGE TO PRACTICE WITHIN THAT PARTY STATE. HOWEVER, ONLY THE HOME STATE SHALL HAVE THE POWER TO IMPOSE ADVERSE ACTION AGAINST THE LICENSE ISSUED BY THE HOME STATE.
- (D) FOR PURPOSES OF IMPOSING ADVERSE ACTION, THE LICENSING BOARD OF THE HOME STATE SHALL GIVE THE SAME PRIORITY AND EFFECT TO REPORTED CONDUCT RECEIVED FROM A REMOTE STATE AS IT WOULD IF SUCH CONDUCT HAD OCCURRED WITHIN THE HOME STATE. IN SO DOING, IT SHALL APPLY ITS OWN STATE LAWS TO DETERMINE APPROPRIATE ACTION.
- (E) THE HOME STATE MAY TAKE ADVERSE ACTION BASED ON THE FACTUAL FIND-INGS OF THE REMOTE STATE, SO LONG AS EACH STATE FOLLOWS ITS OWN PROCEDURES FOR IMPOSING SUCH ADVERSE ACTION.
- (F) NOTHING IN THIS COMPACT SHALL OVERRIDE A PARTY STATE'S DECISION THAT PARTICIPATION IN AN ALTERNATIVE PROGRAM MAY BE USED IN LIEU OF LICENSURE ACTION AND THAT SUCH PARTICIPATION SHALL REMAIN NON-PUBLIC IF REQUIRED BY THE PARTY STATE'S LAWS. PARTY STATES MUST REQUIRE NURSES WHO ENTER ANY ALTERNATIVE PROGRAMS TO AGREE NOT TO PRACTICE IN ANY OTHER PARTY STATE DURING THE TERM OF THE ALTERNATIVE PROGRAM WITHOUT PRIOR AUTHORIZATION FROM SUCH OTHER PARTY STATE.

- (C) CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION SHALL BE TRANSMITTED THROUGH THE COORDINATED LICENSURE INFORMATION SYSTEM ONLY TO PARTY STATE LICENSING BOARDS.
- NOTWITHSTANDING ANY OTHER PROVISION OF LAW, ALL PARTY STATES' LICENSING BOARDS CONTRIBUTING INFORMATION TO THE COORDINATED LICENSURE INFORMATION SYSTEM MAY DESIGNATE INFORMATION THAT MAY NOT BE SHARED WITH NON-PARTY STATES OR DISCLOSED TO OTHER ENTITIES OR INDIVIDUALS WITHOUT THE EXPRESS PERMISSION OF THE CONTRIBUTING STATE.
