AN ACT to amend the penal law, in relation to computer tampering

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. The closing paragraph of section 156.20 of the penal law, as amended by chapter 558 of the laws of 2006, is amended to read as follows:
- 4 Computer tampering in the fourth degree is a class [A misdemeanor] E 5 FELONY.
- 6 S 2. The closing paragraph of section 156.25 of the penal law, as 7 amended by chapter 89 of the laws of 1993, is amended to read as 8 follows:
 - Computer tampering in the third degree is a class [E] D felony.

- 10 S 3. The closing paragraph of section 156.26 of the penal law, as 11 amended by chapter 590 of the laws of 2008, is amended to read as 12 follows:
- 13 Computer tampering in the second degree is a class [D] C felony.
- 14 S 4. The closing paragraph of section 156.27 of the penal law, as 15 added by chapter 89 of the laws of 1993, is amended to read as follows:
- 16 Computer tampering in the first degree is a class [C] B felony.
- 17 S 5. This act shall take effect on the first of November next succeed-18 ing the date on which it shall have become a law.
