AN ACT to amend the agriculture and markets law, in relation to requiring warning labels on food products which contain sodium benzoate

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The agriculture and markets law is amended by adding a new  
2 section 214-o to read as follows:  
3 S 214-O. WARNING LABELS ON FOOD PRODUCTS CONTAINING SODIUM BENZOATE.  
4 1. NOTWITHSTANDING ANY INCONSISTENT PROVISION OF SECTION ONE HUNDRED  
5 NINETY-NINE-B OF THIS ARTICLE, IF ANY PERSON, FIRM, CORPORATION, PART-  
6 NERSHIP, LIMITED LIABILITY COMPANY, ASSOCIATION OR ANY OTHER BUSINESS  
7 ASSOCIATION SELLS OR DISPLAYS FOR RETAIL SALE ANY FOOD PRODUCT CONTAIN-  
8 ING THE ARTIFICIAL FOOD COLORING AND PRESERVATIVE SODIUM BENZOATE, THE  
9 PACKAGING OF SUCH FOOD SHALL BEAR A WARNING LABEL AS PRESCRIBED IN THIS  
10 SECTION WHICH SHALL BE PRINTED THEREON OR ATTACHED THERETO. SUCH WARNING  
11 LABEL SHALL BE IN LETTERS NOT LESS THAN EIGHT POINT TYPE AND SHALL  
12 APPEAR IN A BLACK BOX ON THE PACKAGE, AND SHALL CONTAIN THE FOLLOWING  
13 STATEMENT: "WARNING: THE ARTIFICIAL FOOD COLORINGS AND/OR PRESERVATIVES  
14 USED TO PROCESS THIS FOOD PRODUCT COULD POSE A SERIOUS HEALTH HAZARD TO  
15 CHILDREN. PLEASE USE CAUTION."  
16 2. ANY PERSON, FIRM, CORPORATION, PARTNERSHIP, LIMITED LIABILITY  
17 COMPANY, ASSOCIATION OR ANY OTHER BUSINESS ASSOCIATION, OR ITS OFFICERS  
18 OR AGENTS WHO OR WHICH VIOLATE ANY OF THE PROVISIONS OF THIS SECTION OR  
19 ANY RULES OR REGULATIONS PROMULGATED PURSUANT TO THIS SECTION SHALL BE  
20 LIABLE FOR A CIVIL PENALTY OF TEN THOUSAND DOLLARS PER EACH FOOD PRODUCT  
21 WHICH VIOLATES THE PROVISIONS OF THIS SECTION.

1 3. THE COMMISSIONER SHALL HAVE THE AUTHORITY AND POWER TO PRESCRIBE BY  
2 REGULATIONS THE LABELING OF THE FOOD PRODUCTS IN SUBDIVISION ONE OF THIS  
3 SECTION WHICH ARE NOT SOLD BY PACKAGE OR CONTAINER.

4 S 2. This act shall take effect on the one hundred twentieth day after  
5 it shall have become a law. Provided that the commissioner of agricul-  
6 ture and markets is authorized and directed to promulgate any rules or  
7 regulations necessary for the timely implementation of this act before  
8 such effective date.
