AN ACT to provide for the creation of the Stephentown Memorial library district in the county of Rensselaer; and to amend chapter 672 of the laws of 1993, amending the public authorities law relating to the construction and financing of facilities for certain public libraries, in relation to including the Stephentown Memorial library district within the provisions of such chapter

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Notwithstanding Section 1. Creation of library district. 1 the 2 provisions of any general, special or local law to the contrary, there may be created pursuant to this act in the county of Rensselaer, a public library district which shall include all of the town of Stephen-3 4 5 town, and shall be known as the "Stephentown Memorial library district". 6 S 2. Election. (a) The Stephentown Memorial library district shall not come into existence unless and until it is approved, the initial proposed budget is approved, and seven trustees are elected by a vote of 7 8 9 the majority of the qualified voters in the district voting in an 10 election held pursuant to this section. Upon receipt of a petition signed by not less than fifty voters qualified to vote at a general 11 election and residing within the area of the proposed district, 12 the 13 board of trustees of the existing Stephentown Memorial library association shall give notice of an election to be conducted pursuant to this 14 15 act. Such election shall be held within one year of the effective date of this act. If a majority of such voters approve the formation of 16 the district, then the district shall come into existence on the terms and 17 conditions set forth in this act. At such election the issues shall be: 18 19 whether the public library district shall be created or not, and (i) 20 whether the initial budget therefor proposed by the board of trustees of 21 the Stephentown Memorial library association shall be approved or disap-

proved; and (ii) the election of seven trustees as provided by section 1 2 this act. The trustees of the existing Stephentown Memorial three of 3 library association shall give notice of such election by the publica-4 tion of a notice in one or more newspapers having a general circulation 5 in the district to be served. The first publication of such notice shall 6 be not less than thirteen days and not more than twenty days prior to 7 the date of such election. In addition, the board of trustees of the 8 existing Stephentown Memorial library association shall cause copies of 9 such notice to be posted conspicuously in three public places in the 10 district at least thirteen days prior to the date of such election. 11 Such notice shall specify the time when and the place where such election will be held, the issues to be decided at such election and the 12 hours during which polls will be open for the receipt of ballots. 13 The 14 board of trustees of the existing Stephentown Memorial library associ-15 ation shall prepare the ballots for such elections and the polls shall remain open for the receipt thereof at all elections from 7:00 a.m. 16 17 until 8:00 p.m. Furthermore, the board of trustees, in consultation and cooperation with the board of elections of the county of Rensselaer, 18 19 shall provide for the distribution and acceptance of absentee ballots in accordance with the provisions of the election law. The board of trus-20 tees of the existing Stephentown Memorial library association shall 21 designate a resident qualified voter of such district to act as chair-22 23 person of any election of such district and shall designate not less than two nor more than four resident qualified voters to act as election 24 25 inspectors and ballot clerks at such elections. No trustee or candidate 26 for the office of trustee shall serve as chairperson or as an election inspector or ballot clerk. The board of trustees may adopt a resolution 27 providing that such chairperson, election inspectors and ballot clerks 28 29 shall be paid for their respective services at the initial election or 30 at subsequent elections, should the library district be created. Such resolution, if adopted, may fit reasonable compensation for services of 31 32 such officials. Every voter otherwise qualified to vote at a general 33 election and residing within the area of the proposed district shall be qualified to vote at said election. After the polls have closed at such 34 35 election, the election inspectors and the ballot clerks shall immediate-36 ly canvass publicly the ballots cast and the chairperson of the election 37 shall publicly announce the result. Within seventy-two hours thereaft-38 er, the chairperson, election inspectors and ballot clerks shall execute and file a certificate of the result of the canvass with the board of 39 40 trustees of the existing Stephentown Memorial library association and 41 the town clerk of the town of Stephentown.

42 (b) In the event that the library district is created, there shall be 43 an annual election conducted by the board of trustees of the Stephentown Memorial library district in accordance with the provisions of subdivi-44 45 sion (a) of this section, at a time to be set by the library district's board, at which election vacancies on the board of trustees shall be 46 47 filled and at which any proposed budget which the board shall determine 48 to submit to the voters pursuant to section four of this act shall be 49 submitted to the voters.

(c) Candidates for the office of member of the board of trustees of 50 51 Stephentown Memorial library district shall be nominated by petithe tion. No vacancy on the board of trustees to be filled shall be consid-52 ered a separate, specific office. A separate petition shall be required 53 54 to nominate each candidate for a vacancy on the board. Each petition shall be directed to the secretary of the board of trustees, shall be 55 56 signed by at least fifty qualified voters of the district, shall state

the residence of each signer, and shall state the name and residence of 1 2 the candidate. In the event that any such nominee shall withdraw candi-3 dacy prior to the election, such person shall not be considered a candi-4 date unless a new petition nominating such person in the same manner and 5 within the same time limitation applicable to other candidates is filed 6 with the secretary of the board of trustees. Each petition shall be 7 filed with the secretary of the board of trustees at the library during 8 the hours of operation Monday through Saturday, not later than the thirtieth day preceding the election at which time the candidates nominated 9 10 to be elected. Petitions for candidates for the initial board of are 11 trustees of the Stephentown Memorial library district shall be filed with the secretary of the Stephentown Memorial library association. In 12 13 the event that the new district is created, petitions nominating candi-14 dates for the board of trustees after the initial election shall be 15 filed with the secretary of the Stephentown Memorial library district.

(d) At any election of such district, the voters may adopt a proposi-16 tion providing that, in all subsequent elections, vacancies on the board 17 trustees shall be considered separate, specific offices and that the 18 of nominating petitions shall describe the specific vacancy upon the board 19 trustees for which the candidate is nominated, which description 20 of 21 shall include at least the length of the term of the office and the name 22 of the last incumbent, if any. No person shall be nominated for more than one specific office. Such procedure shall be followed with respect 23 24 to all nominations and election in subsequent years until and unless 25 such proposition is repealed by the electors of the district at a requ-26 lar election by adoption of a proposition to repeal the same.

S 3. Organization and structure. The Stephentown Memorial library district shall be managed, operated and controlled by a board of trus-27 28 29 tees consisting of seven members. The trustees shall take office on the 30 first day of the month following their election and shall, at the first regular meeting of the board, determine when the term of office of each 31 32 member shall expire as follows: the three trustees receiving the first, 33 second and third highest number of votes shall serve for three years; the two trustees receiving the fourth and fifth highest number of votes 34 35 shall serve for two years; and the two trustees receiving the sixth and 36 seventh highest number of votes shall serve for one year. Every trustee 37 shall take and file an oath of office pursuant to section 10 of the public officers law within 30 days of taking office. As vacancies occur, trustees shall be elected at the annual election provided for by 38 39 40 this act to serve three year terms by the voters of the library district created pursuant to this act, such terms to commence on the first day of 41 the month next following the election. Only qualified voters of the 42 43 district shall be eligible for election to the board of trustees. The 44 board of trustees at its first meeting each fiscal year shall elect or 45 appoint a president and vice-president who shall be members of the board and a secretary, treasurer and such other officers as they deem neces-46 47 sary. If the board so determines, the offices of secretary and treasurer 48 may be held by individuals who are not members of the board of trustees and, in that event, such officers may, if the board so determines, receive compensation as fixed by resolution of the board. 49 50

51 S 4. Finances. (a) The initial budget for the Stephentown Memorial 52 library district shall be determined by a vote of the voters of the 53 district in the initial election as provided for in this section. All 54 future budgets that increased or decreased the Stephentown Memorial 55 library district proposed total operating expenditures over the total 56 operating expenditures in the last preceding fiscal year's budget shall 1 be submitted to the residents voting at the annual election of trustees 2 pursuant to section two of this act. Funds voted for library purposes at 3 the initial election and at all future budget elections shall be consid-4 ered an annual appropriation therefor and shall be levied and collected 5 yearly in the same manner and at the same time as other real property 6 taxes in the town of Stephentown.

7 (b) The board of trustees shall annually file with the financial offi-8 cers of the town of Stephentown, the dollar amount to be raised by levy 9 for the library district. Such town shall not make any change in the 10 dollar amount submitted to the town of Stephentown by the board of the 11 library district.

12 (c) The town of Stephentown shall levy a tax against the real property 13 lying within the district for the amount to be raised by tax as 14 contained in the annual budget of the Stephentown Memorial library 15 district. However, nothing in this act shall be construed as superseding 16 any valid property tax exemptions. The town of Stephentown may issue 17 tax anticipation notes, revenue anticipation notes and budget notes 18 pursuant to article 2 of the local finance law to obtain the necessary 19 moneys therefor.

20 The town of Stephentown shall have the power to authorize, sell, (d) 21 and issue bonds, notes and other evidences of indebtedness pursuant to 22 the local finance law in order to permit the library district to provide facilities or improved facilities for library purposes. Upon written 23 request from the board of trustees of the Stephentown Memorial library 24 25 district, after approval by the qualified voters of such library 26 district, the town of Stephentown shall authorize, sell, and issue such bonds, notes or other evidences of indebtedness as are necessary to 27 28 accomplish the improvements specified in the notice. The proceeds of 29 such bonds, notes or other evidences of indebtedness shall be paid to 30 the treasurer of the Stephentown Memorial library district and maintained in a segregated account in accordance with section 165.00 of the 31 32 local finance law and expended by the treasurer only on specific author-33 ization by the board of trustees.

(e) The board of trustees of the Stephentown Memorial library district may accept on behalf of the district any absolute gift, devise or bequest of real or personal property and such conditional gifts, devises or bequests as it shall by resolution approve.

38 (f) The treasurer of the Stephentown Memorial library district shall be custodian of all funds of the library district, including gifts and 39 40 trust funds paid over to the trustees. The board of trustees may authorize the investment of funds in the custody of the treasurer in the same 41 manner in which town funds may be invested. Proceeds of obligations 42 43 received from the town of Stephentown may be invested in accordance with 44 section 165.00 of the local finance law. The town of Stephentown shall 45 promptly pay over to the Stephentown Memorial library district all moneys which belong to or are raised for the library district. No moneys 46 47 shall be disbursed by the treasurer of the library district except after 48 audit by the board of trustees. The board of trustees of the Stephentown Memorial library district shall audit all claims and shall order the 49 50 payment thereof, except as otherwise provided by this section. No such 51 claims shall be reviewed or ordered paid by the trustees unless an itemized voucher therefor shall be presented to the board of trustees for approval and allowance. The foregoing requirement that no moneys shall 52 53 54 be disbursed by the treasurer of the district except after approval by 55 the board of trustees shall not be applicable to payment of claims of fixed salaries and amounts which the library district may be required to 56

1 pay on account of retirement contributions for past or current services 2 to officers and employees of the library district. The treasurer shall 3 keep such records in such manner as the board of trustees may require.

4 S 5. Charter, commencement of operations, and transfer of property and employees. The initially elected trustees shall, within thirty days from 5 6 the date of approval of the library district by the voters of the 7 district, apply to the board of regents for a charter as a public 8 library. Upon the granting of such a charter by the board of regents, then the Stephentown Memorial library association shall be dissolved, 9 10 title to all liabilities and assets, including all property, real and and personal, and all other tangible and intangible property, trust 11 and 12 other funds, and all other obligations, held by the Stephentown Memorial library association shall be transferred to, vested in, and be acquired 13 14 by the Stephentown Memorial library district established by this act. 15 Upon the granting of such charter by the board of regents, all employees 16 the Stephentown Memorial library association shall become employees of 17 of the library district upon the same terms and conditions of employment and at the same rate of pay as their previous employment by the Stephen-18 19 town Memorial library association, and the employees of the Stephentown 20 Memorial library district shall be subject to the civil service law.

21 Ad valorem levy. The several lots and parcels of land within the S 6. 22 the library district are hereby determined to be benefited by of area 23 the library facilities and devises existing as of the effective date of 24 this act, and the town of Stephentown is hereby authorized to assess, 25 levy and collect the necessary expenses of operation, maintenance and 26 repair of such facilities and services and such capital improvements, including debt service on bonds, notes or other evidences of 27 indebtedness of the library of municipality issued for the purpose of the 28 29 Stephentown Memorial library district, as may be authorized pursuant to 30 the provisions of this act from such lots and parcels of land in the same manner and at the same time as other municipal charges. 31

32 S 7. Education law. Except as otherwise provided by this act, the 33 provisions of the education law relating to public libraries shall be 34 applicable to the Stephentown Memorial library district established by 35 this act.

S 8. Section 5 of chapter 672 of the laws of 1993, amending the public authorities law relating to the construction and financing of facilities for certain public libraries, as separately amended by chapters 417 and 501 of the laws of 2010, is amended to read as follows:
