AN ACT to amend the mental hygiene law, in relation to establishing new sexually violent predator facilities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The mental hygiene law is amended by adding a new section  
2 7.26 to read as follows:  
3 S 7.26 SEXUALLY VIOLENT PREDATOR FACILITIES.  
4 1. PRIOR TO OPENING ANY SEXUALLY VIOLENT PREDATOR FACILITY, THE  
5 OFFICE SHALL BE REQUIRED TO HOLD A MINIMUM OF TWO PUBLIC HEARINGS. THE  
6 PLACE, DATE AND TIME OF EACH MEETING SHALL BE CLEARLY AND CONSPICUOUSLY  
7 POSTED TO PROVIDE ADEQUATE NOTICE TO ALL LOCAL RESIDENTS. SUCH NOTICE  
8 SHALL BE POSTED AT LEAST THIRTY DAYS PRIOR TO SUCH MEETING. EACH MEET-  
9 ING SHALL HAVE AT LEAST A PORTION OF SUCH MEETING OPEN TO THE PUBLIC FOR  
10 GENERAL COMMENT. THE OFFICE SHALL NOT MAKE A DETERMINATION AS TO THE  
11 VIABILITY OF THE ESTABLISHMENT OF A SEXUALLY VIOLENT PREDATOR FACILITY  
12 UNTIL AFTER ALL PUBLIC MEETINGS HAVE BEEN HELD. THE OFFICE MUST STATE,  
13 IN WRITING, WITH PARTICULARITY, THE REASONS FOR AUTHORIZING THE ESTAB-  
14 LISHMENT OF A FACILITY. THE OFFICE MUST ALSO POST THE INFORMATION ON THE  
15 OFFICE'S WEBSITE.  
16 2. NO FACILITY MAY BE ESTABLISHED WITHIN A ONE-MILE RADIUS OF ANY  
17 SCHOOL, DAY CARE, PUBLIC PARK, OR SIMILAR ESTABLISHMENT.  
18 3. NO FACILITY MAY BE ESTABLISHED WITHIN THIRTY MILES OF AN EXISTING  
19 SEXUALLY VIOLENT PREDATOR FACILITY.  
20 S 2. This act shall take effect immediately.
